Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

As described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. The amounts related to these excluded accounts are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

***Other Matter – Supplemental Schedules Required by ERISA***

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets Held at Year End is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section, it is inappropriate to, and we do not express an opinion on this supplemental schedule.

NOTE 1--DESCRIPTION OF PLAN

The following description of Methodist Medical Center of Oak Ridge Salary Deferral Plan for Union Employees (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General:* The Plan is a 403(b) defined contribution plan established by Methodist Medical Center of Oak Ridge (the Plan sponsor), for the benefit of eligible employees of the Plan sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

Bargaining unit employees of the Plan sponsor who have completed 90 days of service are eligible to participate in the Plan. Upon satisfying the eligibility requirements, employees may participate in the Plan immediately upon eligibility.

*Contributions:* The Plan is funded through employee elective deferrals and Plan sponsor contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the Internal Revenue Code (IRC). At the discretion of the Plan Administrator, participants may be permitted to deposit or "roll over" into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The following contribution types are allowed by the Plan:

- Employer matching
- Rollover contributions
- Elective deferrals

For participants employed prior to January 10, 2010, who have completed 12 months of eligible service, the Plan sponsor contributes to the Plan a matching contribution of 100 percent of the first 3 percent of qualified participant's compensation contributed to the Plan. For participants employed on or after January 10, 2010, who have 1,000 hours of service within the Plan year, the Plan sponsor contributes to the Plan a matching contribution of 100 percent of the first 6 percent of a qualified participant's compensation contributed to the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

*Participant Accounts:* Each participant's account is credited with the participant's contribution, the Plan sponsor's matching contributions, and an allocation of Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Participant Accounts:* Each participant’s account is credited with the participant’s contribution, the Plan sponsor’s matching contributions, and an allocation of Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting:* Participants are immediately vested in their voluntary contributions. Vesting in the Plan sponsor’s matching contributions is based on years of credited service and employment date as follows:

*Forfeitures:* Forfeitures represent unvested portions of terminated participants’ accounts. The Plan allows forfeitures of non-vested Plan sponsor contributions to be used to reduce employer contributions and pay administrative expenses.

As of December 31, 2024 and 2023, forfeiture balances totaled \$51,728 and \$29,877, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$63,555 were used.

*Notes Receivable from Participants:* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum balance or percent subject to IRS limits. The loans are secured by the balance in the participant’s account and bear interest rates between 3.25% and 8.50% as of December 31, 2024. The term of a loan is no longer than five years unless the loan is used to purchase a principal residence. Principal and interest are paid through payroll deductions.

*Payment of Benefits:* Upon termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the participant’s account balance, systematic installment payments over a specified period, or an immediate life annuity contract.

The following types of distributions are also allowed by the Plan:

- Purchase annuity contract with account balance
- Hardship
- In service
- Termination partial withdrawal

*Plan Termination:* Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants become immediately vested in their account balance.

NOTE 2--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Excluded Contracts and Accounts:* The Plan administrator has elected to exclude certain contracts and accounts from Plan assets in accordance with the Department of Labor's (DOL) Field Assistance Bulletin (FAB) 2009-02 due to the fact that:

- The contract or account was issued to a current or former employee before January 1, 2009.
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact, stopped making contributions to the contract or account before January 1, 2009.
- All the rights under the contract or account are legally enforceable against the insurer by the individual owner of the contract or account without any involvement by the employer.
- The individual owner of the contract is fully vested in the contract or account.

Because the Plan administrator has elected to exclude certain contracts in accordance with DOL FAB 2009-02, the excluded contracts are not in accordance with generally accepted accounting principles in the U.S. GAAP, and, accordingly, it is not intended that these financial statements be presented in accordance with U.S. GAAP.

*Use of Estimates:* The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition:* Investments in shares of registered investment companies are reported at fair value based on the quoted market values of the shares held by the Plan as determined by the trustee.

Money market funds are stated at cost which equals fair value.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Contributions:* Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

*Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recognized as benefits paid to participants based upon the terms of the Plan document.

*Payment of Benefits:* Benefits are recorded when paid.

*Administrative Expenses:* Administrative expenses related to maintaining participant accounts and third-party administration are paid by the Plan and deducted from participant funds. Other Plan expenses may be paid by either the Plan or the Plan sponsor, as provided by the Plan document. Expenses paid directly by the Plan sponsor are excluded from these financial statements.

**NOTE 3--INFORMATION CERTIFIED BY THE CUSTODIAN**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Fidelity Management Trust Company, the custodian of the Plan, and was not subjected to any auditing procedures performed by the Plan's independent public accountants.

**NOTE 4--FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The investment valuation methods described in Note 2 may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the Plan’s valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**NOTE 5--RELATED PARTY TRANSACTIONS AND TRANSACTIONS WITH PARTIES-IN-INTEREST**

Parties-in-interest as defined by DOL regulations include service providers to the Plan. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor. Certain Plan investments are shares of registered investment companies managed by Fidelity Management Trust Company or related organizations. Fidelity Management Trust Company is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Plan made direct payments to Fidelity Management Trust Company and Fidelity Investments Institutional Operations Company, the record keeper as defined by the Plan, of \$18,122.

**NOTE 6--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7--INCOME TAX STATUS**

The prototype plan sponsor has obtained an opinion letter dated August 7, 2017, in which the IRS stated that the restated prototype plan document was in compliance with the applicable requirements of the IRC. The Plan administrator has adopted the restated prototype plan. The Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan Administrator has evaluated the tax positions taken by the Plan and determined December 31, 2024, that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8--SUBSEQUENT EVENTS**

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. During this period, management did not note any material recognizable subsequent events that required recognition or disclosure in the financial statements.
