Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rastelli Brothers, Inc. 401(k) Salary Reduction Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Rastelli Brothers, Inc. 401(k) Salary Reduction Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Rastelli Brothers, Inc.; Market Fresh Holding Company, LLC; WRL, LLC; and Meat Stop, Inc. (collectively the "Company") excluding certain employees whose employment is governed by the terms of a collective bargaining agreement between employee representatives and the Company under which retirement benefits were the subject of good faith bargaining between parties and nonresident aliens who receive no earned income from the Company which constitutes income from sources within the United States. Employees are eligible to participate in the Plan upon date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The trustees are responsible for the oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Each year, participants may contribute up to 100% of annual compensation on a pre-tax or after-tax basis in accordance with the Roth provision, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Employees who meet the eligibility requirements referred to above, has attained the age of 18, and has completed one year of service are eligible for company matching contributions. The Company contributes 25% of the first 6% of base compensation that a participant contributes to the Plan. A profit-sharing contribution may be made at the discretion of the Company's owners and employees are eligible to receive such contribution at date of hire. There were no profit-sharing contributions made to the Plan for 2024 or 2023. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants are 100% vested after three years of credited service.

NOTE 1 - DESCRIPTION OF THE PLAN - CONTINUED

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set 1% above the prime rate, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,567 and \$25,936, respectively. These accounts may be made available to reinstate previously forfeited account balances of participants, if any, and any remaining forfeitures may be used to satisfy any contribution that may be required to correct an omission of an eligible employee or to restore a payment to a previously missing beneficiary or may be used to pay any administrative expenses of the Plan. The remaining forfeitures, if any, shall be used to reduce the employer matching contributions for the Plan year. Forfeitures attributable to nonelective contributions shall be added to any nonelective contributions for the Plan year and allocated among the participants' nonelective contribution accounts in the same manner as any nonelective contribution. Also, in 2024, employer contributions were reduced by \$18,945 from forfeited nonvested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company, are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions from the Company are recorded in the year in which participant compensation is earned.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability to the Plan with a corresponding reduction in contributions. As of December 31, 2024 and 2023, excess contributions payable totaled \$69,221 and \$54,945 respectively. The Plan will distribute the excess contributions to the applicable participants in the subsequent plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts: Valued at the net asset value (NAV) of participation units held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. NOTE 4 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Other transactions, which may be considered related-party or party-in-interest transactions, relate to normal plan management and administrative services, and the related payment of fees.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - TAX STATUS

The Company has adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by FIS Business Systems, LLC. The non-standardized pre-approved profit-sharing plan has received an opinion letter from the IRS dated June 30, 2020, as to the non-standardized pre-approved profit-sharing plan's qualified status. The non-standardized pre-approved profit-sharing plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and, therefore, believe the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - CERTIFIED INVESTMENTS

NOTE 9 - DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company did not remit certain participant contributions to the Plan totaling \$97,864 during 2023, \$4,537 during 2021, \$401 during 2020, \$4 during 2019, \$124 during 2018, and \$186 during 2015 on a timely basis as defined by the Department of Labor. The delinquent participant contributions result in a prohibited transaction totaling \$103,116, which is separately reported on Schedule H, Line 4a - Schedule of Delinquent Participant Contributions. The third-party administrator will calculate lost earnings resulting from the delay in contributions. The Company has not corrected the delinquent participant contributions as of the date of these financial statements.

NOTE 10 - OPERATIONAL DEFECT

During the years ended December 31, 2023 and 2022, it was discovered that certain of the Plan's provisions were not properly applied in the daily operation of the Plan. The definition of compensation for participant and employer contributions as per the plan agreement was not properly applied when calculating contribution amounts for certain payroll periods. The plan administrator determined that a qualified nonelective contribution in the amount of \$4,557 and \$24,450 for the years ended December 31, 2023 and 2022, respectively, is required to make the affected participants and the Plan whole, including lost earnings. These amounts are included in employer contribution receivables on the statements of net assets available for benefits as of December 31, 2024 and 2023. The Company has not corrected the operational defect as of the date of these financial statements.
