Report of Independent Auditors

To the Administrator of Keck Medicine of USC 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Keck Medicine of USC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Plan Description

The following description of the University of Southern California’s (the “University” or “USC”) Keck Medicine of USC 401(k) Retirement Plan (the “401(k) Plan” or the “Plan”) provides only general information. Participants should refer to the Plan or the Summary Plan Description for the Keck Medicine of USC 401(k) Retirement Plan, published by the University and provided to all participants of the Plan, for further discussion and details of the Plan provisions.

General

The Plan, which was established effective April 1, 2009, is a single employer profit-sharing plan covering all employees of the University who are either (1) employed by USC at Keck Hospital of USC (the “USC-KH”) or USC Norris Comprehensive Cancer Center and Hospital (the “USC-NCCCCH”) and covered by a union collective bargaining agreement that provides for participation in the 401(k) Plan or (2) employed at USC Verdugo Hills Hospital (the “USC-VHH”), or (3) by Las Vegas Culinary Health Center. New employees are immediately eligible to make pre-tax, and Roth contributions to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Fidelity Management Trust Company (“Fidelity”) is the Plan’s Trustee, custodian and recordkeeper.

Effective January 1, 2018, the Plan was amended and restated. Furthermore, effective on December 31, 2018, the Plan was renamed Keck Medicine of USC 401(k) Retirement Plan; prior to such date, the Plan was called the University of Southern California Hospital 401(k) Retirement Plan. The right to benefits of any person who does not have an Hour of Service on or after January 1, 2018 will be determined in accordance with the provisions of the Plan as in effect from time to time prior to such date.

In December 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2020 (“SECURE Act”). The Plan implemented provisions of the SECURE Act in 2020 that changed the required minimum distribution age to 72, up from 70 ½ for Plan participants. In December 2022, congress passed the SECURE 2.0 Act of 2022 (“SECURE 2.0”). The Plan implemented provisions of the SECURE 2.0 Act in 2022 that changed the required minimum distribution age to 73, up from 72 for Plan participants.

Responsibility for the daily oversight of the Plan is delegated to the Retirement Plan Administrator who reports to the Associate Senior Vice President, Human Resources, and to the Senior Vice President, Human Resources. The Retirement Oversight Committee reviews the appropriateness of the Plan’s investment choices, valuation policies and performance.

All employees of the USC-VHH and Las Vegas Culinary Health Center are eligible to participate in the 401(k) Plan. Participants are immediately eligible to make pre-tax or Roth contributions by completing a salary reduction agreement through Workday, the University’s Human Capital Management System. The Plan will recognize vesting credit earned while participants were employed by VHH and Las Vegas Culinary Health Center. Participants are credited with actual hours worked towards vesting.

Eligibility and Contributions

All eligible employees can contribute up to 75% (in whole percentages) of eligible earnings on a pre-tax or Roth basis up to Internal Revenue Service (“IRS”) annual limits. Participants can choose to make all or a portion of their contributions as a Roth contribution. These after-tax Roth contributions can be part or all of the contributions participants make that are matched by the University.

Note 1. Plan Description (continued)

Prior to January 1, 2018, for the USC-VHH participants, at its discretion, USC matched 100% of their pre-tax or Roth contributions up to a maximum of 4% of eligible earnings following the end of each calendar year end providing the employee was employed on the last day of the Plan year. Effective January 1, 2018, the USC 4% match is made on a paycheck-by-paycheck basis.

Employees initiate their salary reduction agreements online using Workday. Asset allocation and beneficiary designations are made online at Fidelity's website. Effective April 2016, if participants did not make their own selections, the default funds are the age-appropriate Vanguard Institutional Target Date-Retirement suite, but participants can change their elections at any time.

Participant Accounts and Vesting

Each participant's account is credited with the employee and university contributions and an allocation of Plan earnings, as defined by the Plan. The benefit to which a participant is entitled is provided from the participant's vested account. Employees are immediately vested in their before-tax, Roth, after-tax contributions and rollover contributions. They are also immediately vested in the University's retirement medical benefit account (RMBA) contribution. The University matching contribution is subject to a five-year vesting schedule in which the participant works 1,000 hours or more per year. The equivalency method of crediting hours is used for CNA (the "California Nurses Association") and NUHW (the "National Union of Healthcare Workers") participants. Actual hours worked is the crediting method for USC-VHH and Las Vegas Culinary Health Center employees.

Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$500 up to a maximum amount equal to the lesser of 50% of their vested account balance, or \$50,000 minus the highest outstanding loan balance in the previous 12-month period from all University retirement plans. The notes are secured by the balance in the respective participant's account and bear interest at a rate commensurate with local market rates for similar notes. The current interest rate is 6%. Principal and interest are paid in level payments through after-tax payroll deductions and notes periods range up to five years and, with supporting documentation, up to fifteen years for a home purchase note. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

A participant may have only one outstanding loan under the Plan at any given time. A loan that has been deemed to be distributed or defaulted shall be treated as an outstanding loan for purposes of this requirement.

Payment of Benefits

Benefits are payable to a participant upon attainment of age 59 ½, termination of employment, retirement, or total and permanent disability, as specified by the Plan. RMBA benefits are available at 59 ½ regardless of employment status. Participants may elect to receive the value of their accumulated Plan benefits in a lump-sum distribution, systematic withdrawal payments if over age 55, or they may elect to roll over their benefits into Individual Retirement Accounts or another employer's retirement plan, as specified in the Plan. Benefits are payable to the participant's beneficiary upon the participant's death.

Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will receive a distribution of their vested account balances.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Benefits Paid

Benefits are recorded when paid.

Expenses

The University pays the salaries of the Plan’s administrative personnel, provides office space, and pays for the administrative expenses of the Plan. No University employee receives compensation from the Plan.

The Administrator may direct Fidelity to pay (including from an account, if any, established for such purpose in the nature of “revenue sharing” or for similar deposits of asset management fees, settlement fees or other fees, in accordance with the negotiated amount) any or all expenses of administering the Plan, to the extent such expenses are reasonable, provided that expenses allocable to a specific Participant’s account may be charged against such account.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Valuation of Investments

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Oversight Committee reviews the appropriateness of the Plan’s investment choices, valuation policies and performance.

Notes Receivable from Participants

Participant notes receivable are valued at their outstanding principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Income Recognition

The net appreciation or depreciation in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments during the year, is reported in the Statement of Changes in Net Assets Available for Benefits. Dividend income is accrued on the ex-dividend date. Interest income from other investments is accrued as earned.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains or losses on sales of securities are computed on an average cost basis. Unrealized appreciation and depreciation in the fair value of investments is the change in market value as compared to the cost basis of the assets during the Plan’s fiscal year.

Risks and Uncertainties

The Plan provides for investments in various investment securities that are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades.

Note 3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a hierarchy of valuation inputs based on the extent to which the inputs are observable in the marketplace. Observable inputs reflect market data obtained from sources independent of the reporting entity and unobservable inputs reflect the entity’s own assumptions about how market participants would value an asset or liability based on the best information available. Valuation techniques used to measure fair value under ASC 820 must maximize the use of observable inputs and minimize the use of unobservable inputs. The standard describes a fair value hierarchy based on three levels of inputs, of which the first two are considered observable and the last unobservable, that may be used to measure fair value.

The following describes the hierarchy of inputs used to measure fair value and the primary valuation methodologies used by the Plan for financial instruments measured at fair value on a recurring basis. The three levels of inputs are as follows:

A financial instrument’s categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund investment held by the Plan is classified as a Level I investment since it is a mutual fund with a ticker symbol and a publicly observable price that is actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are classified as a Level I investment as they are deemed to be actively traded.

There have been no changes in the methodologies used in 2024 and 2023.

Note 5. Related Party Transactions

The University is a party-in-interest under the guidelines of ERISA. The University provides certain administrative services at no cost to the Plan. Certain Plan investments represent funds invested in, or maintained by, Fidelity. Fidelity is the Trustee of the Plan. Therefore, these transactions represent exempt party-in-interest transactions. Throughout 2024, Fidelity Investments provides certain administrative services to the Plan pursuant to the Revenue Credit Agreement between the Plan and Fidelity Investments.

If the revenue received by Fidelity Investments from such mutual fund service providers exceeds the amount owed under the agreement, Fidelity Investments remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants.

Note 6. Tax Status

The IRS has issued a determination letter, dated May 26, 2015, that the Plan conforms with the requirements of ERISA, constitutes a qualified plan under Section 401(a) of the Internal Revenue Code ("IRC"), and is exempt from federal income taxes under the provisions of Section 501(a) of the IRC. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to examinations for years prior to 2021.

Note 7. Investment Contract

In 2016, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with New York Life Insurance Company ("New York Life") totaling \$1,719,482 for 2024 and \$1,815,143 for 2023. New York Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract permits the insurance company or plan sponsor to terminate the agreement upon providing written notice. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 7. Investment Contract (continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include events initiated by the plan sponsor, including, but not limited to, total or partial plan termination, mergers, spin offs, layoffs, early retirement incentive programs, sales or closings of all or part of the University's operations, bankruptcy, or receivership. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, if the Plan terminates the contract with the issuer, the issuer will settle at an amount different from contract value. This will occur if the Plan requests a single lump sum payment instead of electing installment payments over six years.

Note 8. Litigation

Occasionally, the Plan or its fiduciaries are party to lawsuits arising from its activities. The University vigorously defends its position in each case, and it is not possible to determine with certainty the outcome of such matters.

Note 9. Subsequent Events

Management has evaluated the events and transactions that have occurred through October 13, 2025, the date the financial statements were available to be issued, and noted no further items requiring adjustments on the financial statements or additional disclosures.
