Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Southern California Painting & Drywall Industries Health and Welfare Trust Fund (the “Plan”) is a multiemployer welfare benefit plan providing medical-hospital, dental, vision, prescription, death and accidental death and dismemberment benefits to participants. Certain benefits are provided by contracts with prepaid health plans and other benefits are paid directly by the Plan.

Working members employed by one or more contributing contractors signatory to the Painters and Allied Trades District Council No. 36 Master Labor Agreement or the Southern California Drywall Finishers Joint Agreement are eligible for benefits specified by the Plan. Dependents, owner-operators and eligible employees of certain subscribing employers are also eligible for certain benefits under the Plan. Senior members meeting the Plan’s eligibility requirements for retired employees and their dependents are eligible for limited benefits under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan documents include detailed rules for each situation. Participants should refer to the Plan agreement and any amendments regarding specific provisions of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

C. Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for hours or months worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts. Owner operator contributions and participant contributions are contributions for coverage during the year.

D. Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The employer payroll compliance program is administered by the Southern California Painters and Decorators Labor-Management Cooperation Committee Trust. The system of internal control provides for examination of employers’ payroll records to ensure compliance with the collective bargaining agreements.

E. Investment and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments are mutual funds valued at their quoted prices in an active market. Level 2 investments consist of a money market fund valued at \$1 per share based on the daily closing prices reported by the Fund.

Unrealized appreciation or depreciation of investments is reported as net appreciation (depreciation) of investments. Form 5500 requires realized gains and losses to be reported as the difference between proceeds from the sale or redemption of investments and the market value of the investment at the beginning of the year, for those investments on hand at the beginning of the year, or the purchase price of investments acquired during the year. The different methods of computing realized gain or loss and the residual unrealized appreciation (depreciation) of investments results in differences in reporting on the financial statements and Form 5500.

F. Benefits

Benefits reported on the statements of changes in net assets available for benefits are segregated by premiums for eligible participants paid during the year (Premiums) and participant claims for participant services paid during the year under the indemnity plan, net of refunds and stop-loss insurance reimbursements (Indemnity Claims - Net).

Benefit obligations are segregated on the statements of benefit obligations based on estimates at the end of the year of unpaid premiums for coverage during the year (Premiums Payable); claims incurred during the year, reported but unpaid, (Claims Payable); claims incurred during the year but not reported nor paid (Claims Incurred But Not Reported); future benefits costs to be incurred based on participants' accumulated eligibility credits (Future Benefits Based on Participants' Accumulated Eligibility) and the actuarial present value of those estimated future benefits expected to be paid to or for (1) currently retired or terminated participants and their beneficiaries and dependents and (2) active participants and their beneficiaries and dependents after retirement from service with participating employers (Postretirement Benefit Obligations).

G. Postretirement Benefits

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to participant service rendered to December 31, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants.

Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated participants and their beneficiaries and dependents and (2) active participants and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's service in the industry rendered to the valuation date.

The postretirement benefit obligations were determined by actuaries from Rael & Letson and are the amounts that result from applying actuarial assumptions to adjust the accrued benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements for death, disability, termination or retirement), between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used for the year ended December 31, 2024 (2023) were: (a) Discount Rate: 5.50% (4.75%) per annum compounded annually, (b) Mortality Rates: Scale MP-2021 generational projection of the Pri-2012 Blue Collar and Disabled headcount-weighted tables, where the nondisabled rates were multiplied by 109%, (c) Health Care Cost Increase or Trend Rates for retiree premiums and claims – 6.75% (7%) in the first year, and an ultimate rate of 3% (4%), (d) Actuarial Cost Method: Projected Unit Credit Actuarial Cost Method, and (e) other assumptions for records and data, decrement rates for active participants, spouse health coverage rate – 60%, election of retirement coverage – 10% (5%) of all eligible participants.

G. Postretirement Benefits (Continued)

The changes in actuarial assumptions during the years ended December 31, 2024 and 2023 resulted in decreases of \$2,919,700 and \$11,342,700, respectively, in postretirement benefit obligations.

The foregoing assumptions and methods are based on the presumption that the Plan will continue unchanged. Were the Plan to terminate or be amended, different actuarial assumptions, methods and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The costs of the postretirement benefit plan are shared by the Plan's participating employers and retirees. Retirees on average pay approximately 68% and 30% of the estimated cost of postretirement benefits during the years ended December 31, 2024 and 2023, respectively.

The health care cost increase or trend rates have a significant effect on the postretirement benefit obligations. A 1% increase in the health care cost increase or trend rates would increase the postretirement benefit obligations as of December 31, 2024 and 2023 by \$88,300 and \$94,900, respectively.

I. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

The actuarial present value of postretirement benefit obligations is reported based on certain assumptions pertaining to interest rates, inflation rates, employee demographics and other factors, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 5 - CONCENTRATION OF CREDIT RISK

NOTE 6 - TRANSACTIONS WITH RELATED PARTIES

The Plan collects employer contributions for the Plan and other related organizations through a lockbox system and transmits to the related organizations the employer contributions and remittances collected on their behalf.

The Plan also pays certain common administration expenses and allocates these expenses to various related entities based on a pre-determined allocation formula periodically approved by the Board of Trustees.

NOTE 7 - PLAN TERMINATION

The Plan shall cease and terminate upon occurrence of any one or more of the following events:

1. In the event the Trust shall, in the opinion of the Board of Trustees, be inadequate to carry out the intent and purpose of the Trust Agreement, or be inadequate to meet the payments due or to become due under the Trust Agreement and under the plan of benefits to participants and beneficiaries already drawing benefits;
2. In the event there are no individuals living who can qualify as employees;
3. In the event of termination by action of the District Council and the Association; or
4. In the event of termination as may be otherwise provided by law.

In the event of termination, the Board of Trustees shall:

1. Make provision out of the Trust for the payment of expenses incurred up to the date of termination of the Trust and the expense incidental to such termination;
2. Arrange for a final audit and report of the transactions and accounts, for the purpose of termination of their Trusteeship;
3. Pay any and all obligations of the Trust and distribute and apply any remaining surplus in such manner as will, in their opinion, best effectuate the purposes of the Trust and the requirements of law; and
4. Give any notices and prepare and file any reports, which may be required by law.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 23, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
