Opinion

We have audited the accompanying financial statements of Oregon Laborers - Employers Defined Contribution and 401(k) Plan, which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes are presented below.

Mutual Funds: The fair value of mutual funds is generally based on quoted prices in active markets (Level 1).

Common/Collective Trusts: The Plan’s common/collective trusts consist of The Bank of New York Mellon Capital Stock Index Fund and the Galliard Retirement Income Fund. The fair value of the investments in this category have been estimated using the net asset value per share of the investments. The net asset value is being used as a practical expedient to estimate fair value. The common/collective trusts are direct filing entities with the Department of Labor; therefore, information regarding the investment strategy is not disclosed. There are no unfunded commitments to either of these common/collective trusts.

The Bank of New York Mellon Capital Stock Index Fund has daily liquidity, and no advanced written notice is required for redemption. The Galliard Retirement Income Fund allows participant redemptions on a daily basis. The fund requires a 12-month notice period for the Plan to liquidate this investment.

Money Market Mutual Funds: The fair value of the money market mutual funds, which are not actively traded, is based on amortized cost, which approximates fair value of the underlying investments (Level 2).

Valuation Methods, Consistency

The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant and employer contributions due but not paid at year-end are recorded as contributions receivable. Allowances for uncollectible accounts are considered unnecessary and are not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in mutual funds, common/collective trusts and money market mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The following description of the Oregon Laborers - Employers Defined Contribution and 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for more complete information.

General

The Plan was established in January 1986 and is a defined contribution plan covering employees whose employers have a collective bargaining agreement or special agreement that provides coverage under the Plan. Effective November 1, 1997, a 401(k) option was added to the Plan, which permits eligible employees to make pretax contributions through payroll deductions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Board of Trustees

The Plan is administered by a Board of Trustees composed of three union trustees and three employer trustees.

Contributions

Employers shall contribute monthly to the Plan for the account of each of its Participants. The amount is determined according to the collective bargaining agreement or special agreement. Participants may make pre-tax contributions based on flat-dollar amounts per hour (also referred to as deferrals), and direct roll over contributions. Participant contribution rates apply for all hours covered under the collective bargaining agreement or special agreement. Participant contributions are subject to the maximum contribution limits established by the Internal Revenue Code.

Participant Accounts

Each participant's account is credited with employer contributions (if any), voluntary employee contributions and investment earnings thereon, net of operating expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in employer contributions and their voluntary contributions plus earnings thereon.

Benefits

Benefits are paid in the form of a single lump-sum payment. The sole exception is a minimum required distribution for those participants who have attained age 70-1/2. Effective January 1, 2020, the Plan was amended to increase the required minimum distribution age to age 72.

Under limited circumstances, a participant may elect to receive a distribution while still working. These are referred to as in-service distributions. The portion of a participant's account attributable to employer contributions can be distributed if the participant has obtained age 55 or commenced participation in the Plan more than 60 months prior to the distribution.

Participants may take normal retirement at age 65, may retire early upon reaching age 53, or may retire at age 50 if the sum of their age and years of credited service equals 80 or more. Hardship withdrawals are permitted from a participant's pre-tax contributions, if they have a financial hardship and meet other requirements.

Investment Options

The 401(k) contributions to the Plan are invested as directed by the participant in various investment options, which include mutual funds and common/collective investment funds. Participants must evaluate their own investment goals and objectives and choose the investment option best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their vested balances to be lower than the amount contributed to the Plan on their behalf.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees.

In the event of termination, the rights of all affected participants to all account balances shall be nonforfeitable. After payment of expenses properly chargeable against the Plan, the Trustees shall determine the time of commencement of payment of benefits and the method of distribution.

4. TAX STATUS

The Plan obtained its latest determination letter, dated March 18, 2013, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, or that any instances of noncompliance would be eligible for correction, including self-correction, under an applicable Internal Revenue Service corrective procedure. They believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate the tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

During the years ended December 31, 2024 and 2023, the contributing employers to the Plan made contributions to the Plan that were considered late under U.S. Department of Labor regulations. As of December 31, 2024 and 2023, contributions not yet corrected under prescribed correction procedures totaled \$283,970 and \$250,851, respectively.

7. SUBSEQUENT EVENTS

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after December 31, 2024, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through October 9, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.


