Report of Independent Auditors

To the Administrator of University of Southern California Defined Contribution Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of University of Southern California Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 ("supplemental schedule"), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Plan Description

The following description of the University of Southern California (the “University” or “USC”) Defined Contribution Retirement Plan (the “Defined Contribution Plan” or the “Plan”) provides only general information. Participants should refer to the *Summary Plan Description for the University of Southern California Defined Contribution Retirement Plan*, published by the University and provided to all participants of the Plan, or the Plan document for further discussion and details of the Plan provisions.

General

The Plan is a defined contribution single employer plan covering all staff and faculty employees of the University who have satisfied an eligibility requirement and who are not covered under the Keck Medicine of USC 401(k) Retirement Plan. Effective January 1, 2019, new employees are eligible after completing a one-year period of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. American General Life Insurance Company (“American General”), Empower Annuity Insurance Company of America (“Empower”), Fidelity Management Trust Company (“Fidelity”), Vanguard Fiduciary Trust Company (“Vanguard”), Teachers Insurance and Annuity Association of America (“TIAA”), College Retirement Equities Fund (“CREF”), (collectively, the “Insurance Companies and Trustees”) are the Plan’s trustees, insurance companies, custodians, and recordkeepers. TIAA certifies investments in mutual funds held by TIAA and CREF investments.

Effective June 30, 2007, the University no longer offers American General investment options with respect to new retirement contributions, transfers, or rollovers. Effective April 1, 2016 USC no longer offers Empower investment options with respect to new contributions, transfers, or rollovers. Transfers into and rollovers into American General and Empower are restricted.

Effective March 1, 2016, participants have the option to invest their contributions in a streamlined selection of funds or set up a self-directed brokerage account to invest in their choice of thousands of mutual funds. Effective April 29, 2016, Fidelity, Vanguard, and TIAA and CREF continue to be approved investment providers. The amendment removed Empower as an approved provider for new contributions, plan to plan transfers or rollovers.

Responsibility for the daily oversight of the Plan is delegated to the Retirement Plan Administrator who reports to the Associate Senior Vice President, Associate Vice President, Strategy and Programs, and to the Senior Vice President, Human Resources. The Retirement Oversight Committee reviews the appropriateness of the Plan’s investment choices, valuation policies and performance.

Eligibility and Contributions

Until July 1, 2007, as a condition of employment, eligible employees were required to contribute 5% of their eligible earnings to basic component of the University of Southern California Tax-Deferred Annuity Plan (the “TDA Plan”). The University contributed 10% of the participant’s eligible earnings to the Plan. All employees were eligible to make unmatched contributions to the supplemental component of the TDA Plan.

The Plan was amended effective July 1, 2007, to allow all eligible non-exempt staff members to participate, unless their collective bargaining agreement provides otherwise. The Plan was amended effective January 1, 2014 to exclude any employee deemed eligible for the Keck Medicine of USC 401(k) Retirement Plan. Under the Plan, all eligible participants receive a 5% non-elective contribution from the University whether or not they contribute to the TDA Plan. If participants choose to contribute to the TDA Plan, the University will match the participant’s TDA contribution with an employer contribution to the Plan one for one up to the first 5% of the participant’s contribution.

Participants may increase or decrease their contribution level at any time. University contributions to the Plan are fully vested and non-forfeitable for participants hired prior to January 1, 2012. Effective January 1, 2014, the Plan was amended to add the provision that permits the University to grant service credit in the case of acquisitions or mergers. Effective January 1, 2021, the Plan was amended to suspend the 5% basic contribution component by the employer. For the Plan Year beginning January 1, 2022 the University reinstated the 5% basic contributions component by the employer.

Vesting

Effective January 1, 2012, employees must earn four years of service credit in which 1,000 hours or more are worked with the University in order to retain the full amount of the employer’s 5% non-elective contribution, at which point the employee is “fully vested.” In the first three years of service, the employee will be vested an incremental 25% per year, at the completion of each year. After earning four years of service, the employee is considered fully vested and upon terminating from employment may retain all of the employer’s non-elective contribution. Employees who terminate before they earn four years of service relinquish the portion of the non-elective contribution in which they did not vest. The University match contributions are fully vested at all times.

Rollovers are unallowable transactions. However, rollovers occurred during the year ended December 31, 2024 and 2023. The Plan recognized a liability for such rollovers as due to the TDA Plan.

Plan Assets

Participants in the Plan may elect to allocate the employer contributions among any investment options from the current trustees and insurance companies. The allocations of employer contributions within the investment options may be changed by the participant at any time by notifying the trustees and insurance companies. The allocation of employer contributions between the investment options is changed through Workday, the University’s Human Capital Management System. If the participant does not make their own selection regarding a provider, they will be defaulted to Fidelity as their recordkeeper. If the participant selects a provider but does not choose investments, they will be defaulted to the Vanguard Target Date Retirement suite.

Participant Accounts

Each participant’s account is credited with the employer’s contribution and an allocation of Plan earnings or losses and charged with an allocation of administrative expenses as defined by the Plan. The benefit to which a participant is entitled is provided from the participant’s vested account.

Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their accounts held by the trustees a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance, or \$50,000 minus the highest outstanding loan balance in the preceding 12-month period from all loans against all University sponsored retirement plans. The loans are secured by the balance in the respective participant's account and bear interest at a rate commensurate with local market rates for similar loans. The current interest rate is Prime plus 1% which is currently 9.50%. Principal and interest are paid in level payments through after-tax payroll deductions and loan periods range from one to five years. Home loans may be repaid over a ten-year period. Participants directly pay loan fees. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan document.

A participant may have only one outstanding loan under the Plan (which includes both this Plan and the TDA Plan) at any given time. A loan that has been deemed to be distributed or defaulted shall be treated as an outstanding loan for purposes of this requirement.

Payment of Benefits

Benefits are payable to a participant or beneficiary upon termination of employment, retirement, total and permanent disability, or death, as specified by the Plan. Participants who have invested in Fidelity, Vanguard, American General, Empower or TIAA and CREF may elect to receive the value of their accumulated Plan benefits as an annuity, a lump-sum distribution, equal installments over a five-, ten-, or fifteen-year period, or they may elect to roll over their benefits into Individual Retirement Accounts or non-University investment accounts, as specified in the Plan.

Participants who have invested in TIAA Traditional annuity contracts are limited in their ability to elect a lump-sum distribution depending upon the contract into which contributions were made; however, after termination, they may receive the value of their accumulated benefits over a five-year period.

In December 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2020 ("SECURE Act"). The Plan implemented provisions of the SECURE Act in 2020 that changed the required minimum distribution age to 72, up from 70 ½ for Plan participants. In December 2022, congress passed the SECURE 2.0 Act of 2022 ("SECURE 2.0"). The Plan implemented provisions of the SECURE 2.0 Act in 2022 that changed the required minimum distribution age to 73, up from 72 for Plan participants.

The Plan was amended February 2022. Effective as of March 1, 2022, a participant who has attained age 59 ½ may make a withdrawal of part or all of their accounts under the Plan, without conditions.

Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will receive a distribution of their vested account balances.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Benefits Paid to Participants

Benefits are recorded when paid.

Expenses

The University pays certain expenses of maintaining the Plan, and those expenses are excluded from these financial statements. To the extent provided under the terms of the Plan and the terms of any trust agreement or annuity contract, the Administrator may direct a Trustee or an Insurance Company to pay from any trust or annuity contract, any or all expenses of administering the Plan, to the extent such expenses are reasonable, provided that expenses allocable to a specific Participant's account may be charged against such account and included in administrative expenses on the Statement of Changes in Net Assets Available for Benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Oversight Committee reviews the appropriateness of the Plan's investment choices, valuation policies and performance. Reports from the insurance companies and trustees are made to the Senior Vice President, Administration. Refer to Note 4, "Fair Value Measurements," for more information.

Income Recognition

The net appreciation or depreciation in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments during the year, is reported in the Statement of Changes in Net Assets Available for Benefits. Dividend income is accrued on the ex-dividend date. Interest income is accrued as earned.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains or losses on sales of securities are computed on an average cost basis. Unrealized appreciation and depreciation in the fair value of investments is the change in market value as compared to the cost basis of the assets during the Plan's fiscal year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Risks and Uncertainties

The Plan provides for investments in various investment securities that are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades.

Note 3. Investments

The University has entered into contracts with Fidelity, American General, Empower, Vanguard and TIAA and CREF to hold and invest Plan contributions. American General, Empower and TIAA and CREF investments are either in variable annuities, mutual funds, or unallocated funds with a guaranteed fixed return. Fidelity, Vanguard and Empower maintain investments in pooled separate accounts, mutual funds and New York Life Insurance Company (“New York Life”) guaranteed interest accounts.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (“FASB”), Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a hierarchy of valuation inputs based on the extent to which the inputs are observable in the marketplace. Observable inputs reflect market data obtained from sources independent of the reporting entity and unobservable inputs reflect the entity’s own assumptions about how market participants would value an asset or liability based on the best information available. Valuation techniques used to measure fair value under ASC 820 must maximize the use of observable inputs and minimize the use of unobservable inputs. The standard describes a fair value hierarchy based on three levels of inputs, of which the first two are considered observable and the last unobservable, that may be used to measure fair value.

The following describes the hierarchy of inputs used to measure fair value and the primary valuation methodologies used by the Plan for financial instruments measured at fair value on a recurring basis. The three levels of inputs are as follows:

A financial instrument’s categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan has adopted the authoritative guidance contained in FASB ASC 820-10, for estimating the fair value of investments in investment funds that have calculated Net Asset Value (“NAV”) per share in accordance with FASB ASC 946-10, *Financial Services-Investment Companies*. Consistent with this guidance, the Plan uses the NAV as reported by the investment managers as a practical expedient, to determine the fair value of investments in investment funds which (a) do not have a readily determinable fair value and (b) either have the attributes of an investment fund or prepare their financial statements consistent with the measurement principles of an investment fund. At December 31, 2024 and 2023, the fair value of all such investments in investment funds has been determined by using NAV as a practical expedient.

The following is a description of the valuation methodologies used for assets measured at fair value.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund investment held by the Plan is classified as a Level 1 investment since it is a mutual fund with a ticker symbol and a publicly observable price that is actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are classified as a Level 1 investment as they are deemed to be actively traded.

Pooled Separate Accounts: Plan assets with Empower Annuity Insurance Company (“Empower”) are represented by a “unit of account” and a per unit value whose value is determined using NAV as a practical expedient and is the result of the accumulated values of underlying investments. The underlying investments are valued in the following ways:

- Equity securities (stock): Valued at the closing price reported on the active market on which individual securities are traded.
- Bonds: Valued based on prices derived by an independent party (Convergent Financial Technologies Inc.) that uses inputs such as benchmark yields, reported trades, broker/dealer quotes, and issuer spreads. Prices are reviewed and can be challenged with the independent party and/or overridden by Convergent Financial Technologies Inc. if Empower believes such would be more reflective of fair value.

The TIAA Real Estate Account (REA) is a pooled separate account, is exchange traded, valued at the daily closing price and is available to be traded on any day the New York Stock Exchange is open for business. Transfers out of the REA are limited to one per calendar quarter. There are no unfunded commitments to purchase REA. A participant’s transfers into REA are limited if the effect of the transfer would cause the participant’s balance to exceed \$150,000.

Variable annuities: The units in the CREF variable annuity funds are available for transactions at the closing unit value on any day the New York Stock Exchange is open for business. The funds held by the Plan are deemed to be actively traded and have a readily determinable fair value as the daily NAVs are publicly available.

These pooled separate accounts and variable annuities have no unfunded commitments, no defined remaining life, offer daily liquidity (pending market conditions) and are not subject to any redemption restrictions at the measurement date, except as described below. Trades within these funds generally settle daily with no required redemption notice period. A full redemption of the fund could be temporarily delayed based on ordinary market conditions.

Guaranteed interest accounts: The American General, New York Life and Empower guaranteed interest accounts are valued at fair value by multiplying the contractual Market Value Adjustment (MVA) by the Contract Value. The MVA formula is based on the standard formula which approximates the change in market value of a bond given a change in the interest rate environment. Contract value approximates fair value for the years ended December 31, 2024 and 2023.

TIAA non-fully benefit responsive Traditional Annuities, which are classified as guaranteed interest accounts, are valued at contract value, which approximates fair value. The contract value of the non-fully benefit responsive TIAA Traditional Annuities equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers. In determining the reasonableness of the methodology, the Retirement Oversight Committee considers a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms while others are substantiated utilizing available market data.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Related Party Transactions

The University is a party-in-interest under the guidelines of ERISA. The University provides certain administrative services at no cost to the Plan.

Certain Plan investments represent funds invested in, or maintained by, American General, Empower, Fidelity, Vanguard and TIAA and CREF. These companies are the Insurance Companies and Trustees of the Plan. Therefore, these transactions represent exempt party-in-interest transactions.

Throughout 2023, certain administrative services were provided to the Plan by Fidelity Investments, TIAA and Empower (collectively “the administrative providers”) pursuant to the respective Revenue Credit Agreements between the University and the administrative providers. The administrative providers receive revenue from mutual fund, pooled separate account and variable annuities service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the administrative providers for its administrative services to the Plan.

If the revenue received by the administrative providers from such mutual fund, pooled separate account or variable annuities service providers exceeds the amount owed under the agreement, the administrative providers remit the excess to the Plan’s trust on an at least annual basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to the administrative providers for administrative expenses not covered by revenue sharing.

Empower and New York Life Non-Fully Benefit Responsive Investment Contracts

The Plan entered into a traditional insurance company guaranteed interest account investment contract with Empower in 1991. The Plan entered into additional insurance company guaranteed interest account contracts with New York Life in 2016. Empower and New York Life maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. When establishing interest crediting rates for the Guaranteed Interest Account, Empower and New York Life consider many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuers' general account. These rates are established without the use of a specific formula. The New York Life minimum crediting interest rate cannot be less than 1.00%.

The Guaranteed Interest Account does not permit Empower to terminate the agreement prior to the contract maturity date unless agreed upon between the Plan and Empower. The Guaranteed Interest Account will terminate when all of the following have occurred: (a) no further contributions may be paid under the contract, (b) no participant's account remains uncanceled, and (c) no further annuity or transfer payments are payable from the contract. Empower may limit the amount transferred by participants, and may, upon notice limit the frequency of transfers. The Empower average yield approximates the minimum crediting interest rate which cannot be less than 3.00%.

The New York Life guaranteed interest account contracts allow both the Plan and New York Life to terminate a contract. During termination, New York Life may limit withdrawals and transfers if certain conditions, such as the sale or closing of the plan sponsor occurs. In addition, transfers from the New York Life guaranteed interest account are limited to 15% of the account balance, and any request for a transfer out above 15% of the account balance is limited to 96% of the requested transfer.

TIAA and American General Non-Fully Benefit Responsive Investment Contracts

Contributions to the TIAA Traditional Annuities are used to purchase a guaranteed amount of future retirement benefits. TIAA provides to participants annuities, which are considered unallocated contracts. The TIAA Traditional Annuities is a guaranteed annuity which guarantees principal and pays a guaranteed minimum interest, currently 3% during the accumulation phase and 2.5% during the payout phase. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of the TIAA Board of Trustees on a year-by-year basis. When declared, the additional amounts remain in effect for the declaration year that begins each March 1 and are not guaranteed for future years. Together the guaranteed minimum and additional amounts make up the crediting rate in the accumulation phase. TIAA groups premium dollars received over defined periods into vintages for the purposes of determining the crediting rate for the applicable declaration year during the accumulation period. During 2024, the average crediting rate for regular annuities was between 3.25% and 7.00%, depending on the contract, for annuities in both the accumulation and payout phases. The TIAA and American General yields are typically above the minimum crediting rate of 3.00%.

The Plan's TIAA Traditional investments are offered to the Plan through the RA and GRA contracts. The TIAA Traditional Annuity holdings within the RA and GRA contracts have liquidity restrictions and are non-benefit responsive. Distributions, withdrawals, and transfers out of these contracts can only be made in 10 annual installments through Transfer Payout Annuities ("TPAs").

All investment contracts that are not fully benefit-responsive held by a defined contribution plan are required to be reported at fair value. Contract value approximates fair value. Contract value approximates a discounted cash flow value calculated using an appropriate risk adjusted market discount rate which correlates closely with the non-fully benefit responsive historical crediting rates.

Note 8. Tax Status

The Internal Revenue Service has issued a determination letter, dated August 26, 2015, that the Plan conforms with the requirements of ERISA, constitutes a qualified plan under Section 401(a) of the Internal Revenue Code ("IRC"), and is exempt from federal income taxes under the provisions of Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan administrator believes it is no longer subject to examinations for years prior to 2021.

Note 9. TIAA Traditional Annuity Loans

Participants may borrow directly from TIAA, not directly from a participant's account, using a portion of their plan account as security for the loan. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their balance in the TIAA Traditional annuity account. To secure plan loans, participants are required to pledge as collateral their TIAA Traditional annuity account value equal to 110% of the outstanding loan balance in the event of default. Loan interest on these loans is paid directly to TIAA.

Loan balances outstanding from TIAA to the Plan's participants were \$2,740,000 and \$3,559,000 as of December 31, 2024 and 2023, respectively. As such, approximately \$3,014,000 and \$3,915,000 of TIAA Traditional annuity account balances as of December 31, 2024 and 2023, respectively, serve as loan collateral for the related loans. If a TIAA loan were to go into default, the collateral associated with the loan would not be distributed to TIAA unless the participant was otherwise eligible for a distribution.

Note 10. Litigation

Occasionally, the Plan or its fiduciaries are party to lawsuits arising from its activities. The University vigorously defends its position in each case, and it is not possible to determine with certainty the outcome of such matters.

Note 11. Subsequent Events

Management has evaluated the events and transactions that have occurred through October 13, 2025, the date the financial statements were available to be issued, and noted no items requiring adjustments on the financial statements or additional disclosures.
