Notes to Financial Statements for the year ended December 31, 2024

NOTE 1 – DESCRIPTION OF PLAN

The following description of the MC2 Civil, LLC 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established for the benefit of all employees of MC2 Civil, LLC, formerly Main Lane Industries, Ltd., and MC2 Oilfield Services, LLC (collectively the Company) who are not nonresident aliens or members of collectively bargained units. Covered employees are eligible to participate after six months of eligible service. Plan entry dates are the first day of each quarter of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the name of the Plan was changed from mc2 civil, inc. 401(k) Plan to MC2 Civil, LLC 401(k) Plan, MC2 Civil, LLC became the plan sponsor and mc2 civil, inc. ceased its participation in the Plan. Effective June 24, 2024, Principal Trust Company (Principal) became the custodian of the Plan. In connection with this change, all assets of the Plan were transferred from John Hancock Life Insurance Company (U.S.A.) (John Hancock) to Principal in August 2024.

Contributions – The Plan provides for contributions by both participants and the Company as follows:

- *Participant contributions* – Participants may contribute up to 100% of their compensation as defined by the Plan on a pre-tax basis or as Roth contributions on an after-tax basis, subject to certain limitations under the Internal Revenue Code (the Code). The Plan allows catch-up contributions, as defined by the Code, for participants who have attained the age of 50 prior to the end of the plan year. Participants also may rollover any amounts they receive as distributions from another qualified retirement plan.
- *Employer contributions* – The Company makes a safe harbor matching contribution to all eligible employees equal to 100% of the first 3% of employee contributions and 50% of contributions in excess of 3% but less than 5%. The Company also may make discretionary matching contributions and nonelective contributions. During 2024, there were no discretionary matching or non-elective contributions made to the Plan.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting – Participants are immediately 100% vested in all participant and safe harbor contributions plus actual earnings thereon. Participants become 20% vested in discretionary employer matching and nonelective contributions after two years of credited service and vest 20% per year thereafter, becoming 100% vested after six years of credited service. Participants who are employed at time of death or disability become 100% vested in all amounts at that time.

Participant accounts – Each participant's account is credited with the participant's contribution, related employer contributions and an allocation of the investment earnings and expenses for each fund in which their account is invested. Allocations of investment income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The only benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes receivable from participants – Participants can borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the preceding one-year period or 50% of their vested account balance. The balances in the participants' accounts secure the loans. Loan terms range from one to five years, unless for the purchase of a principal residence, for which loan terms may range up to 15 years. Participants are limited to one outstanding loan at any time. Interest rates are established by the plan administrator based on prime plus 1%.

Forfeitures – The Plan uses any amounts forfeited to reduce future employer contributions or to pay plan expenses. During 2024, no forfeitures were used to fund employer contributions and approximately \$2,000 of forfeitures were used to pay plan expenses. There were no unused forfeitures at December 31, 2024 and 2023.

Distribution of benefits – The Plan provides for benefit distributions to plan participants or their beneficiaries, equal to the balance of their vested accounts upon death, disability, retirement, or other termination of employment. Participants may withdraw a portion or all of their accounts which are 100% vested, while still employed, upon reaching the age of 59½. Additionally, participants may qualify for a hardship withdrawal of their accounts which are 100% vested, while still employed, for the purpose of immediate and heavy financial needs, as defined in the Plan document.

Plan termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, insurance company and custodian. See Note 6 for discussion of fair value measurements.

The Plan invests in a fully benefit-responsive investment contract, the Principal Fixed Income Guaranteed Option (PFIGO) and reports this investment in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive investment contract represents contributions plus earnings, less participant withdrawals and administrative expenses.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions from Plan participants and employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Benefit payments to participants are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain investment management fees are included in net appreciation in fair value of investments. Other investment-related and recordkeeping expenses paid by the Plan are included in administrative expenses.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions. Actual results could vary from the estimates that were used.

NOTE 3 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 30, 2020 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan sponsor has indicated it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

NOTE 4 – INVESTMENTS

At December 31, 2023, substantially all assets of the Plan were invested in pooled separate accounts managed by John Hancock Life, as an insurance company of the Plan. At December 31, 2024, certain assets of the Plan were invested in funds managed by Principal Trust Company, the custodian of the Plan and Principal Life Insurance Company (PLIC), as an insurance company of the Plan. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

NOTE 5 – INFORMATION CERTIFIED BY INSURANCE COMPANY AND CUSTODIAN

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules related to notes receivable from participants and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, a qualified institution, for the period January 1, 2023 to August 5, 2024 and Principal, a qualified institution, for the period August 5, 2024 to December 31, 2024.

NOTE 6 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a hierarchy that prioritizes inputs used to measure fair value. The three levels of the fair value hierarchy are as follows:

- *Level 1* – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the reporting date.
- *Level 2* – Inputs are other than quoted prices included in Level 1, which are either directly observable or can be derived from or corroborated by observable market data at the reporting date.
- *Level 3* – Inputs are not observable and are based on the reporting entity’s assumptions about the inputs market participants would use in pricing the asset or liability.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the valuation methods used at December 31, 2024 and 2023.

- *Mutual funds* are value at the net asset value of the shares held by the Plan at year end.
- *Collective investment trusts (CIT)* are valued at the net asset value of the CIT. Net asset values are published daily and are the basis for current transactions.
- *Pooled separate accounts* are valued at net asset value as determined by the issuer based on the fair value of the underlying assets as determined by quoted market prices.

These valuation methods may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

NOTE 7 – INVESTMENT CONTRACT

In July 2024, the Plan entered into a benefit-responsive investment contract with PLIC. The general account portion of this contract, or the PFIGO, represents a group annuity contract, and the assets in this account are commingled with other assets of the insurance company. The account is credited with interest at the rate specified in the contract, but may not be less than 1%, and is charged for participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value such as: (1) complete or partial plan termination or merger with another plan, (2) plan sponsor events such as bankruptcy, spin-offs, divestitures, layoffs, or retirement incentive programs, (3) the liberalization of Plan withdrawal or transfer rules, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Upon occurrence of any of these events, a market value adjustment may apply. United Way does not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 8 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 13, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, no events were identified that are required to be disclosed or would have a material impact on reported net assets or changes in net assets.
