- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the MarketAxess Corporation 401(k) Profit Sharing Plan (the “Plan”) sponsored by MarketAxess Corporation (the “Company”) provides only general information. A more complete description of the Plan and its provisions can be found in the Plan Document.

General

The Plan is a defined contribution plan covering all full-time employees of MarketAxess Holdings Inc., and its subsidiaries, including the Company. Employees are eligible to participate in the Plan immediately upon hiring, contingent on the satisfaction of the eligibility requirements found in the Plan Document. Additionally, interns, summer interns, seasonal employees, occasional employees, and limited duration or temporary employees may also participate in the Plan on the first entry date once they have attained age 21 and have completed at least 1,000 hours of service during an eligibility computation period.

The Company adopted the Plan effective January 1, 1998. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Company has appointed Fidelity Management Trust Company (“Fidelity” or the “Trustee”) as trustee to, and recordkeeper for, the Plan.

The Plan is administered by the Company. The Plan has a trust agreement with Fidelity whereby they receive contributions, invest Plan assets, manage investment income or loss and distributes amounts for benefit payments as directed during the term specified by the respective agreements. As recordkeeper and the trustee of the Plan, Fidelity maintains certain accounting and other records of the Plan's transactions and assets.

The Plan was amended effective January 1, 2024 to i) recognize Pragma LLC as a related employer, ii) add Pragma LLC and Pragma Financial Systems LLC as entities for which prior service shall be credited by the plan; iii) increase the Company’s matching contributions of 100% of the participants' elective deferral to \$17,500; and iv) add the Fidelity Government Money Market Fund to the Plan.

The plan was amended effective June 3, 2024 to change certain permissible investment options.

Contributions

Each year, participants may contribute from their pre-tax and post-tax annual compensation up to a maximum dollar amount determined by the Internal Revenue Code (“IRC”) deferral limit. For the year ended December 31, 2024, participants were allowed to contribute up to 90% (the “Deferral Limit”) of their pre-tax and post-tax annual eligible compensation. For the year ended December 31, 2024, aggregate employee elective contributions were limited to \$23,000. All employees who maximize their elective deferrals under the Plan and who have attained the age of 50 before the close of the Plan year were eligible to make catch-up contributions of an additional \$7,500 for the 2024 calendar year. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan permits the Company to make matching contributions of 100% of the participants' elective deferral (up to \$17,500). In addition, the Plan permits an additional discretionary match at year end. There were no additional discretionary matches for the year ended December 31, 2024.

Vesting

Participants are vested immediately in their voluntary contributions and actual earnings or losses thereon. Vesting in the Company matching contributions is based on years of continuous service where service is defined as a minimum of 1,000 working hours in a calendar year: 25% after one year, 50% after two years, 75% after three years, and 100% after four years of service.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if applicable, and (b) Plan earnings and losses, and is charged with an allocation of investment expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits

A participant may elect to receive benefits as a lump-sum amount under the Plan upon hardship, normal retirement (the attainment of the later of age 65, or the fifth anniversary of participation in the Plan), early retirement (the attainment of age 55 and five years of service), termination of employment, disability, death or for other reasons as defined by the Plan.

Forfeited accounts

Forfeitures can be used to reduce administrative expenses and the employer contribution to the Plan. At December 31, 2024 and 2023, the forfeiture account balance was \$242 and \$1,050, respectively. Forfeitures of \$288,157 were used during 2024 to pay plan expenses and employer matching contributions to the Plan.

2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the reporting period and, when available, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Payment of benefits

Benefits are recorded when paid and are payable in the form of lump-sum distributions.

Plan expenses

Plan expenses incurred in connection with the administration of the Plan are paid by the Company and are excluded from these financial statements. Plan expenses incurred can also be paid by the use of available plan forfeitures. Plan expenses, related to notes receivable and in-service withdrawals from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

3. Investments and Fair Value Measurements

Each participant may direct that contributions be invested in various investment options offered. For administrative purposes, the Company requires that investment allocations are indicated as a percentage. A participant may change such allocation at any time directly with the Plan's recordkeeper, Fidelity. On each valuation date, the investment earnings or losses are determined for each investment option. A participant's share of these investment earnings or losses is determined based upon the ratio of the participant's account balances to the respective total investment option balance.

The FASB's Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability, or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- A. *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- B. *Common trust funds* – Common trust funds are comprised of shares or units in commingled funds that are not publicly traded. The underlying assets in these funds are primarily fixed income securities, bond funds, and derivative instruments and are valued at their NAV, as a practical expedient to fair value, that is calculated by the investment manager or sponsor of the fund and have varying liquidity, redemption period notices and other restrictions.
- C. *Money market funds* – Valued at one dollar per share held by the Plan at year end. Money market funds held by the Plan are mutual funds invested in highly liquid, near-term instruments and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

⁽¹⁾ Redemption of common trust funds is permitted daily. Funds moved from the common trust fund to certain other competing funds within the plan must be first held in non-competing funds for 90 days. There are no unfunded commitments. Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.

4. Investment Certification

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Fidelity, the trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- All investments and notes receivable from participants - related activity, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, Line 4i - schedule of assets (held at end of year) as of December 31, 2024.

5. Notes Receivable from Participants

Loans are made available to all participants and must be adequately collateralized using not more than 50% of the participant's vested account balance. The minimum amount of any loan is \$1,000, and the maximum amount of any loan is the lesser of \$50,000 or 50% of the vested balance. Loans bear interest at the applicable prime rate plus 1%. The interest rates on loans outstanding on December 31, 2024 ranged from 4.25% to 9.50%. All loans are required to be repaid within five years of the date of the loan (up to 30 years for loans relating to first-time home buyers) or upon termination of employment, except for those terminated due to a corporate action. Individuals terminated by a corporate action of the Company, that remain performing the same job after that corporate action, may request that Fidelity roll over the loan to the new employer's retirement plan within 60 days of termination. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Notes receivable are measured at the unpaid principal balance plus any accrued but unpaid interest. The participant pays expenses related to loan origination to Fidelity. There were no allowances for loan losses as of December 31, 2024 and 2023.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

7. Mutual Fund Fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

8. Tax Status

The Plan administrator has adopted a Fidelity Management & Research Co prototype plan document, which obtained its latest opinion letter dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or disclosure in the financial statements). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Related-Party and Party-in-Interest Transactions

A portion of the Plan's investments are comprised of mutual funds and common trust funds managed by Fidelity. Fidelity is the recordkeeper of the Plan and the custodian of the Plan assets and, therefore, the transactions related to these investments qualify as party-in-interest transactions. Fidelity provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund service providers exceeds the amounts owed Fidelity remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, \$21,056 was received from Fidelity and is reflected in other income in the statement of changes in net assets available for benefits. The account balance as of December 31, 2024 and 2023 was \$17,754 and \$785, respectively. Fees paid to Fidelity amounted to \$4,088.

10. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant would become 100% vested in his/her employer contribution.

11. Transfer from Related Plan

Effective January 1, 2024, the Plan received a transfer of assets from the Pragma Securities, LLC Insperity 401(k) Plan, a defined contribution plan sponsored by an affiliate of the Plan Sponsor. The transfer was the result of a plan consolidation initiated by the Plan Sponsor to streamline benefit administration.

The net assets transferred totaled approximately \$18,219,326, consisting of the following:

Investments, at fair value – \$18,178,700

Participant loans – \$40,626

The transfer increased the Plan's net assets available for benefits by \$18,219,326. Participant accounts were credited with balances in accordance with their respective interests under the transferring plan. The transfer of assets was completed in accordance with the requirements of ERISA, and participants in the Pragma Securities, LLC Insperity 401(k) Plan became participants of this Plan effective January 1, 2024.

12. Subsequent Events

The Company has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. There have been no subsequent events that required adjustment to or disclosure to in the financial statements as of and for year ended December 31, 2024, except for the following:

The plan was amended effective January 1, 2025 to reduce the maximum deferral election from 100% to 85%.
