## INDEPENDENT AUDITOR'S REPORT

To the Retirement Committee and participants of the  
Premier Healthcare Solutions, Inc. Retirement Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Premier Healthcare Solutions, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

### 1. Description of Plan

The following description of the Premier Healthcare Solutions, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a single-employer defined contribution plan sponsored by Premier, Inc. (the Company). The Plan includes six employers, which are all subsidiaries of the Company: Premier Healthcare Solutions, Inc. (formerly known as Premier, Inc.), Premier Healthcare Alliance, L.P. (formerly known as Premier Purchasing Partners, L.P.), Premier Supply Chain Improvement, Inc., SVS, LLC (S2S), CECity.com, Inc. (CECity.com), and Healthcare Insights, LLC (HCI). During 2024 and 2023, CECity.com and HCI had no employees and made no contributions to the Plan.

Employees are eligible to participate in the Plan on the later of the date the employee attains age 21, or the date of hire. Employees become eligible to participate in the profit sharing component of the Plan following the completion of one year of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Participants are automatically enrolled in the Plan upon meeting the eligibility requirements to make pre-tax contributions at a rate of 5% of eligible compensation, unless they elect otherwise. Each participant may elect to make pre-tax and/or Roth contributions up to 30% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus an additional \$7,500 for eligible participants who have attained age 50 by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company provides safe harbor matching contributions of 100% of first 3% of a participant's eligible compensation, plus 50% of the next 2% of the participant's eligible compensation contributed with respect to each payroll period to the Plan up to 4% in total. Safe harbor matching contributions were \$13,819,701 during the year ending December 31, 2024. In addition, the Company may, at its discretion, provide an additional profit sharing contribution determined by the Company's Board of Directors. The discretionary profit sharing contribution is allocated to each eligible participant who completes one year of service and is active on the

last day of the Plan year or has retired during the Plan year. During 2024, the Company did not make any discretionary contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered by the Plan and may change their investment options on a daily basis thereafter. The Plan also offers a self-directed brokerage account as an additional investment option for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions, plus earnings thereon. A participant vests gradually over five years in discretionary profit sharing contributions in accordance with the table below:

Less than 1	0%
1 but less than 2	15%
2 but less than 3	30%
3 but less than 4	50%
4 but less than 5	75%
5 or more	100%

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$39,716 and \$33,471, respectively, which are included in money market funds on the statements of net assets available for benefits. These accounts may be used to pay administrative expenses or to reduce Company contributions. During 2024, \$259 of forfeitures were used to pay administrative expenses and none were used to reduce Company contributions.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one half of their vested account balance. The maximum note term is 5 years, or 10 years for the purchase of a primary residence. Participants may have up to three notes outstanding at any time, for which only one may be for the purchase of a primary residence. The notes are secured by the participant's account and must bear a reasonable rate of interest as

defined in the Plan agreement. At December 31, 2024, interest rates on outstanding notes ranged from 4.25% to 9.50%. Principal and interest are paid through payroll deductions. During 2024, there were \$476,492 of deemed distributions, which are included in benefit payments on the statement of changes in net assets available for benefits.

### **Payment of Benefits**

At the time of death, disability, termination of employment or retirement, a participant or their beneficiary may elect to receive a payment of the vested interest in their account in a lump sum distribution. Participants are eligible to receive hardship withdrawals when certain conditions are met. After attaining the age of 59 ½, participants may also be eligible to make a withdrawal of all or any part of their vested account. If a participant terminates employment and has an account balance of less than \$1,000, the participant will automatically receive a lump-sum distribution of their vested account. If a participant terminates employment and has an account balance greater than \$1,000, but less than \$7,000, their balance will automatically be rolled over to an individual retirement account (IRA) set up in the participant's name, if no distribution election is made.

### **Administrative Expenses**

Participants are charged with specific transaction charges such as loan origination and distribution fees, as well as certain plan administration fees including audit, recordkeeping, and advisory fees. These plan administration fees are allocated to participants at an equal dollar amount based on the number of participants in the Plan. These expenses are paid to service providers of the Plan and qualify as party-in-interest transactions.

The Plan established an ERISA account where the qualified institution deposits revenue sharing payments that can be used to pay Plan administrative expenses or reallocated to participants. During 2024, \$85,655 was deposited into the account, which includes investment earnings. No expenses were paid from the account and \$85,000 was credited to participants at the direction of Company. The account balance at December 31, 2024 and 2023 was \$72,253 and \$71,598, respectively, and is included in money market funds on the statements of net assets available for benefits.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

The Plan's investment options are provided through the Premier Healthcare Solutions, Inc. Retirement Savings Plan Trust (the Trust), for which Fidelity Management Trust Company

(Fidelity) acts as the trustee. The statements of net assets available for benefits present the fair values of the investments included in the Trust.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Contributions**

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The Company discretionary profit sharing contributions are considered payable to the Plan upon approval by the Company's Board of Directors.

### **Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments. Interest income is recorded when received. Dividends on common stock are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

### **Notes Receivable from Participants**

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

### **Payment of Benefits**

Benefit payments are recorded when paid.

### Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity, the Plan's qualified institution.

### 4. Investments and Fair Value Measurements

Certain plan investments include money market funds, mutual funds, common/collective trusts, and self-directed brokerage accounts managed by Fidelity. Transactions in investments offered by Fidelity, the Plan's qualified institution, qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of the investment, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks, among others. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan’s own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and money market funds are valued at market prices for the identical security in an active market (Level 1).

Investments in self-directed brokerage accounts include exchange-traded funds, mutual funds, common stock, and interest-bearing cash. All investments in the self-directed accounts are valued at market prices for the identical security in an active market (Level 1).

Investments in the common/collective trusts (CCT) are valued daily to determine their net asset value (NAV) based on the fair value of the stocks, debt instruments, mutual funds, and other securities in the trusts. The CCTs may be traded daily at their NAV (Level 1).

### **5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their employer discretionary profit sharing contributions.

### **6. Income Tax Status**

The Internal Revenue Service has determined and informed the Company by letter dated August 9, 2013 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.



