## INDEPENDENT AUDITORS' REPORT

To the Plan Trustees of  
PCP/AHP/ABS 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of PCP/AHP/ABS 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

### Basis for Opinion

### NOTES TO FINANCIAL STATEMENTS

#### Note 1 - Description of the Plan:

The following description of the PCP/AHP/ABS 401(k) Profit Sharing Plan (the “Plan”) provides only general information and is presented to assist in understanding the Plan’s financial statements. The financial statements and notes are representations of the Plan’s management, which is responsible for their integrity and objectivity. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering all eligible employees of Primary Care Partners, LLC (the “Company”). Effective January 1, 2019, the Company executed a Supplemental Participation Agreement to designate Atlantic Health Partners, LLC (“AHP”) as a participating employer under the Plan. Effective January 1, 2024, the Company executed a Supplemental Participation Agreement to designate Atlantic Brain and Spine, LLC (“ABS”) as a participating employer under the Plan. Effective January 1, 2024, the Plan name changed from Primary Care Partners/Atlantic Health Partners 401(k) Profit Sharing Plan to PCP/AHP/ABS 401(k) Profit Sharing Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees of the Company are eligible to participate in the Plan upon completion of three months of service. Upon completion of 1,000 hours and 12 months of service, employees are then eligible to participate in the employer non-elective safe harbor and discretionary profit sharing portions of the Plan. The participant’s entry date is the first day of each calendar quarter of the Plan year, upon completion of the service requirements.

A participant may receive an allocation of the employer discretionary profit sharing contribution provided they have at least completed 1 year of service during the Plan year and are employed on the last day of the Plan year. A participant may receive an allocation of the safe harbor contribution for a particular plan year if they were eligible to participate in the Plan at any point during that Plan year, regardless of employment status as of the last day of the Plan year. Any compensation earned during a Plan year, but prior to the date an employee became eligible will be excluded in determining the allocation of the employer non-discretionary and safe harbor contributions.

**Administration of the Plan** - Administrative and Investment Committee are appointed by the Board of Directors of the Company. The Plan Sponsor serves as a fiduciary of the Plan. The Administrative Committee has responsibility for administering the Plan (Plan Administrator); the Investment Committee has responsibility for reviewing the performance of the Plan’s investments, which were held by Reliance Trust Company, the (“Trustee”) of the Plan.

**Contributions** - Eligible participants may defer up to 100 percent of their compensation on a “pre-tax” basis and “after-tax” basis subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 by the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may elect to make employer discretionary profit-sharing contributions. The Company will also make non-elective safe harbor contributions equal to at least 3% of each participant’s compensation. Employer discretionary profit-sharing contributions are made at the discretion of the Company and are allocated at the discretion of the Company.

The Company will make non-elective safe harbor contributions equal to \$546,250 for the year ended December 31, 2024. The Company will make discretionary profit-sharing contributions equal to \$2,115,691, net of forfeitures, for the year ended December 31, 2024.

**Vesting** - Participants maintain 100% vesting in their voluntary deferral, rollover and employer non-elective safe harbor contributions. Participants vest in the employer discretionary profit-sharing component of their individual account in accordance with the following schedule:

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, (b) net plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested amount. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Payment of Benefits** - On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum, or in annual installments over a period of not more than their assumed life expectancy or the assumed life expectancy of their beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If death occurs prior to retirement, the participant's account is paid to the designated beneficiary.

**Hardship Withdrawals** - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by the hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with IRS rules and regulations as well as the Plan document.

**Forfeitures** - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are used to reduce employer's matching contributions and to pay Plan administrative expenses. In 2024, the employer contributions were reduced by \$12,291. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$21,962 and \$7,191, respectively.

#### **Note 2 - Summary of Significant Accounting Policies:**

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing the information provided by the investment advisors and Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and withdrawal fees are charged directly to the participant's account and are included in administrative expenses. Fees related to administrative and record-keeping services are also included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through October 10, 2025, the date the financial statements were available to be issued. The effect of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

#### **Note 3 - Certified Investment Information:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- a) Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- b) Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

- c) Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets held (at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

#### **Note 4 - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the closing price in the active market in which the fund is traded.

- *Pooled separate account:* Valued at its “accumulation unit value” (AUV). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts and is then determined daily based on the net asset value of the shares of the underlying funds, the fund’s dividends and contract’s separate account charges. Fair value includes reinvested dividends and interest income, received and accrued, realized gains and losses, and unrealized gains or losses of the underlying separate account investments. There are no unfunded commitments at December 31, 2024 or 2023. Redemptions can be made daily and there are no other restrictions or penalties. The pooled separate account invests primarily in mutual funds whose objective is to seek a high total rates of return primarily from current income and long-term capital appreciation.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Transfers Between Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

#### **Note 5 - Pooled Separate Account:**

The Plan entered into a pooled separate account with the Trustee. The Trustee maintains the contributions in the pooled account. The pooled account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by the Trustee.

#### **Note 6 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their own contributions and in any employer contributions. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

#### **Note 7 - Notes Receivable from Participants:**

Participants may obtain loans from the Plan at a minimum of \$1,000 and a maximum of one half of a participant's account balance, or \$50,000 whichever is less, and may not have more than two loans outstanding at any time. Loans bear a reasonable rate of interest as reflected by local banks and are collateralized by a participant's account balance. Loans are generally repaid through payroll deductions within five years.

#### **Note 8 - Tax Status:**

The Plan was written on an IRS non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 9 - Party-in-Interest Transactions:**

The Trustee provides administrative and investment management services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and administrative services totaled \$139,126 for the year ended December 31, 2024.

#### **Note 10 - Risks and Uncertainties and Concentration of Investment Risk:**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investment in one fund comprises approximately 22% of total investments at December 31, 2024. The Plan's investment in two funds comprises approximately 31% of total investments at December 31, 2023.

#### **Note 11 - Prohibited Transactions:**

During 2023 and 2024, the Company's remittances of certain employee contributions to the Plan's Trustee totaling \$33,254 were not remitted within the period prescribed by DOL regulations. During 2024, the Company made contributions to the affected participants' accounts for two payroll periods totaling \$30,294 to compensate those participants for potential lost income due to the delays, totaling \$1,059. During 2025, the Company made additional contributions to the affected participants' accounts for two payroll periods totaling \$2,960 to compensate those participants for potential lost income due to the delays, totaling approximately \$200.
