Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of CHW 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of CHW 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

1. Description of Plan

The following description of CHW 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of Causseaux, Hewett & Walpole, Inc. (the "Company") who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Company management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Company is the Plan's administrator and Economic Group Pension Services is the Plan's recordkeeper.

The Company has entered into an agreement whereby, Voya Retirement Insurance and Annuity Company (the "Trustee") has been appointed the Trustee of the Plan's assets. Under the terms of the agreement, the Trustee holds and invests the funds of the Plan.

Plan merger:

In 2023, the Company was acquired by NV5 Global, Inc. As a result, effective December 31, 2024 the Plan was approved to merge into the NV5, Inc. 401(k) Profit Sharing Plan (the "Receiving Plan"). Accordingly, all investments were transferred from the Plan into the Receiving Plan on that date. As a result of the merger, all assets and liabilities of the Plan were transferred to the Receiving Plan. The total net assets transferred as of the merger date were \$10,059,897. In accordance with the merger agreement, all participants became fully vested in their account balances as of the merger date. Each participant's account balance under the Plan immediately following the merger equaled the sum of their account balances under the Plan immediately prior to the merger. All unallocated forfeitures under the Plan were allocated to participants in accordance with the Plan provisions prior to the merger. The Plan assets were zero as of December 31, 2024 and a final Form 5500 is being filed.

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollovers, amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Safe harbor match provisions provide for employer contributions equal to 100% of the participant's contributions up to 4% of compensation. The Company may also, at its discretion, make nonelective contributions. During the year ended December 31, 2024, the Company made no discretionary contribution to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued)

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's non-elective contribution portion of their accounts is based on years of continuous service. As described in Note 1, pursuant to the plan merger provisions all participants became fully vested in all of their accounts which merged into the NV5, Inc. 401(k) Profit Sharing Plan.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set by the plan administrator commensurate with prevailing interest rates at the date of loan issuance. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

SECURE Act 2.0:

On December 29, 2022, the Setting Every Community Up for Retirement Act ("SECURE") 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act, 2023. The SECURE 2.0 Act includes numerous reforms to retirement law intended to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and simplify and clarify retirement plan rules. As of December 31, 2024, and through October 14, 2025, the date the financial statements were available to be issued, Plan management believes Plan provisions conform with required SECURE 2.0 regulations, and it is the intent of Plan management to amend Plan provisions in the future, as needed.

2. Summary of Accounting Policies

Basis of accounting:

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements. All Plan assets were transferred to the Receiving Plan before close of business on December 31, 2024.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Accounting Policies (continued)

Notes receivable from participants:

Notes receivable from participants is measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits:

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid at December 31, 2024.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

3. Information Certified by Trustee

The December 31, 2024 and December 31, 2023, Statements of net assets available for benefits, the investment activities included on the Statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified as complete and accurate by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$0 and \$9,818,711, and notes receivable from participants of \$0 and \$120,418 at December 31, 2024 and December 31, 2023, respectively, and net appreciation in fair value of investments and dividends and interest income of \$1,337,813 for the twelve-month period ended December 31, 2024.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820, "Fair Value Measurements", are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Money market funds – Money market funds are valued at the closing price as reported by the fund sponsor from an actively traded exchange. The money market funds are open-end mutual funds that invest in short-term debt securities and cash equivalents. These funds are required to publish their daily net asset value and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Mutual funds – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Group annuity contract – The fair value of the group annuity contract is determined based on the market approach using credited interest rates published to the Plan on a daily basis. Any market value adjustments are based on formulas and schedules in the contract. The credited interest rate, account balance and formulas upon which payments may be based are observable through the contract.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023.

5. Related Party Transactions

Certain Plan investments and related transactions were in investment funds managed by the Plan's Trustee and, therefore, these investments and transactions qualify as party-in-interest transactions. The notes receivable from participants are also considered to be party-in-interest transactions. These transactions are not considered prohibited by statutory exemptions under ERISA.

6. Plan Termination

As described in Note 1, the Plan was merged into the NV5, Inc. 401(k) Profit Sharing Plan, effective December 31, 2024. Consequently, all employees eligible under the Plan became eligible to participate in and make contributions to the NV5, Inc. 401(k) Profit Sharing Plan. All assets were transferred as of December 31, 2024 and Plan management believes it has structured the transfer in a manner that does not constitute a plan termination. Participant account activity subsequent to the effective date of the merger will be transacted under the NV5, Inc. 401(k) Profit Sharing Plan.

7. Tax Status

The Company has adopted a prototype plan document that has received a favorable tax determination letter from the IRS dated June 30, 2020, stating that the pre-approved plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan itself has not received a determination letter and the prototype plan has been amended since receiving that determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of net assets available for benefits.

9. Late Remittance of Participant Contributions

During the year ended December 31, 2024, the Company inadvertently failed to make deposits of \$28,634 of participant deferrals on a timely basis. The Department of Labor considers late deposits, without regard to materiality, to be prohibited transactions. The general rule for deposits of 401(k) withholdings requires that the Company remit withheld employee 401(k) deferrals to the Plan as of the earliest date on which such amounts can reasonably be segregated from the Company's general assets. The Company intends to self-correct any lost earnings due to the delinquent contributions.
