Opinion

We have audited the accompanying financial statements of MVM, Inc. Health and Welfare Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – cash basis for the years then ended, and the related notes to the cash basis financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of MVM, Inc. Health and Welfare Plan – cash basis as of December 31, 2024 and 2023, and the changes in its net assets available for benefit – cash basis for the years then ended in accordance with the cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of MVM, Inc. Health and Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describe the basis of accounting. The financial statements and supplemental schedules are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with cash basis of accounting described in Note 2; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about MVM, Inc. Health and Welfare Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Note 1 - Description of Plan

The following description of the MVM, Inc. Health and Welfare Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan’s provisions.

General

The Plan and Trust were established on December 1, 1991 to provide health and other benefits to eligible participants and their dependents. The sponsoring employer, KG&P Strategies, Inc. (the “Company”) is bound by the terms and conditions of the Trust agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Securities Act of 1974, as amended (ERISA). The Plan was amended and restated effective January 1, 2024.

The sponsoring employer is KG&P Strategies, Inc. and following are participating entities: KG&P Strategies, Inc., MVM, LLC, The Kace Company, LLC, The Providencia Group, LLC and Sherpa, LLC d/b/a evolve24.

Benefits

The Plan provides medical, dental, vision, life, prescription drug coverage, employee assistance program, disability, flexible spending, supplemental accidental death and disability, hospital indemnity, accident, critical illness, medical abroad insurance, legal plan and health advocate program benefits for eligible participants and their dependents. The Plan allows for a health savings account, which is funded with employee contributions only and is not funded by the trust. The health savings account is not included in the statements of net assets available for benefits – cash basis or the statements of changes in net assets available for benefits – cash basis. Information about the Plan is available in the Plan documents, the Plan’s Trust agreement and the Service Agreement.

Fully insured benefits

The Plan fully insures the dental insurance benefits, life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and dependent), short-term disability, long-term disability, accident benefits, hospital indemnity, critical illness, medical abroad insurance, and legal plan benefits and employee assistance and health advocate programs. Premiums for these fully insured benefits are paid from the assets of the trust. The Plan also carries a stop-loss insurance policy, which covers both specific and aggregate claims, in excess of deductibles of \$150,000 per individual.

Self-insured benefits

The Plan provides for self-insured medical, vision, and prescription drug benefits for eligible participants and their dependents. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan’s trust account. Despite the Plan’s utilization of third-party claim’s processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions

The Plan is a contributory plan that is funded by both participating employee and Company contributions. Active employee contributions are withheld through payroll deductions in amounts determined by the employee’s elections during the annual enrollment period.

The Company contributes a percentage of the premium based on the participant’s election. Former employee (i.e. COBRA) contributions are remitted directly to the Company in amounts determined by the participants’ elections during the annual enrollment period.

Payment of benefits

The Plan provides certain medical, dental, vision, prescription, and other coverage to the participating employees and their eligible family members based on the type of service rendered and whether and in-network or out-of-network service provider is used.

Plan administration and expenses

Administrative expenses are paid from Plan assets. During the years ended December 31, 2024 and 2023, Cigna Health and Life Insurance Company ("Cigna") processed the medical claims and prescription claims. For medical claims processing, Cigna received a fee, based on the number of participating employees in the Plan, which was paid from Plan assets. For prescription claims processing, Cigna received a fee, based on the number of prescription claims processed, which was paid from Plan assets.

Pursuant to an agreement between the Plan and Willis, insurance broker, certain defined administrative and management services are provided or arranged by Willis.

Pursuant to an agreement between the Plan and Government Service Administrators (GSA), certain recordkeeping services are provided by GSA.

Pursuant to an agreement between the Plan and Hartford Life and Accident Insurance Company ("Hartford"), certain leave management and Americans with Disabilities Act ("ADA") management support services are provided by Hartford.

Pursuant to an agreement between the Plan and Health Advocate Solutions, Inc., certain healthcare navigation services are provided by Health Advocate Solutions, Inc.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the cash basis, additions to net assets are recognized when received rather than when due and deductions from net assets are recognized when paid rather than when incurred. Consequently, no liabilities for health claims incurred but unpaid are included in the financial statements. In addition, no assets related to potential insurance recoveries or under funding amounts, if any, are included in the financial statements.

Cash

The Plan's cash consists of non-interest bearing accounts to pay claims as incurred.

Investment valuation and income recognition

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors.

Purchases and sales of securities are recognized principally on a trade-date basis. Interest income is recorded on the cash basis.

Benefit Payments

Claim payments are recorded when paid.

Estimated benefit obligations

The total amount of estimated benefit obligations is determined based on (1) historical data regarding the time that typically elapses between the dates on which claims are incurred and the dates on which they are paid, and (2) available information about the amount of claims that were paid subsequent to the fiscal year end but incurred during the fiscal year.

Administrative expenses

All administrative expenses are generally paid by the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Estimates

The preparation of financial statements using the cash basis of accounting requires Plan management to make estimates and assumptions that affect the amounts reported in the cash basis financial statements. Such estimates primarily relate to unsettled transactions and events as of the date of the cash basis financial statements. Accordingly, upon settlement, actual results may differ from those estimates and assumptions.

Concentrations of Credit Risk

The Plan maintains its cash balances in two financial institutions which may, from time-to-time, exceed the FDIC limit. Management does not feel there is a risk of loss.

Termination of Plan

In the event of termination, the Company shall continue to provide contributions to the Plan for the purpose of paying benefits and expenses incurred before the termination.

Note 3 – Fair Value Measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market – Valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated January 1, 2007, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although, the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

The Plan Sponsor received a notice from the Internal Revenue Service dated December 29, 2023 stating that they owed an Employer Shared Responsibility Payment for tax year 2021. The issue was resolved in 2024.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Plan shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of Plan management, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the Plan’s participants.

Note 6 – Other Risks and Uncertainties

The present value of benefit obligations is reported based on certain assumptions pertaining to historical claims paid and future claims, all of which are subject to change. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

These estimated benefit obligations and the changes in the benefit obligations are not reported in the accompanying cash basis financial statements because of the Plan’s use of the cash basis of accounting, as described in Note 2.

Note 8 – Stop Loss

The Company has a stop loss insurance policy in order to be reimbursed for Plan benefits paid in excess of a specific attachment point. For the Plan years ending December 31, 2024 and 2023, the specific attachment point was \$150,000 per individual. The policy also includes an aggregating specific attachment point of eighty-five percent of the first monthly aggregate attachment point multiplied by twelve. Once an individual exceeds the \$150,000 specific attachment point, then they or a group of participants must also exceed the aggregating specific attachment point before the Plan Sponsor is reimbursed. After acceptable proof of loss and satisfactory proof of paid plan benefits, the insurance company will then reimburse the Plan Sponsor. For the Plan years ending December 31, 2024 and 2023, stop loss premiums paid, net of stop loss experience refunds, were \$1,376,358 and \$1,297,050, respectively.
