### Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of Hayman Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Hayman Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024****NOTE 1 - PLAN DESCRIPTION**

The following description of Hayman Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of The Hayman Company (the "Company") who have completed 2 months of service, are age 18 or older, and are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - The Plan provides for employee salary deferral contributions up to a maximum of 75 percent of the eligible compensation subject to maximum limitations established by the Internal Revenue Code. Salary deferrals consist of pre-tax and Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enroll participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant.

The Company may, at its discretion, make matching contributions. Matching contributions equal to 25% of the first 4% of compensation that a participant contributes to the Plan. Matching contributions totaling \$78,138, were made for the year ended December 31, 2024 of which \$20,545 was funded by available forfeited account balance. The Company may also authorize discretionary profit sharing and qualified nonelective contributions to the Plan for the related year. There were no discretionary profit sharing or qualified nonelective contributions authorized for 2024.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers a stable value fund and various mutual funds as investment options.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and allocations of (a) the Company's discretionary profit sharing contribution (when made), (b) the Company's discretionary qualified non-elective contribution (when made), and (c) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participants' compensation, account balances, or specific participant transactions as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their contributions and any qualified non-elective contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts are based on years of continuous service. A participant vests on a graded schedule, vesting 20% after 2 years of credited service and each year thereafter, resulting in 100% vesting after 6 years of credited service.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to maximum amount as prescribed in the Plan and in the Internal Revenue Code. The notes are secured by the balance in the participant's account. The loan interest is determined on the day the loan is issued by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024****NOTE 1 – PLAN DESCRIPTION (CONTINUED)**

**Payment of Benefits** - Distributions are payable upon the retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. A participant who has attained age 59½ may request a withdrawal of all or a portion of his or her vested account balance or various installment annuities. The Plan also permits withdrawals of active participants' elective contributions only in amounts necessary to satisfy financial hardships as defined by the Plan.

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,700 and \$10,144, respectively. These accounts are used to reduce future employer contributions or reduce administrative expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of the maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for custodial and record keeping services are paid by the Plan. Fees for the administration of notes receivables from participants and distribution costs are charged directly to the participant's account.

**Date of Management's Review of Subsequent Events** - Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

### NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

#### Level 1 Fair Value Measurements

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, as trustee, has certified the completeness and accuracy of the investment information reflected on (1) the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and (2) the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024. Fidelity Management Trust Company has also certified the completeness and accuracy of the investments reflected in Schedule H, line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024****NOTE 5 – STABLE VALUE FUND – GUARANTEED INVESTMENT CONTRACT (GIC)**

The Plan has a stable value investment option (GIC) with Standard Insurance Company. The contract on this investment meets the fully benefit-responsive investment contract criteria.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The contract is presented on the face of the statements of net assets available for benefits at contract value in arriving at net assets available for benefits. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administration expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract value of the fully benefit-responsive investment contract at December 31, 2024 and 2023 was \$27,016 and \$523,255, respectively. If all participants were eligible for a distribution of their full accounts from the Plan on the reporting date, the amount payable on demand on the reporting date would be at “contract value”. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

In the event that the full value of the account could not be paid upon demand, such as amounts subject to the Market Value Adjustment, the “fair value” estimates are based upon “demand value” for the contracts. The “demand value” is the amount due to the contract holder under the surrender provisions of the contracts.

Certain events limit the Plan’s ability to transact at contract value with the issuers of the Guaranteed Investment Contracts. Such events may include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan) or (b) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan. Furthermore, certain events would allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events may include: (a) an uncured breach of the Plan’s investment guidelines, (b) a material amendment to the contracts without the issuer’s consent, (c) a violation of a material obligation under the contracts, or (d) a material misrepresentation. The Plan Administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with plan participants or the issuer are probable of occurring. Based on the above, fair value approximates contract value.

**NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST**

Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to the trustee, record keeper and investment advisor totaling \$34,828, for the year ended December 31, 2024, which was not covered by revenue sharing. All these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. The Plan has a stable value investment option (GIC) with Standard Insurance Company. The contract on this investment meets the fully benefit-responsive investment contract criteria.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all employer contributions.

**DECEMBER 31, 2024****NOTE 8 - TAX STATUS**

The Plan is based on the Non-Standardized Pre-Approved Profit Sharing Plan (“Pre-approved Plan”) of Fidelity, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Pre-approved Plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). The Plan has not filed for its own determination letter from the IRS. The Plan has been amended since the date of the opinion letter. However, the Plan management believes the Plan is designed to operate in compliance with the applicable requirements of the IRC. Therefore, Plan management believes the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
