Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Knighted Ventures, LLC 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Knighted Ventures 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of Plan

The following description of the Knighted Ventures 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution Plan, with elective deferral and employer matching contribution features, that was established effective January 1, 2016, and covers all employees of Knighted Ventures LLC, Elevated, LLC, Knighted Services, Inc., Game Knight, Inc., Champions Group, Inc., Champions Houston LLC, and Champions Dallas, LLC (the "Employers"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

Employees become eligible to participate in the Plan after attaining a minimum age of 21 years old and two months of service to be eligible for employer matching contributions, and one year of service to be eligible for profit sharing contributions. Enrollment is effective the first day of each calendar month of the Plan year coinciding with or following satisfaction of the eligibility requirements.

Contributions

Participants may contribute up to 100 percent of their pretax annual compensation as defined in the Plan, subject to certain limitations as prescribed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions or rollovers from other qualified defined benefit or defined contribution Plans. Participants direct both the investment of their contributions and Employers' matching contributions into various investment options offered by the Plan.

The Employers may elect to make discretionary matching and profit-sharing contributions, subject to certain limitations, to the Plan in an amount determined by the Employers. For the year ended December 31, 2024, the Employers made discretionary matching contributions equal to 25 percent of the participants' contribution, up to 4 percent of eligible salary. To be eligible for the Employers' matching contributions, the participants must have satisfied the eligibility requirements mentioned above.

Notes To Financial Statements *(Continued)*

Participant Accounts

Each participant's account is credited with the participant's contribution and the Employers' contributions, if any, as well as earnings associated with his or her investment elections. Participants' accounts are charged with any withdrawals or distributions requested by the participant, investment losses, and an allocation of administrative expenses, if applicable. Allocations are based on participants' earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Policy

Participants are immediately vested in their contributions plus accumulated earnings thereon. Employers' contributions, plus accumulated earnings thereon, are based on a graded schedule whereby a participant is 100 percent vested after 5 years of credited service as outlined in the table below. Otherwise, a participant becomes fully vested immediately in employer contributions upon reaching normal retirement age, death or becoming permanently disabled while employed, as well as upon termination of the Plan or the complete discontinuance of employer contributions to the Plan.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance in their accounts during the prior 12-month period, or 50 percent of their vested account balance. Participants may have one loan outstanding at a time, and terms range from 1 to 5 years, or up to 20 years for the purchase of a primary residence. The loans are secured by the respective participant's vested account balance and bear interest at the Wall Street Journal prime rate plus 1.0 percent. Principal and interest are paid ratably through bi-weekly payroll deductions.

Notes To Financial Statements (*Continued*)

Payment Of Benefits

The government places certain restrictions on withdrawals in order to retain the special tax- saving benefits associated with the Plan. Upon termination of service due to disability, retirement, or for other reasons, a participant or beneficiary may elect to receive the value of the vested interest in his or her account as a lump-sum payment, partial payment, annuity contract, in installments over a period of time determined by the event, or to roll the balance directly over to an eligible retirement Plan or individual retirement account. However, if the value of a separated participant's vested balance is between \$1,000 and \$5,000, the Plan can cause the vested balance to be transferred to an individual qualified retirement account. If the value of a separated participant's vested balance does not exceed \$1,000, the Plan can cause the vested balance to be either transferred to an individual qualified retirement account or distributed to the separated participant directly. In the event of a participant's death, payment of the vested value of the participant's account is made to his or her beneficiary in one lump-sum payment or in installments.

Other withdrawals are available only in cases of immediate and heavy financial hardship, upon meeting certain requirements as defined by ERISA and approval from the Plan Administrator. A participant's right to make deferrals will be suspended for six months after receipt of a hardship withdrawal.

Forfeited Accounts

At December 31, 2024 and 2023, the accumulated forfeited nonvested account balances totaled \$28,000 and \$38,000, respectively, and are included in investments in the statements of net assets available for benefits. Under the terms of the Plan, the Plan can use forfeitures to pay expenses in connection with the management and operation of the Plan or to reduce future employer contributions. During the year ended December 31, 2024 the Employers elected to use \$30,236 to pay Plan expenses.

Administrative Expenses

Non-investment costs, primarily accounting and administrative expenses of the Plan, are paid for by the Employers, which are parties-in-interest. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions. Certain Plan recordkeeping and advisory services and administrative fees are paid by the Plan or charged against Plan investment activities and are included in the statement of changes in net assets available for benefits. Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are reported at fair value. Fair value is the price that would be received in an asset sale or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Fair Value Measurements

The Plan follows current accounting standards, which establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for asset measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds

Valued at the NAV of units of the collective trust funds. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchase and sales) may occur daily. The collective trust funds file an annual report on Form 5500 as a direct filing entity, and there are no capital commitments related to these investments.

Pooled Separate Accounts (PSA)

Valued at the net asset value (NAV) as a practical expedient of units held by the Plan at year end. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. PSA are comprised, primarily, of shares of mutual funds that are traded on an active market. PSA may be redeemed by participants daily at NAV. For the years ended December 31, 2023, the Plan had no unfunded purchase commitments or redemption restrictions. Investments that are measured at NAV as a practical expedient have not been categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Party In Interest Transactions

Certain investments offered by the Plan are managed by Fidelity Management Trust Company and John Hancock Investment Management Company, the trustee and custodian of the Plan, respectively, during the years ended December 31, 2024 and 2023; therefore, all transactions in these investments and expenses paid to the custodians qualify as party-in-interest. Notes receivable from participants are also party-in-interest transactions.

7. Income Tax Status

The Plan uses a pre-approved plan document sponsored by Standard Retirement Services. Standard Retirement Services received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan, in its entirety, at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

9. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. It is at least reasonably possible, given the level of risk associated with investment securities that changes in the values of investment securities in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.
