INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of
South Bay Hotel Employees Restaurant Employees Welfare Fund:

Opinion

We have audited the financial statements of South Bay Hotel Employees Restaurant Employees Welfare Fund, an employee benefit plan subject to the Employment Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended; and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of South Bay Hotel Employees Restaurant Employees Welfare Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Notes to Financial Statements

December 31, 2024 and 2023

1. DESCRIPTION OF THE FUND

South Bay Hotel Employees Restaurant Employees Welfare Fund (the “Fund”) was established on December 23, 1958, by a trust agreement between local unions whose members are employed in the hotel, restaurant and related industries and certain employer associations and independent operators in those industries. The Fund provides medical, life, dental, vision, prescription drug, and accidental death and dismemberment benefits for eligible participants and their dependents. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

General eligibility rules under the Fund are as follows:

- a. Participants attain initial eligibility upon working 100 hours for two consecutive months and become eligible for coverage on the first day of the fourth month. However, because of the economic hardships from COVID-19, effective January 1, 2021, the Board of Trustee’s approved lowering the hours requirement to obtain coverage from 100 hours to 80 hours per month. This change has been adopted indefinitely.
- b. To maintain continuing eligibility, the participant must work 80 hours or a combination of 22 hours or more plus self-payments to equal the 80 hours required for continued coverage.
- c. The Fund has adopted an hour bank whereby the participant can accumulate up to 80 hours to be used for continuing eligibility when working 22 hours or more but less than the required 80 hours.

The Fund has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-funded benefits. If the claims paid on behalf of an eligible participant or dependent exceed the deductible amount of \$185,000 for the years ended December 31, 2024 and 2023, the carrier will reimburse the Fund for the excess in accordance with the terms of the stop-loss insurance arrangement. During the years ended December 31, 2024 and 2023, self-funded benefits exceeding the stop-loss deductible totaled \$1,092,750 and \$507,326, respectively.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (COBRA), has been adopted by the Fund.

Participants should refer to the Summary Plan Description for more complete information.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

Notes to Financial Statements

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Fund. Unobservable inputs reflect the Fund's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Fund has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Method

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for the Fund's investment classes are presented below.

Money Market Funds, U.S. Treasury notes, exchange-traded funds, and mutual funds: Money market funds, U.S. Treasury notes, exchange-traded funds and mutual funds are valued based on quoted market prices (Level 1).

Corporate Obligations: Corporate obligations are valued based on discount yield/price modeling that takes into account the various maturity dates and stated coupon rates of the bonds (Level 2).

Valuation Methods, Consistency

The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Employer contributions due and not paid at year-end are recorded as employer contributions receivable. Management has evaluated contributions receivable and believes all amounts are fully collectible. Therefore, an estimate for current expected credit losses is not provided.

The collectability of contributions due as a result of payroll audits is uncertain. In determining the amount of the allowance as of the financial statement date, management developed a loss rate based on management's historical collection experience, adjusted for management's expectations about current and future economic conditions. At December 31, 2024 and 2023 management believes its historical loss rate is a reasonable and supportive forecast for current and future economic and industry conditions.

Participant Contributions

Participant contributions withheld by employers, which are due but not paid at year-end, are recorded as participant contributions receivable. Management has evaluated contributions receivable and believes all amounts are fully collectible. Therefore, an estimate for current expected credit losses is not provided.

Stop-Loss Refunds Receivable

Stop-loss refunds from the Fund's stop-loss carrier for refunds earned prior to year-end and received after year-end are recorded as stop-loss refunds receivable.

COBRA Subsidy Receivable

COBRA subsidies earned prior to year-end and received after year-end are recorded as COBRA subsidy receivable.

Benefit Obligations

Estimates of claims payable and claims incurred but not reported and of accumulated eligibility credits were based on premiums and claims experience data. Claims payable and claims incurred but not reported is an estimate of the cost to the Fund for claims incurred by participants under the terms of the Fund through December 31 of each year but paid by the Fund subsequent to December 31. Accumulated eligibility credits is an estimate of the cost to the Fund for benefits earned based on work performed in November and December that provides eligibility for the following months of January and February. Accumulated eligibility credits also include an estimate of the cost of hours banked by participants for work through December and provide eligibility for a period of one month, beginning in March or later. Premiums payable is estimated based on premiums paid subsequent to year-end for December and prior eligibility.

The Fund provides health benefits to retired employees. In order to receive these benefits, retirees must contribute 100% of the cost determined by the Fund's consultant. Therefore, no obligation to provide post-retirement benefit obligations is recorded on the financial statements.

Housing Benefit

Effective December 8, 2023, the Plan established the Housing Benefit to provide participants with financial assistance for employee housing. This benefit is only available to participants of employers contributing to the Housing Benefit Fund. There is currently only one employer contributing to the Housing Benefit Fund. Any participant of a contributing employer who has been employed by that employer for at least two years as of November 1, 2023, shall be eligible for housing assistance of \$1,000, while participants employed for at least one year but less than two years shall be eligible for housing assistance of \$500.

Managed Care Services

Effective August 18, 2022, the Fund adopted an amendment to the Administrative and Claims Services Agreement between the Fund and the Third-Party Administrator "Administrator", adding new services. The Administrator agrees to provide the Fund with medical claim optimization services to obtain savings or discounts to claims utilizing internally developed technology systems or contracted third parties to reproduce claims, each as determined appropriate by the Administrator. This process is described as Managed Care Services. The Administrator will receive a contingency fee of \$1,485 for these services.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Fund invests in various investment securities. Such investments are exposed to various risks, such as market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Fund in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Fund is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Fund. Any remaining Fund assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Fund. Termination shall not permit any part of the Fund to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Fund obtained its latest determination letter, dated December 17, 1962, in which the Internal Revenue Service stated that the Fund qualified under Section 501(c)(9) of the Internal Revenue Code and, therefore, is not subject to tax under present income tax laws. The Fund has been amended since receiving the determination letter. However, the Fund's administrator and the Fund's counsel believe that the Fund is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Fund was qualified, and the related trust was tax exempt as of the financial statements date.

Accounting principles generally accepted in the United States of America require management to evaluate the tax positions taken by the Fund and to recognize a tax liability if the Fund has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Fund and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Fund is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Fund is financed by employer, participant and retiree contributions and by participants electing COBRA coverage. The monthly employer contribution rate is specified in the collective bargaining agreements. Employer contributions are based on hours of work and are made in accordance with rates set forth in the collective bargaining agreements. Contribution rates for participants electing dependent coverage, for retirees, and for participants electing COBRA coverage are set by the Board of Trustees based on information provided by the Fund's consultant.

7. CONCENTRATIONS

The Fund has significant cash balances at financial institutions which throughout the year regularly exceed the federally insured limit of \$250,000. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Company's financial condition, results of operations, and cash flows.

The Fund had one employer that accounted for approximately 27% and 26% of employer contributions during the years ended December 31, 2024 and 2023, respectively. Economic changes to this employer might result in a significant financial impact to the Fund.

8. COBRA SUBSIDY

On March 11, 2021, the American Rescue Plan Act of 2021 ("ARPA") was enacted to provide relief from the economic and health effects of the COVID-19 pandemic and ongoing recession. The ARPA includes a provision for COBRA premiums assistance which helps qualified participants continue their health benefits. For qualified participants, the ARPA provides that such participants are treated as having paid the full amount of such premium. The Fund is then reimbursed directly for the COBRA coverage provided. The premium assistance applies to health coverage on or after April 1, 2021 through September 30, 2021.

For the year ended December 31, 2021, the Fund submitted COBRA premiums assistance totaling \$3,589,110. As of the date of the financial statements, the Fund has not yet received the subsidy, and the Plan Administrator is working with the IRS to collect amounts due. Management believes this amount to be fully collectible. Therefore, an estimate for current expected credit losses is not provided.

9. RELATED PARTIES

The Fund is related through common trustees with the South Bay Hotel Employees Restaurant Employees Training Fund (the "Training Fund") and the South Bay Hotel Employees Restaurant Employees Legal Fund (the "Legal Fund"). Contributions for the Training and Legal Funds are received by the Plan and remitted to the applicable Funds when processed. As of December 31, 2024 and 2023, there were \$3,615 and \$3,615, respectively, in contributions received by the Plan and not yet remitted to the Training and Legal Funds.
