## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of USCB, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of USCB, Inc. Employee Stock Ownership Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the USCB, Inc. Employee Stock Ownership Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about USCB, Inc. Employee Stock Ownership Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. DESCRIPTION OF PLAN

The USCB, Inc. (the "Company") established the USCB, Inc. Employee Stock Ownership Plan (the "Plan") effective January 1, 2003. The Plan operates as a leveraged employee stock ownership plan (ESOP), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan has purchased shares of Company common stock using the proceeds of a loan from the Company, and holds the stock in a trust established under the Plan. The borrowing is to be repaid by fully deductible Company contributions to the Plan. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the Internal Revenue Code (the "Code"). The borrowings are collateralized by the unallocated shares of stock. The Company has no rights against shares once they are allocated under the Plan. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024 present separately the assets and liabilities, and changes therein pertaining to:

- \* The accounts of employees with rights in allocated stock (allocated); and
- \* Stock not yet allocated to employees (unallocated)

The Plan document includes detailed rules for each situation. Participants and other interested parties should refer to the Plan agreement and any amendments regarding specific provisions of the Plan.

**Participation**

All employees employed on January 1, 2003 became participants. Thereafter, all employees of the Company who are age 20 or older and have completed 1,000 hours of service in one year are eligible to participate in the Plan.

**Retirement Age**

The normal retirement age is 62.

**Vesting**

Participants vest 20% in their accounts after completion of two years of vesting service, and an additional 20% each year thereafter. Participants are 100% vested upon death or disability. A year of vesting service is earned for each year in which the participant is credited with 1,000 years of service.

**Benefits**

Normal retirement date for participants under the Plan is the later of age 62 or the completion of five years of service. Upon termination of service due to death, disability or retirement, the participant will receive either a lump sum amount or installment payments equal to the value of the participant's vested interest in his or her account. If some or all of a participant's account balance is allocated to the employee stock ownership feature of the Plan, that portion of the Plan benefit may be paid in the form of Company stock.

The Plan changed the benefit distribution policy in 2023. The revised distribution policy is as follows: i) if the value of participant's vested account is \$5,000 or less, distribution will be made during the plan year following termination of service and will be made in a single lump sum cash payment. ii) if the value of the participant's account exceeds \$5,000, distribution will be made in six annual installments. The first installment will be made in the plan year following termination of service. The minimum value of each annual installment will be the lesser of \$5,000 or the remaining vested balance.

**Benefits (continued)**

If a participant with a vested account balance of \$7,000 or less does not accept a distribution when offered, the distribution will be made in a direct rollover to an Individual Retirement Account without consent.

If a participant whose vested balance exceeds \$7,000 and either elects not to receive a distribution, or otherwise fails to return the distribution election form, the Plan will maintain such account balances until the participant requests a distribution. After such a request is received, the regular distribution policies will apply.

**Allocations**

A participant is entitled to share in the allocation of contributions for each year in which he or she has completed 1,000 or more of service hours and is still employed by the Company at the end of the Plan year. A participant automatically participates in contributions in the year of normal retirement, disability or death. Allocations of contributions are based upon the ratio of participants' covered compensation, as defined by the Plan, to total covered compensation of all eligible participants.

**Contributions**

The Company makes contributions to the Plan, in cash or by cancellation of indebtedness, in amounts sufficient to permit the Plan to make timely payments of principal and interest due under the terms of its loan. The Company made a cash contribution of \$900,000 for 2024.

**Put Option**

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. Participants eligible to diversify make their election after year-end based on the number of shares of the employer's stock held in their account at year-end.

**Administrative Expenses**

Administrative expenses are paid by the Company.

**Forfeitures**

Forfeitures of non-vested shares are allocated to current participants, used to restore forfeitures, reduce Company contributions or to pay plan expenses. If allocated, the allocation is based upon the ratio of participants' covered compensation to total covered compensation of all eligible participants. A total of 2,760.23 shares were forfeited in 2024.

**Voting Rights**

A participant has the right to direct the voting USCB, Inc. common shares allocated to his or her account with respect to any corporate matter that involves the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction as the Department of Treasury may prescribe in its regulations. On other corporate matters requiring a vote of the shareholders, the ESOP Committee shall direct the trustee to properly vote shares held in participants' accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Date of Management Evaluation**

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

**Investment Valuation and Income Recognition (Continued)**

The fair value of the Company common stock is based on an annual independent appraisal. This appraisal was based on a Discounted Cash Flow Method. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums. The Employee Benefits Administration Committee, under the supervision of the Company's Board of Directors, determines the fair value measurement policies and procedures in consultation with the Company's chief financial officer. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

Level 1 - Inputs are quoted prices in active markets.

Level 2 - Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 - Inputs are generally observable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

**3. PARTY-IN INTEREST TRANSACTIONS**

The Plan invests in Company common stock and had indebtedness guaranteed by the Company. These are related party and party-in-interest transactions. As described in Note 1, the Company pays the expenses of the Plan. The Plan has a service provider. Such parties are parties-in-interest under ERISA. The Investment Committee of the Plan utilizes an investment advisor, GreatBanc, to serve as the independent investment advisor for the Plan. GreatBanc (1) recommends mutual funds to be included in the Plan's investment menu, (2) monitors the performance of those funds against certain pre-determined standards, and (3) recommends the removal of funds from the investment menu and the replacement of these funds by alternative funds if the advisor determines that the funds to be removed are not performing in accordance with pre-determined standards. Fees paid by the Plan to GreatBanc are party-in-interest transactions.

**4. INCOME TAX STATUS**

The Plan has received a favorable letter of determination, issued by the Internal Revenue Service on June 10, 2014, stating that the Plan constitutes a qualified plan under Section 401(a) of the Code. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, the rights of participants to their accounts as of the date of the termination shall be nonforfeitable.

**6. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by GreatBanc Company, the trustee of the Plan. The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**8. ADMINISTRATIVE AND PLAN ASSETS**

The Plan's assets, which consist principally of Company common stock, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which is reimbursed to the Trustee through contributions as determined by the Company. Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

**9. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the risk associated with certain investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the financial statements. The Plan's exposure to the credit loss in the event of non-performance of the investments is limited to the carrying value of such investments.
