Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Health Care Employees/Employer Dental and Medical Trust (the "Plan") is provided for general information purposes only.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

The Plan is a multi-employer plan providing medical, dental, prescription, life and supplemental benefits to eligible employees and their dependents. The Plan is maintained pursuant to various collective bargaining agreements between the Service Employees International Union, and certain other organizations and their affiliates operating in California, and between employers who are parties to various participation and collective bargaining agreements with the organizations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Active employees are eligible for those benefits specified in their collective bargaining agreement. Dependents of eligible active employees are also eligible to receive benefits.

1. Inception Date - July 1, 1976

2. Contributions

Under the terms of the applicable participation or collective bargaining agreements, contributions are made to the Plan at the prevailing premium coverage rate plus \$8.75 and \$1.90 administration fees assessed per participant for medical and dental premium coverage, respectively. An additional 3% dental administration fee is assessed on premiums paid for each employer covered under the Plan. Contributions from the IHSS Fresno, Sonoma, San Joaquin, Santa Cruz, Napa, San Bernadino and Sacramento groups are determined based on monthly hours worked by the county employees.

3. Eligibility

Eligibility for participants (including initial eligibility, maintaining eligibility, and the loss of eligibility) is determined by the applicable participation or collective bargaining agreements between the employers and the organizations. Eligibility for IHSS participants is determined through negotiations between the public authority and the organizations based on a minimum hours worked requirement. Contributions for hours worked are received in the following month which determines eligibility for the next month. The Plan provides future benefits to IHSS participants through the IHSS Employer Reserve Liability program to those participants who have worked the minimum hours to receive eligibility. In the event that contribution funding is not sufficient to cover benefits for all eligible IHSS participants, a waiting list is used. Participants who cease to be eligible for Plan coverage during the periods of disability, unemployment or retirement may, in certain circumstances, keep benefits in force by making monthly payments in an amount designated by the Board of Trustees. This self-payment provision is limited in duration depending upon the nature of the qualifying event.

4. Benefits

The Plan offers medical, prescription, life and supplemental benefits primarily through various fully-insured contracts. Dental benefits are primarily offered through fully-insured experience-rated contracts with Delta Dental described in Note 4.

5. Termination of the Plan

Although there is no intent to do so, in the event of termination of the Plan, the Board of Trustees, after accounting for any and all funds and property remaining in the Plan and after payment of or making adequate provisions for all liabilities relating to or affecting the Plan, the Board of Trustees shall use remaining Plan assets, if any, for the purpose of continuing the benefits herein provided for and shall adopt any plan or procedure for the fair and orderly administration of said remaining assets for such benefits pursuant to law.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accounts of the Plan are maintained on the accrual basis accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results may differ from those estimates.

C. Employer Contributions and Deferred Revenue

Employer contributions as reported are contributions by employers on behalf of employees for the hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts. Contributions received by the Plan prior to its year-end but due after year-end are recorded as deferred revenue.

D. Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' payroll records under a separate payroll compliance program.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

E. Tax-Exempt Status

The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i. Therefore, no provisions for federal or state income tax is made.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - CONCENTRATION OF CREDIT RISK

During 2024, the Plan had cash deposits with Heritage Bank of Commerce and Community Bank of the Bay, that exceeded the Federal Deposit Insurance Corporation insurance limit of \$250,000 per bank. The Board of Trustees believe the banks to be creditworthy and to date have not incurred any losses.

NOTE 4 - DELTA DENTAL PREMIUM RATED CONTRACT

Delta Dental performs an experience rating calculation at the end of each contract period on the Plan's group policy. If the calculation indicates that premiums paid under the group policy exceeded the claims and retention for the contract year, a surplus is credited to the Plan. If the calculation reflects a deficit, the deficit will be offset against future contract year surpluses until fully repaid, before any surplus is credited to the Plan. If a deficit remains upon termination of the group policy by either Delta Dental or the Plan, the Plan will not be liable for the deficit. The experience rating calculation for the years ended December 31, 2024 and 2023 resulted in a surplus of approximately \$2.1 million and \$3.1 million.
