Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Foothill Family Service 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Foothill Family Service 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following brief description of Foothill Family Service 403(b) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

The Plan is a Section 403(b) tax-deferred annuity plan covering all employees of Foothill Family Service, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

All employee contributions to the Plan are through salary reduction agreements between Foothill Family Service, Inc. and its employees. For the years ended December 31, 2024 and 2023, federal tax law limit of basic participant contributions to the plan was 100% of participant salary up to \$23,000 and \$22,500, respectively, plus a limit of \$7,500 in catch-up contributions for participants who attain the age of 50 or more by the end of a taxable year.

Employer Contributions

Effective December 31, 2014, the employer, as defined in the plan, may make matching and/or profit-sharing contributions each year. Foothill Family Service, Inc.’s matching levels are reassessed annually by the employer’s board of directors. As of, and for the year ended December 31, 2024, the employer matched 50% of the first 4% of the eligible participant’s contribution. In addition, Foothill Family Service, Inc. contributes 3% of the eligible participant’s salary.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Foothill Family Service, Inc.’s contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Each participant has a nonforfeitable right to 100% of the value of his or her accounts.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan, continued

Plan Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loan terms vary based upon the purpose of the loan from 1-5 years for a general-purpose loan, or up to ten years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid quarterly by the participant.

Forfeitures

Forfeitures of employer discretionary contributions are allocated to the individual qualifying participant accounts. Forfeitures of matching contributions are applied to reduce employer contributions or administrative expenses. The forfeiture balances were \$14,262 and \$14,567, respectively, for the periods ended December 31, 2024 and 2023.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to either receive a lump-sum distribution equal to the value of his or her account, or to rollover a portion or the entire balance of the account to another retirement account.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned, and related fees are recorded as administrative expenses and expensed when incurred.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statements elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentration of credit risk consist of cash invested in money market and mutual funds. Credit risk related to these investments is limited as funds are invested in debt and equity securities of companies located in many different geographic regions and industries.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results may differ from those estimates.

Administrative Expenses

The costs of the plan for accounting and administration expenses are the responsibility of the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statement of Net Assets Available for Benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

3. Reclassifications

Certain amounts have been reclassified for the year ended December 31, 2023 to conform to the presentation for the year ended December 31, 2024.

4. Notes Receivable from Participants

Loans to participants are repaid semi-monthly at varying interest rates. Loans to participants outstanding at December 31, 2024 and 2023 were \$349,138 and \$290,935, respectively.

The Voya Fixed Plus Account III guarantees minimum rates of interest and may credit interest that exceeds the guaranteed minimum rates. Daily credited interest becomes part of principal and the investment increases through compound interest. All amounts invested by the plan in the Voya Fixed Plus Account III receive the same credited rate. This is known as a portfolio method of interest rate crediting.

The Mutual of America general account (interest accumulation account) is comparable to a cash equivalent and therefore exempt from classification as a Level 1, 2, or 3 asset under ASU-820-10 for the following reasons: 1) there are no front-or-back end chargers, so investments in the general account are completely liquid; 2) the interest rate credited to investments in the general account is a current rate, and is not dependent upon the length of time the assets are invested with Mutual of America Life Insurance Company; 3) requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the company having to liquidate securities in order to generate a payment; and 4) the value shown on the pension fund report is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

8. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$57,436.

The Plan's investment options include funds managed by Voya or its affiliates. As custodian and recordkeeper, Voya's transactions qualify as exempt parties-in-interest transactions.

9. Plan Termination

Although it has not expressed any intent to do so, Foothill Family Service, Inc. has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

10. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (“IRC”). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (“IRS”). The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
