Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Morrow Equipment Company, L.L.C. Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1) Description of the Plan

The following description of the Morrow Equipment Company, L.L.C. Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was first established effective April 1, 1985, as Morrow Crane Co., Inc. Savings Plan. During 1993, Morrow Equipment Company, L.L.C. (the “Company”) was formed by a transfer of substantially all of the assets of American Pecco Corporation and Morrow Crane Co., Inc. Substantially all operations and personnel were also transferred. American Pecco Corporation had previously established a profit-sharing plan on October 1, 1986. As such, the two plans were merged into one plan, effective January 1, 1994, now known as the Morrow Equipment Company, L.L.C. Savings Plan. The plan is a defined contribution plan which is qualified as a cash or deferred arrangement and profit-sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (the “Code”). The Plan covers employees of Morrow Equipment Company, L.L.C. who have completed two months of service and are age eighteen or older. Employees may enter into the plan on the first day of the calendar month coinciding with or next following satisfaction of their eligibility requirements. The Employer serves as the Plan Administrator. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA) as amended.

Contributions

Plan participants are permitted to make elective deferrals of their total compensation up to certain limits as defined in the Plan. Participants at least 50 years of age may also make catch-up elective deferral contributions subject to Code limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company matches 50 percent of participant’s contributions up to the first six percent of the participant’s compensation. Additional amounts may also be contributed at the discretion of the Board of Directors. Matching and discretionary contributions totaling \$433,414 and \$418,910 were made for the years ended December 31, 2024 and 2023, respectively.

It is the policy of the Company to fund contributions to the Plan on a regular basis as soon as participant deferrals are made, and employer contributions are elected.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions and their allocable share of Company matching contributions into a variety of investment choices as more fully described in the Plan’s literature.

Participants may change their allocation daily. All investments are participant directed.

Participant Accounts

Each participant's account is credited with elective deferrals, the employer matching contribution, a pro-rata allocation of the Company's discretionary contribution, and the applicable fund's earnings. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' elective deferrals, transfer, and rollover accounts are always 100 percent vested and non-forfeitable. Company matching contributions and discretionary contributions are 100 percent vested when eligible to participant in the plan.

In addition, a participant's vested percentage shall be 100 percent upon death, total and permanent disability while an employee, or attainment of early or normal retirement age, which is defined as age 55 and 65 years of age, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates. Principal and interest is paid in level payments over a period not to exceed five years. Interest paid by participants on their loan balances is credited to their individual accounts.

Payment of Benefits

Upon termination of employment, a participant may elect to receive the entire vested benefit. The distribution is to be made in the form of a lump sum, an annuity, or periodic payments based on the participant's election.

Upon retirement, the participant has benefit elections similar to the above.

The Plan also provides participants who demonstrate "financial need" with the option of withdrawing an amount against the sum of elective deferrals, transfer, and rollover contributions.

Payment of benefits is not guaranteed as this Plan is not covered by plan termination insurance.

2) **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See additional information in the “Fair Value Measurements” note to the financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, record keeping, short-term trading, and other costs are charged directly to the participant’s account and are included in the administrative expenses. Investment related expenses are deducted from net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts

Valued at the NAV of units of a common collective investment trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4) Guaranteed Investment Contract with Insurance Company

In 2019, the plan entered into a fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (OneAmerica). OneAmerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The crediting rate is based on a formula established by the contract issuer and averaged two percent for the years ended December 31, 2024 and 2023. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the plan by OneAmerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The contract was liquidated during 2024.

5) Information Certified by the Custodians (Unaudited)

The custodians, American United Life Insurance Company (AUL), a OneAmerica company, and Voya Institutional Trust Company (Voya), hold all investments and execute all investment transactions on behalf of the Plan. Information regarding the value of all investments, participant loans, interest and dividend income, and net appreciation/depreciation in the fair value of investments have been certified by the custodians as complete and accurate in accordance with 29 CFR Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

6) Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Voya. Voya is the third-party administrator as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in the summary of significant accounting policies note, the Plan made direct payments to the third-party administrators of \$7,367 which was not covered by revenue sharing. The

Plan Sponsor pays directly any other fees related to Plan operations. Other parties-in-interest include the Plan's investment committee, participants, and anyone performing services for the Plan.

7) Trustees of the Plan

The Plan provides for an Investment Committee to be appointed by the Board of Directors. These individuals are officers or employees of the Company and are responsible to appoint the Plan trustee.

8) Plan Termination

Although it has not expressed any intent to do so, Morrow Equipment Company, L.L.C., has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

9) Tax Status

The Company has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the form of the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the prototype sponsor and the plan administrator believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11) Excess Contributions

Excess contributions payable as of December 31, 2024 and 2023, consist of \$- and \$33,296 respectively, which were refunded to participants subsequent to year-end.

12) Accrued Qualified Nonelective Contribution (QNEC)

The definition of compensation used to calculate participant deferrals for the period January 2020 through March 2023, was inconsistent with that stipulated in the plan documents, resulting in missed deferrals. The correction amount has been accrued as a receivable and includes 50% of the total missed deferrals as well as an estimate for lost earnings. The QNEC receivable as of December 31, 2024 and 2023, is \$392,093 and \$275,359, respectively.
