Independent Auditor's Report

To the Trustees and Participants of
Western States 401(k) Retirement Fund of the OPEIU:

Opinion

We have audited the financial statements of Western States 401(k) Retirement Fund of the OPEIU, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits as of December 31, 2024 and the changes in net assets available for benefits for the year then ended of Western States 401(k) Retirement Fund of the OPEIU in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Western States 401(k) Retirement Fund of the OPEIU and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Other Matter - December 31, 2023 Financial Statements

The financial statements of Western States 401(k) Retirement Fund of the OPEIU as of December 31, 2023, were audited by other auditors whose report dated October 14, 2024, expressed an unmodified opinion on those statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description of Plan

The following brief description of the Western States 401(k) Retirement Fund of the OPEIU (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement and summary plan description for more complete information.

General

The Plan was established in 1959 to provide an individual account retirement plan for participating eligible employees who are: (a) an employee of an employer covered by a collective bargaining agreement which requires or permits contributions to the Plan; (b) an employee of the Union; (c) an Associate Employee of an employer; and (d) an employee of an employer, not covered by a collective bargaining unit, but are in a classification approved by the Plan's board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Employers shall contribute to the Plan for each participant, the applicable amount as set forth in the Employer's collective bargaining agreement or special agreement. Participants may elect to make voluntary 401(k) contributions equal to the lesser of (a) 100% of their earnings or (b) the annual deferral limit applicable under Internal Revenue Code 402(g) which includes a catchup contribution for those participants who are age 50 or older

Participants Accounts

Each participant's account is credited with (a) contributions made by the participant's Employer; (b) contributions made by the participant; and (c) an allocation of Plan earnings and expenses. The allocation of Plan earnings and expenses to each participant's account is based on the ratio of the participant's account balance, after reduction for distributions, to the total of all participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are 100% vested in their accounts at all times.

Benefits

Benefits can be paid from the Plan upon termination of employment, retirement, death, disability, or upon reaching age 59½. Benefits can be paid in a lump-sum, periodic and nonperiodic installments as set forth in the Plan.

Effective January 1, 2019, the Plan was amended to permit participants to receive a distribution of their account, plus earnings thereon, in the case of certain hardships as defined in the Plan. Participants should refer to the Summary of Material Modifications of information contained in the Summary Plan Description for what qualifies as a hardship and other requirements for such a distribution.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Options

The Plan provides participants with a choice from an array of different investment options. The allocation of Employer and participant contributions among the investment options must be in 1% increments. Participants may change their investment allocation for both current assets and future contributions on a daily basis. All investments are participant directed.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the pooled separate account which represents a fully benefit-responsive investment contract and is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Contributions Receivable

Employer contributions receivable represent the amount that employers are obligated to contribute under the terms of their labor agreements for work that participants performed during the year ended December 31. Participant elective deferrals receivable represent amounts withheld from employees' paychecks during December. These receivables typically are collected within 20 days, and management believes the amounts are fully collectible. Accordingly, there is no allowance for expected credit losses.

3. Income Tax Status

The Plan obtained its latest determination letter, dated July 16, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, or that any instances of noncompliance would be eligible for correction, including self-correction, under an applicable Internal Revenue Service corrective procedure. They believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate the tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees.

In the event of termination, the rights of all affected participants to all account balances shall be nonforfeitable. After payment of expenses properly chargeable against the Plan, the Trustees shall determine the time of commencement of payment of benefits and the method of distribution.

5. Loans in Default

Beginning July 1, 2015, the Plan no longer offered the ability for participants to borrow from the Plan. The amounts shown as loans to participants on the statements of net assets available for benefits represents the outstanding principal balance on loans that were made prior to July 1, 2015, all of which are in default. Loans are classified as loans in default if the participant fails to make payments for a consecutive ninety (90) day period. The loans are secured by the individuals' account balances and will be deducted from the participants' account balance upon distribution of their benefit.

6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observed for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported on the actual date of the event or change in circumstances that caused the transfer.

The Plan’s management evaluates the significant transfers, if any, between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2 or 3.

7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

8. Pooled Separate Account

Pooled separate account (New York Life Insurance Co. Anchor Accounts) – The Plan has entered into an investment contract with the New York Life Insurance Company Stable Value Fund, Anchor Account IV (the “Fund”). The Fund maintains contributions in a pooled account which is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is fully benefit-responsive. For example, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Fund is valued at contract value based on the value of the underlying investments, which consist of U.S. government and agency securities, asset-backed securities, mortgage-backed securities, collateralized mortgage obligations, commercial mortgage-backed securities and corporate bonds. The value of underlying assets are determined based on a model that uses inputs that may include interest-rate yield curves, cross-currency-basis index spreads or country credit spreads that are similar to the valued bond in terms of issuer, maturity and seniority. Participant transactions (purchases and sales) may occur daily.

Certain market value events may limit the ability of the Fund to transact at contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the Fund and lead to any Fund disbursements which have or will have a material adverse effect on the operations of the Fund and a financial effect on the investment contract or wrap issuer’s interest thereunder.

Such events may include but are not limited to: Fund administration amendments or changes, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of a Fund, failure to meet certain tax qualifications, transfers to competing options without meeting the equity wash provisions of the Fund, and plan sponsor withdrawals without the appropriate notice to the Fund and/or issuer.

In the normal course of business, such events or conditions would not limit the ability of the Fund to transact at contract value with the participants in the Fund. The Fund is managed to maintain a certain amount of liquidity to provide for the day to day liquidity needs of participants as well as the occasional market value event.
