1. Description of Plan

The following description of the Stratos 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a multiple employer defined contribution 401(k) profit sharing plan as defined under Section 413(c) of the Internal Revenue Code, administered by Stratos Global Services, LLC (the Plan Sponsor/Employer and Plan Administrator), covering eligible participants of the employers subscribing to the Plan. Participating employers include Stratos Global Services, LLC, Forex Capital Markets, LLC (a related party of the Employer), and Basic Pay II, LLC (an unrelated party), (collectively the "Participating Employers"). The Plan covers all employees of the Participating Employers, excluding residents of Puerto Rico and interns, who are age 18 or older. There is no service requirement for participation in the Plan, except interns excluded solely because of their classification shall become eligible to participate in the Plan upon attainment of age 21 and completion of 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan was amended effective March 6, 2023, to change the name of the Plan from FXCM 401(k) Plan to Stratos 401(k) Plan as result of a change in the Plan Sponsor's name from FXCM Global Services, LLC to Stratos Global Services, LLC. There were no changes to the Plan's provisions resulting from the name change.

Contributions

Each year, participants may contribute up to 85 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after 35 days of employment unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated lifecycle fund until changed by the participant. The Participating Employers may make discretionary matching contributions on behalf of eligible participants as a uniform percentage of the participants' elective deferrals. For the year ended December 31, 2024, the Participating Employers made a discretionary match of 25 percent of the first 6 percent of base compensation that a participant contributed to the Plan, which totaled \$157,999. The Participating Employers may also make discretionary non-elective

contributions. Discretionary non-elective contributions are allocated to the account balances of eligible participants in the ratio that each eligible participant's compensation bears to the total compensation paid to all eligible participants for the contribution period. For the year ended December 31, 2024, there were no discretionary non-elective contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Participating Employers' matching contributions, allocations of the Participating Employers discretionary contributions, if any, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Participating Employers contribution portion of their accounts is based on years of continuous service. Participants become 50 percent vested in the discretionary matching contribution portion of their accounts after 2 years of service and 100 percent vested after 3 years of service. A participant is 100 percent vested in the discretionary non-elective contributions portion of their account after 1 year of service. Participants shall become 100% vested in the Participating Employers discretionary matching and non-elective contributions portion of their accounts upon disability, death, or attainment of normal retirement age (age 65), as defined, if still employed by the Participating Employers on that date. Participants who are members of a class that includes a prior plan employer with vesting source contributions shall be immediately 100 percent vested in those contributions.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to 5 years or greater for the purchase of a primary residence.

Payment of benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Effective January 1, 2024, if a terminated participant's vested balance is less than or equal to \$7,000 (\$5,000 prior to 2024), the amount may be automatically distributed in the form of lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant does not elect a distribution upon termination and their vested account balance is between \$1,000 and \$7,000, the vested portion of their account balance will be rolled over into an individual retirement account (IRA). In-service withdrawals are permitted for participants who remain employed after age 59 ½. In addition, the Plan allows for in-service hardship distributions if certain criteria are met.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,793 and \$14,698, respectively. These accounts may be used to pay Plan expenses. Any forfeitures not used to pay Plan expenses shall be used to reduce the contributions of the Participating Employers for the immediately following Plan year. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts.

Recent Regulatory and Economic Events

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with effective dates beginning January 1, 2023 and beyond. SECURE 2.0 is intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules. During 2024, the Plan increased the threshold for mandatory cash-out distributions from \$5,000 to \$7,000 pursuant to the optional provisions under SECURE 2.0. See Note 12 for subsequent event disclosure information related to provisions adopted in 2025 .

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers, custodian/trustee and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Participating Employers. Expenses that are paid by the Participating Employers are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued. See Note 12 for subsequent events disclosure information.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Money market funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: The underlying investments of the self-directed brokerage account held by the Plan consist of common and preferred stocks, mutual funds, and interest-bearing cash accounts such as money market funds and certificates of deposit. These investments are valued at the closing price reported on the active market on which the individual securities are traded.

4. Information Certified by Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as exempt party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fidelity Management Trust Company receives revenue from investment fund service providers for services Fidelity Management Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Fidelity Management Trust Company for its administrative services to the Plan. If the revenue received by Fidelity Management Trust Company from such investment fund service providers exceeds the amount owed for its services, Fidelity Management Trust Company remits the excess to the Plan's trust on a quarterly basis. The Plan or the Participating Employers may make a payment to Fidelity Management Trust Company for administrative expenses not covered by revenue sharing. During 2024, direct payments made by the Plan for service provider fees total \$20,411. These transactions qualify as exempt party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as exempt party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Participating Employers. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Participating Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Tax Status

The Plan adopted a pre-approved plan offered by Fidelity Management & Research, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Delinquent Participant Contributions

For the years ended December 31, 2024 and 2023, the Plan administrator did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances, which constitute non-exempt prohibited transactions and are identified on the Schedule of Delinquent Participant Contributions, totaled \$419 and \$560 for the 2024 and 2023 Plan years, respectively. During 2024, the Company remitted the 2023 delinquent contributions and compensated the affected participant for lost earnings resulting from the delay in remitting the contributions. A participant contribution receivable totaling \$560 related to these delinquent contributions is included in the statements of net assets available for benefits as of December 31, 2023. There was no receivable related to the 2024 untimely remittance as the contribution was remitted to the Plan prior to December 31, 2024. The Company intends to remit the lost earnings on the 2024 untimely remittance as soon as administratively possible (see Note 12).

10. Compliance Matters and Voluntary Corrections Program

The Plan administrator identified that during 2019 through 2022, eligible bonus compensation was excluded from the calculation of employer matching contributions. In July 2023, the Plan administrator remitted to the Plan employer matching contributions totaling \$75,192 plus the lost earnings related to this error and filed a submission with the IRS under the Voluntary Compliance Program (VCP) of the Employee Plans Compliance Resolution System (Rev. Proc. 2019-19) stating their intention to correct these errors by making the corrective contributions plus applicable lost earnings to the affected participants. As of the date of the auditors' report the response from the IRS was still pending.

12. Subsequent Events

In May 2025, the Company remitted the lost earnings to the affected participant's account to compensate the participant for the delays in remitting the 2024 contribution (see Note 9).

Effective January 1, 2025, the Plan adopted the increased catch-up contribution limits for participants age 60 through age 63 pursuant to Section 109 of the SECURE 2.0 Act. Under this provision, for eligible participants, the catch-up limit increases to \$11,250 for 2025, which is 150 percent of the age 50 catch-up amount. Additionally, the Plan adopted the optional SECURE 2.0 Act withdrawal provisions, which includes the Domestic Abuse, Emergency Expense, Qualified Disaster Withdrawal, and the Qualified Birth and Adoption Distribution provision.

The Plan was amended effective June 26, 2025, to adopt the e-certification provisions for hardship withdrawals.

The Plan was amended effective July 11, 2025, to allow for In-Plan Roth Rollover Contributions and In-Plan Roth Conversions.

The Plan is in the process of being amended with an effective date of September 29, 2025, to allow for forfeitures not used to pay Plan expenses or reduce Participating Employer contributions to be allocated to eligible participants.
