Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Hornwood Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Hornwood Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **NOTE A – PLAN DESCRIPTION**

The following brief description of the Hornwood, Inc. ("Company") Retirement Plan ("Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a contributory defined contribution plan covering substantially all full-time employees of the Company who have one year of service and are age eighteen or older. The Plan was established on February 1, 1995 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Employee Contributions

Each employee who is eligible and wishes to participate in the Plan executes a salary reduction agreement to withhold a percentage of his or her compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

### Employer Contributions

The Company may make matching contributions equal to a discretionary percentage of salary deferrals as determined each year, limited to 6% of eligible compensation. Contributions are subject to certain limitations. For the years ended December 31, 2024 and 2023, the Company's matching contribution was 25% of the first 6% of contributions. Matching contributions for 2024 and 2023 were \$49,932 and \$50,385, respectively. The Company may also make discretionary profit-sharing contributions to the Plan. During the years ended December 31, 2024 and 2023, no discretionary profit sharing contributions were made.

### Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, if any, as well as allocated Plan earnings (losses) and fees, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Investment Options

Upon enrollment in the Plan, a participant directs contributions in any of the Plan's investment options. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their salary reduction contributions and discretionary profit sharing contributions plus actual earnings thereon.

Vesting in the employer matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service according to the following schedule:

Notes Receivable from Participants

At the discretion of the administrative committee, a participant may borrow up to \$50,000 or 50% of his or her vested individual account balance, whichever is less. Terms range from 1 to 5 years unless the loan qualifies as a home loan. The loans are secured by the balance in the participant's account and bear interest at 8.75% - 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount of the value of the vested interest in his or her account, or equal installments over a period of not more than assumed life expectancy of the participant or his or her designated beneficiary. If the value of the participant's account is \$1,000 or less, a lump-sum distribution will be made.

Forfeited Accounts

Forfeitures of non-vested Company contributions are used to reduce administrative expenses or future Company contributions. At December 31, 2024 and 2023 there were \$12,983 and \$11,750, respectively, of forfeited non-vested accounts that had not yet been applied to reduce administrative expenses or the Company's contributions. No forfeitures were used during 2024 and 2023.

**NOTE B - SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Plan administrative expenses are allocated to participants ratably based on participant balances.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D, "Fair Value Measurements" for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

**NOTE C – NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are valued at the amortized cost of the note which is felt to approximate fair value. Interest income is recorded when received. The Plan currently does not have an allowance for doubtful accounts as all amounts are considered collectible.

**NOTE D – FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The Plan has investments in participation units held in pooled separate accounts through sub-accounts of an insurance company. Except for the pooled separate account noted in the following paragraph, the underlying securities in pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits, administrative maintenance charges and other items) and reported by the insurance company denotes readily determinable fair value. These pooled separate accounts are classified in Level 1 in the fair value hierarchy.

One of the Plan's pooled separate accounts primarily invests in a stable value fund which represents participation units of a collective investment trust for which the net asset value is based on the market value of the underlying investments. The stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The Plan has concluded that the net asset value as adjusted and reported by the insurance

**NOTE F - PLAN TERMINATION**

While it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested in their accounts, and the assets of the Plan shall be administered and distributed to the participants and beneficiaries at such time and in such nondiscriminatory manner as prescribed by ERISA and its related regulations.

**NOTE G - TAX STATUS**

The Plan was established through the adoption of a prototype plan sponsored by Loren D. Stark Company. The Internal Revenue Service has determined and informed Loren D. Stark Company by a letter dated November 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) and, therefore, is exempt from Federal income taxes. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date. The Plan has determined that it does not have any material unrecognized tax benefits or obligations as of December

31, 2024. The Plan is generally subject to routine audits by the Internal Revenue Service and/or Department of Labor for three years, including 2021, 2022, and 2023. There are currently no audits for any periods in progress.

**NOTE H - PARTY-IN-INTEREST TRANSACTIONS**

Fees paid to John Hancock Life Insurance Company, the Plan's third party administrator, amounted to \$27,384 and \$27,631 for the years ended December 31, 2024 and 2023, respectively. The fees are included in administrative fees in the statements of changes in net assets available for benefits. Certain investments in pooled separate accounts are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE J – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through July 21, 2025 (the issuance date of the financial statements) and has determined that there were no subsequent events to recognize or disclose in these financial statements.
