**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Tunnell Companies, L.P. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Tunnell Companies, L.P. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

**Opinion**

## **Basis for Opinion**

#### NOTE A - DESCRIPTION OF THE PLAN

The following description of Tunnell Companies, L.P. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a single employer discretionary profit sharing and 401(k) elective deferral plan, established on January 1, 1990, and covers substantially all employees of Tunnell Companies, L.P. (the Company). Employees are eligible for participation in the Plan upon one year of service and having worked at least 1,000 hours and the attainment of age 21.

Contributions: Eligible employees may make elective deferral contributions to the Plan each year, subject to the limitations as defined in the Plan document, in pre-tax and/or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions not exceeding the limit set by the Internal Revenue Code (IRC) in addition to the deferral contribution. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover contributions).

Effective January 1, 2024, to comply with the SECURE Act 2.0, the Plan provides that long-term, part-time employees having worked at least 500 hours for three consecutive years and have attained the age of 21 are eligible to make elective deferral contributions to the plan. The Company is not required to make employer matching contributions on behalf of these employees.

The Company matches 50% of the employee elective deferral up to 6% of the participant's pay each payroll period. An additional required Company safe harbor matching contribution of 3% of participant's pay is made following the plan year end.

Participant Accounts: Each participant's account is credited with the participant's contribution, Company match contribution, Company safe harbor contribution and allocation of Plan earnings, and is charged with withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeited nonvested amounts are used to reduce employer contributions in the year of forfeiture.

Vesting: Participants are immediately vested in all elective deferral, catch-up, rollover and employer safe harbor contributions as well as actual earnings thereon. Vesting in the Company's employer match contributions is based on years of service and provides for 100% vesting after 6 years of credited service.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$ 1,000 up to a maximum equal to the lesser of \$ 50,000 or 50% of their vested account balance. A participant may have no more than one loan outstanding at a time. The length of the loan cannot exceed five years unless the loan is for the acquisition of the participant's principal residence and then the loan cannot exceed fifteen years. The loans are secured by the balance of the participant's account and bears interest at prevailing interest rates charged by similar lending institutions. Principal and interest is paid ratably through payroll deductions.

#### NOTE A - DESCRIPTION OF THE PLAN - CONTINUED

Payment of Benefits: Generally, benefit payments commence at the employee's normal retirement age (age 65). Early retirement benefits can be elected after the participant has reached the age of 55 and has completed six years of vested service. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or rollover the vested account into another retirement plan. The Plan permits withdrawals of active participants' vested balances in amounts necessary to satisfy financial hardship as defined by the Internal Revenue Service (IRS). In-service withdrawals of vested balances may be elected by participants who have reached 59 1/2 years of age.

Forfeited Accounts: Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$ 188 and \$ 93, respectively. These accounts will be used to reduce future employer contributions. Also in 2024, employer contributions were reduced by \$ 21,438 from forfeited nonvested accounts.

The Plan is administered by Robert W. Tunnell, III, managing partner of Tunnell Companies, L.P. This individual has the overall responsibility for the operation and administration of the Plan.

#### NOTE B - SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting under accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the payment date. Dividends are recorded on the payment date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Participant loans are valued at their outstanding balance, which approximate fair value.

## NOTE B - SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes receivable are recorded as distributions based on the terms of the Plan document.

### Expenses

Expenses incurred administering the Plan are paid by the Plan and are allocated to each participant's account based on their balance at the time of the allocation. Fees for the administration of notes receivable and distributions are included in administrative expenses and charged directly to the participant's account.

### Payment of Benefits

Benefits paid to participants are recorded upon their distribution.

### Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

## NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. The Plan does not hold any assets valued under Level 2 or Level 3.

In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

**NOTE C - FAIR VALUE MEASUREMENTS - CONTINUED**

The common/collective trust fund is valued at the net asset value (NAV) of units of an investment company collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The December 31, 2024 and 2023, statements of net assets available for benefits, the investment activities included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments and notes receivable from participants of \$ 21,388,995 and \$ 19,226,831 at December 31, 2024 and 2023, respectively, and the related net appreciation in the fair value of investments, interest and dividends for the year ended December 31, 2024. All investments are participant directed.

**NOTE F - PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fidelity Management Trust Company is the trustee, custodian and record keeper for the Plan, and holds the Plan's investment assets and executes investment transactions for participants. All Plan investments are in funds selected by Fidelity Management Trust Company. Fees paid by the Plan for costs associated with the administration of the Plan amounted to \$ 49,375 for the year ended December 31, 2024. The Plan holds investment funds managed by Adkadios Wealth Advisors and Osaic FA Inc.; therefore, these transactions and the Plan's payment of fees in the amount of \$ 42,729 to both advisors qualify as party-in-interest transactions. The Plan contracts with Associated Benefit Planners, Ltd. for Plan year end administration as well as preparing Form 5500; therefore, these transactions and the Plan's payment of fees to Associated Benefit Planners, Ltd. qualify as party-in-interest transactions. The Plan contracts with Jefferson, Urian, Doane & Sterner, P.A. as an independent auditor for the Plan; therefore, these transactions and the Plan's payment of fees in the amount of \$ 20,450 to Jefferson, Urian, Doane & Sterner, P.A. qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules or ERISA.

**NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE H - INCOME TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Subsequent to this issuance of the opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt. If the Plan were subject to interest and penalties, they are included under deductions in the statement of changes in net assets available for benefits.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Therefore, the value, liquidity, and related income of the securities are sensitive to changes in economic condition, delinquencies, or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE J - SUBSEQUENT EVENTS**

On February 3, 2025, Plan provisions were amended to include employees of Tunnell Management Company, LLC.

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Additional provisions will become effective in 2025 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
