### INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
the SRC of Lexington, Inc. Health and Welfare Trust

#### **Opinion**

We have audited the accompanying financial statements of SRC of Lexington, Inc. Health and Welfare Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (cash basis) for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (cash basis) of SRC of Lexington, Inc. 
### **Auditor's Responsibilities for the Audit of the Financial Statements**

**1. Description of Plan**

**General**

The SRC of Lexington, Inc Health and Welfare Trust (The Plan) was established to provide certain medical expense benefits, as described more fully in the Summary Plan Description, to all eligible employees.

The plan became effective January 1, 2020.

Operations and processing of claims is provided by an independent contract administrator and is compensated by the Plan. Professional fees, other than bank service charges, are paid directly from the operation funds and assets of the sponsor. Disbursements from the plan are exclusively for the provision of benefits to plan participants.

**Benefits**

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, disability, and accidental death and dismemberment benefits. The premiums for the aforementioned benefits are paid to the insurance companies from the general assets of the Plan Sponsor. The Plan Administrator has the discretionary authority to determine coverage and to change the amount of required employee contributions at any time. The Plan provides upon completion of 60 calendar days of regular employment in a covered position. An eligible employee is a person who is classified by the employer as an employee who works full-time 30 or more hours per week.

**Stop Loss Coverage**

The Plan has entered into a stop-loss arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Notes to Financial Statements (continued)

**1. Description of Plan (continued)**

**Contributions**

Employees are required to contribute specified amounts, determined periodically by the Plan Administrator. The Plan Sponsor, SRC of Lexington, Inc. Health and Welfare Trust, contributes funds on an as needed basis to meet benefit obligations in excess of plan participant contributions. Employees are eligible to make pre-tax contributions to the Plan.

Any deficiency of the Plan's net assets is funded by the Company on a pay-as-you-go basis.

**Insured Benefits**

The Plan fully insures the life insurance benefits, disability, and accidental death and dismemberment benefits. Premiums for these insured benefits are paid to the insurance company from the general assets of the Company.

**Self-Insured Benefits**

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust, or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

**2. Summary of Significant Account Policies**

**Basis of Accounting**

The accounts of the Plan are maintained and the accompanying financial statements have been prepared on the cash basis, which is in accordance with a comprehensive basis of accounting other than generally accepted accounting principles. Under this basis of accounting, revenues and the related assets are recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred. Any balance in the bank account is utilized to offset the subsequent contribution from the Plan Sponsor.

**2. Summary of Significant Account Policies (continued)**

**Payment of Benefits**

Premiums paid by either the Plan Sponsor or the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor.

**Stop Loss**

Premiums for stop-loss insurance are recorded are included in premium payments of the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$525,943 and \$31,114 were received directly by the Plan Sponsor for the years ended December 2024 and 2023, respectively.

**Refunds**

Pharmacy rebates for the years ended December 31, 2024 and 2023 in the amounts of \$255,592 and \$183,904, respectively, were remitted directly to the Plan Sponsor. These rebates are not reflected in the Plan's financial statements.

**Use of Estimates**

Preparation of the financial statements using the cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts in the cash basis financial statements at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those reported.

**3. Plan Termination**

The Plan Administrator has the right to terminate the Plan, reduce or cease contributions, or to amend the Plan at any time. Upon termination of the plan, benefits to participants will be limited to those claims incurred to the date of termination. Funding for such liabilities will remain in accordance with the funding requirements described in Note 1. Any remaining Plan assets that are not needed for claims incurred prior to the termination date will be applied toward the cost of establishing and/or maintaining other employee benefit programs sponsored by SRC of Lexington, Inc. Health and Welfare Trust.

**5. Tax Status**

The Trust established under the Plan to hold the Plan's assets qualifies as an exempt organization under Section 501(c)(9) of the Internal Revenue Code (IRC). The Internal Revenue Service has made a favorable determination in a letter dated October 27, 2021 that the Plan meets the requirements of IRC Section 501(c)(9) and is, therefore, exempt from federal income taxes under IRC Section 501(9).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosures in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Related Party Transactions**

In addition to administrative costs paid by the Plan Sponsor, an excess reimbursement policy exists with Symetra Life Insurance Company, whereby the Plan Sponsor is reimbursed for claims that exceed the applicable individual and aggregate limit.
