To the Administrative Committee of

Opinion

We have audited the accompanying financial statements of CPC Commodities Group Medical Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (modified cash basis) of CPC Commodities Group Medical Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) for the year ended December 31, 2024 and 2023, in accordance with the modified cash basis accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the CPC Commodities Group Medical Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

General

The CPC Commodities Group Medical Plan (The Plan) was established to provide certain medical expense benefits, as described more fully in the Summary Plan Description, to all eligible employees.

The plan became effective January 1, 2022.

Operations and processing of claims is provided by an independent contract administrator and is compensated by the Plan. Professional fees, such as accounting and legal fees, are paid directly from the operation funds and assets of the sponsor. Disbursements from the plan are exclusively for the provision of benefits to plan participants.

Benefits

The Plan provides health benefits (medical, and prescription drugs). The Plan Administrator has the discretionary authority to determine coverage and to change the amount of required employee contributions at any time. The Plan provides upon completion of 60 calendar days of regular employment in a covered position. An eligible employee is a person who is classified by the employer as an employee who works full-time 30 or more hours per week.

Stop Loss Coverage

The Plan has entered into a stop-loss arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

CPC Commodities Group Medical Plan

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Contributions

Employees are required to contribute specified amounts, determined periodically by the Plan Administrator. The Plan Sponsor, CPC Commodities, contributes funds on an as needed basis to meet benefit obligations in excess of plan participant contributions. Employees are eligible to make pre-tax contributions to the Plan.

Any deficiency of the Plan's net assets is funded by the Plan Sponsor on a pay-as-you-go basis.

Self-Insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-part claims processor. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

2. Summary of Significant Account Policies

Basis of Accounting

The accounts of the Plan are maintained and the accompanying financial statements have been prepared on the modified cash basis, which is in accordance with a comprehensive basis of accounting other than generally accepted accounting principles. Under this basis of accounting, revenues and the related assets are recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred. Any balance in the bank account is utilized to offset the subsequent contribution from the Plan Sponsor.

Notes to Financial Statements (continued)

2. Summary of Significant Account Policies (continued)

Payment of Benefits

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor.

Stop Loss

Premiums for stop-loss insurance are recorded are included in premium payments of the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$379,069 and \$470,828 were received directly by the Plan for the year ended December 2024 and 2023.

Use of Estimates

Preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those reported.

Subsequent Events

Management has evaluated subsequent events for the Plan through October 5, 2025, the date the financial statements were available to be issued.

Reclassification

Certain prior year amounts have been classified to conform to the 2024 financial statement presentation. The reclassifications did not have any effect on the prior period statement of net assets available for benefits or the changes therein.

Notes to Financial Statements (continued)

3. Plan Termination

The Plan Administrator has the right to terminate the Plan, reduce or cease contributions, or to amend the Plan at any time. Upon termination of the plan, benefits to participants will be limited to those claims incurred to the date of termination. Funding for such liabilities will remain in accordance with the funding requirements described in Note 1. Any remaining Plan assets that are not needed for claims incurred prior to the termination date will be applied toward the cost of establishing and/or maintaining other employee benefit programs sponsored by CPC Commodities Health and Welfare Plan.

4. Benefit Obligation

As noted in Note 2, the Plan's financial statements are prepared on the cash basis of accounting. Accordingly, no benefit obligations are recorded on the financial statements. Subsequent to year-end and through the date of the audit report, the plan sponsor had paid approximately \$112,961 and \$101,687 in claims related to the 2024 and 2023 plan years, respectively.

5. Tax Status

The Trust established under the Plan to hold the Plan's assets is not qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net unallocated investment income is subject to income taxes. The Plan Sponsor files fiduciary income tax returns with the Internal Revenue Service and the Kentucky Department of Revenue. For the plan year ended December 31, 2024 and 2023, the Plan Sponsor filed and paid the taxes on behalf of the Plan and Trust. As a result, no provision for income taxes has been included in the Plans' financial statements.
