INDEPENDENT AUDITORS' REPORT

To the Retirement Plan Committee of
Tazmanian Freight Forwarding 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tazmanian Freight Forwarding 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tazmanian Freight Forwarding 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tazmanian Freight Forwarding 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tazmanian Freight Forwarding 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

DECEMBER 31, 2024 AND 2023

A. DESCRIPTION OF THE PLAN

The following description of the Tazmanian Freight Forwarding 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, adopted April 1, 1995 and restated effective January 1, 2016, is a defined contribution plan with 401(k) provisions. The Plan covers substantially all employees of the Company who are twenty one years of age or older and who have completed at least three months of service and are not either 1) an employee who is included in a unit of employees covered by a collective bargaining agreement, if retirement benefits were the subject of good faith bargaining, and if the collective bargaining agreement does not provide for participation in the Plan or 2) an employee who is a non-resident alien who received no earned income which constitutes income from services performed within the United States. Employees were previously able to enter the Plan on the first day of the month, following the month in which eligibility was reached. Effective November 1, 2023, the Plan was amended to allow employees to immediately enter the Plan and begin contributing upon becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

A participant in the Plan may elect to defer (elective deferral contributions) and contribute to the Plan up to 100% of their compensation or up to an amount allowable by law. Contributions are also limited to an annual fixed dollar amount established by the Plan. The Plan allows elective deferral contributions to be made as Roth contributions, which are made in the same manner as pre-tax effective deferral contributions, except Roth contributions are made to the Plan on an after-tax basis. The Plan Sponsor will make safe harbor matching contributions in an amount equal to 100% of employee contributions that are not in excess of 4% of compensation, which are fully vested. The Plan Sponsor may make additional safe harbor matching contributions and profit-sharing contributions. Additional safe harbor matching contributions and profit-sharing contributions are subject to the matching vesting schedule described in the Vesting section. Participants who have completed at least 501 hours of service during the Plan year or are employed by the Company on the last day of the Plan year are eligible to receive any discretionary profit-sharing contributions. No additional safe harbor matching contributions or profit sharing contributions were made for the years ended December 31, 2024 and 2023.

Participant Accounts

The Plan Administrator maintains an individual account for each participant. A participant's account is credited with contributions and earnings from plan investments. Accounts are reduced for withdrawals and distributions. Participants self-direct their investments as to their allocation among the available investment fund options. Participants may change their investment options at any time. However, the elective deferral may only be changed effective on the first day of any calendar month. A participant may suspend their elections at any time.

A. DESCRIPTION OF THE PLAN (CONTINUED)

Distributions

Participants are entitled to receive a distribution from their account after employment has been terminated, including termination due to disability. If a participant continues working for the Company after Normal Retirement Age (65), the participant will continue to participate in the Plan and distributions will begin following the date the participant terminates employment. If a participant dies, the participant's beneficiary will become entitled to receive the participant's vested account balance.

Vesting

Participants are always 100% fully vested in their elective deferral contributions, rollover contributions and safe harbor matching contributions. A participant is vested in the non-safe harbor matching contributions and profit-sharing contributions, as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
After 2 years	20%
After 3 years	40%
After 4 years	60%
After 5 years	80%
After 6 years	100%

Participants become fully vested upon attainment of Normal Retirement Age while an employee, death while an employee, or becoming disabled while an employee.

Participant Loans

Participants may borrow from their fund accounts. Loans will only be made if the sum of a participant's new loan and the outstanding balance of all other loans do not exceed the lesser of (i) \$50,000 minus the difference between the highest outstanding balance of loans in the past twelve months and the outstanding balance of loans from the Plan on the date the loan is made, or (ii) one-half the present value of the participant's vested account balance. The maximum number of loans outstanding at any one time is two and the minimum loan amount is \$1,000. Loans must be repaid over a period not extending beyond five years from the date of the loan, unless such loan is used to acquire a dwelling unit that will be used as a principal residence for which the maximum loan term would be 20 years. Loans must be repaid in accordance with the repayment schedule or in full. Partial early loan payoffs are not permitted. Payments are made through payroll deduction from each regular paycheck. Loans become payable in full on a participant's termination of employment. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 10.5%, which is commensurate with local prevailing rates.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Forfeitures

In accordance with the Plan document, if employment with the Company terminates, the nonvested portion of a participant's account is forfeited. If employment is resumed after a distribution and forfeiture, the amounts forfeited (if any) will be restored to the account if the full amount of the previous distribution is repaid before the earlier of five (5) years after the first date of subsequent reemployment, or the date the participant incurs five (5) consecutive One-Year Breaks in Service following the date of the distribution. Forfeitures amounted to \$0 for both the years ended December 31, 2024 and 2023.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Participant loans are stated at cost, which approximates fair value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Subsequent events

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 14, 2025, the date the financial statements were available to be issued, and all relevant subsequent information is included within the applicable notes to the financial statements.

C. INVESTMENTS

The Plan's investments, including gains and losses on investments bought and sold, as well as held during the year, appreciated in value by \$1,728,029 and \$1,534,005 during the years ended December 31, 2024 and 2023, respectively.

D. FAIR VALUE OF FINANCIAL ASSETS

The Plan uses fair value measurements to record fair value adjustments to certain assets and liabilities and to determine fair value disclosures. In accordance with ASC 820-10, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy:

Level 1 – Financial assets and liabilities whose values are based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access. These include investments that are recorded at fair value on a recurring basis and fair value measurement is based upon quoted prices, if available. Securities valued using Level 1 inputs include those traded on an active exchange and other exchange trade securities.

Money Market Funds: Valued based on cost plus accrued interest, which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 – Financial assets and liabilities whose values are based on quoted prices in markets that are not active or model inputs that are observable either directly or indirectly for subsequently the full term of the asset or liability.

Level 3 – Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

E. PLAN TERMINATION

Although the Company intends to maintain the Plan indefinitely, the Company may amend or terminate the Plan at any time in its sole discretion. If any of these actions are taken, participants will be notified. However, no such action may permit any part of Plan assets to be used for any purpose other than the exclusive benefit of participants and beneficiaries or cause any reduction in the vested account balances as of the date of the amendment or termination. If the Plan is terminated, all amounts credited to a participant's account will become 100% vested.

F. TAX STATUS

The Plan Administrator and the Plan's Tax Counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

G. INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN ASSETS

Information as to the Plan assets as of December 31, 2024 and 2023 has been certified to the Plan Administrator by John Hancock Financial, the custodian of the plan assets.

As directed by the Plan Administrator, no auditing procedures have been performed on this information except to compare such information to the information included in the accompanying financial statements and supplemental schedule.

H. EMPLOYER ABSORBED COSTS

The Company absorbs a portion of the Plan's administrative expenses.

I. RELATED PARTY TRANSACTIONS

John Hancock Financial is the custodian of the Plan assets. CBIZ, Inc. acts as the Plan Administrator and is the investment advisor for the Plan. Administration fees and investment management fees paid by the Plan amounted to \$78,787 and \$58,288 for the years ended December 31, 2024 and 2023, respectively.

J. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

K. PLAN RESTATEMENT

The Company adopted a restatement of the Plan effective as of January 1, 2016.

L. PLAN AMENDMENTS

Effective November 1, 2023, the Plan was amended to allow employees to immediately enter the Plan and begin contributing upon becoming eligible. Employees were previously only able to enter the Plan on the first day of the month, following the month in which eligibility was reached.

On April 4, 2025, the Plan was amended retroactive to November 4, 2024 under the IRS' Employee Plans Compliance Resolution System to correct an insignificant operational error.
