Opinion

We have audited the accompanying financial statements of Pipe Trades District Council No. 36 Health and Welfare Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The Pipe Trades District Council No. 36 Health and Welfare Trust Fund (the "Plan") was established as a multiemployer welfare benefit plan in 1954 for the purpose of providing health care benefits to eligible participants covered by collective bargaining agreements between Pipe Trades District Council No. 36, and employer associations and individual employers signatory to the agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation was determined by an actuary from NWPS and is the amount that results from applying actuarial assumptions to historical benefit cost data to estimate future annual incurred benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used were as follows for 2024 and 2023: (a) Discount Rate: 5.50% (5.00%) per annum, (b) Mortality: Pri-2012 Blue Collar adjusted tables projected fully generational using Scale MP-2020, (c) Retirement Age: Age 55 or first eligible, if later and (d) Health Care Cost Increase or Trend Rate: based on models reviewed and recommended by the Society of Actuaries.

C. Postretirement Benefits (Continued)

The 2024 valuation reflects several assumption and methodology changes from those utilized in the 2023 valuation as follows:

- The assumption for medical inflation has been updated to this year's Getzen model.
- Assumed plan costs were calculated to reflect recent experience.
- Self pay rates were updated to current rates.
- The discount rate was updated from 5.00% to 5.50%.

The health care cost trend rate and retiree contribution trend rate have a significant effect on the postretirement benefit obligation. A 1% increase in the health care cost trend rate would increase the net postretirement benefit obligation as of December 31, 2024 and 2023 by \$44,439,852 and \$40,567,910, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

D. Employer and Participant Contributions

Employer contributions are contributions made for hours worked during the year at hourly contribution rates agreed to in the collective bargaining agreements. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts. Self-pay contributions are contributions made by participants for coverage during the year.

E. Employer Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

F. Claims Examination Program

A program of examining benefit payments, on a sample basis, is being conducted by the Plan's independent auditors under a separate, continuing claims examination engagement.

G. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are based on quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

G. Investment Valuation and Income Recognition (Continued)

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Deposit Accounts and Certificates of Deposit – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Mutual Funds – Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust – Valued at the net asset value of units of the funds. The net asset value is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Unrealized appreciation or depreciation in the fair value of investments are computed using investments' carry value of financial statement purposes and are reported as net appreciation of investments. Investment income realized gains and losses on sale of investments, and other investment income and expenses are reported on the accrual basis. Form 5500 requires realized gains and losses to be reported as the difference between proceeds from the sale or redemption of investments and the current (market) value of the investment at the beginning of the year, for those investments on hand at the beginning of the year, or the purchase price of investments acquired during the year. The different methods of computing realized gain or loss and the residual unrealized appreciation in fair value of investments results in differences in reporting on the financial statements and Form 5500. The Plan's investments have been invested in accordance with its investment policies and guidelines.

H. Tax-Exempt Status

No provision for federal income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9).

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

I. Risks and Uncertainties

Benefit obligations are reported based on certain assumptions pertaining to health care inflation rates, participant demographics and other assumptions which are subject to change. Due to the uncertainty of the assumption process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the financial statements.

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Due to the level of risk associated with investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risk in the near term would be material to amounts reported in the financial statements.

NOTE 3 - RELATED PARTY TRANSACTIONS

The Plan paid certain expenses related to Plan operations and investment activity to various service providers for which these transactions are exempt party-in-interest transactions under ERISA.

Certain administrative costs are reimbursed to the Pipe Trades District Council No. 36 Pension Trust (Pension Plan), who pays them in total on behalf of the various related Trusts. As of December 31, 2024 and 2023, the amount due to the Pension Plan for reconciliation issues was \$9,967 and \$7,041, respectively.

The Pension Plan holds the Lockbox account that receives contributions and liquidated damages on behalf of the related entities. These contributions are allocated based on each entity's contribution rate and should be transferred monthly. As of December 31, 2024 and 2023, the amount due from the Pension Plan for contributions received from employers was \$1,856,531 and \$1,927,883, respectively. In addition, the Pension Plan is authorized by some retired participants to withhold their self-pay contribution to the Plan from their monthly pension check. These withheld amounts are transferred monthly. As of December 31, 2024 and 2023, the amount due from the Pension Plan was \$167,422 and \$157,865, respectively, for self-payments withheld from pension payments and not yet transferred to the Plan.

Reimbursements are made to District Council No. 36 Local Unions for expenses associated with certain membership administration of the Plan. For the years ended December 31, 2024 and 2023, reimbursements totaled \$52,826.

Any remaining plan assets will be distributed in such manner as will, in the opinion of the Board of Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

NOTE 6 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 27, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that require recognition or additional disclosures in these financial statements.
