We have performed audits of the financial statements of Pathfinder, Inc. 401(k) Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of Pathfinder, Inc. 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions, which is available from the plan administrator.

General

The Plan is a defined contribution plan sponsored by Pathfinder, Inc. (Company) for the benefit of its eligible employees. Eligible employees include all employees of the Company, excluding collectively bargained employees, nonresident aliens, leased employees, highly compensated employees, and certain employees covered by National Industries for the Severely Handicapped contracts. All eligible employees, as defined above, are eligible to participate in 401(k) employee pretax and Roth deferral contributions on the first day of the month after 30 days of employment. All eligible employees with at least six months of service are eligible to participate in employer nonelective contributions; however, employees can only begin participation in employer contributions on the first day of the plan year and the first day of the seventh month of the plan year. Plan participants are also eligible to receive an allocation of any discretionary employer profit-sharing contribution by completing at least one hour of service during the plan year. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company is the trustee and custodian of the Plan. Fidelity Investments Institutional serves as plan record-keeper. WealthPath Investment Advisors (WealthPath), which is a part of Pensionmark Financial Group, LLC, serves as the investment advisor for the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover and employee Roth contributions are also permitted. Additional amounts may be contributed at the discretion of the Company's board of directors. The Company did not make any additional discretionary contributions for the years ended December 31, 2024 and 2023. The Company made nonelective employer contributions in the amount of 4% of plan compensation to eligible employees for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of service. A participant is fully vested after three years of service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of their account or a joint and survivor annuity. Participants are entitled to receive distributions of all or any portion of

employee deferrals upon the attainment of age 59.5. Hardship withdrawals are also allowed for any participant demonstrating an immediate financial need that meets plan guidelines.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,443 and \$1,181, respectively. Forfeitures are available to pay administrative expenses, are allocated to participants based on their eligible earnings, or are used to reduce employer contributions. In 2024 and 2023, no forfeitures were used to pay plan expenses. In 2024 and 2023, \$14,470 and \$14,615, respectively, was used to reduce nonelective employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Quoted market prices, if available, are used to value investments. Mutual funds and the stable value fund are valued at the net asset value of shares held by the Plan at year-end. The Plan's interest in collective trusts is valued using the net asset value per share as a practical expedient based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has

certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in administrative expenses on the accompanying statements of changes in net assets available for benefits. The plan sponsor pays directly any other fees related to the Plan's operations. Certain plan investments are collective trusts managed by WealthPath, operating under PensionMark Financial Group, LLC. WealthPath is the investment adviser for the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$34,440 and \$32,547 of record-keeping fees to Fidelity Investment Institutional during 2024 and 2023, respectively. In addition, the Plan also paid \$27,042 and \$25,847 of investment advisory fees to WealthPath during 2024 and 2023, respectively. The plan sponsor provides certain administrative services at no cost to the Plan.

Note 5. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows and classified within Level 2 of the valuation hierarchy. Level 2 securities include a stable

Note 6. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a nonstandardized pre-approved adoption agreement in connection with a pre-approved retirement plan and trust/custodial document sponsored by Fidelity Management & Research Company (FMR, LLC). This pre-approved plan document has been filed with the appropriate agency. The trust/custodial document obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
