

9. **Death Benefits:** Upon death prior to retirement, actuarial present value of Accrued Benefit is payable (in the form of a Pre-Retirement Survivor Annuity unless elected otherwise with Spousal Consent).
10. **Termination of Employment:** Upon termination of employment prior to retirement, death, or disability, the vested Accrued Benefit is payable.
11. **Vesting:** Vested in the accrued benefit based on years of service. 0% for less than 1 year, 20% after two years, increasing by 20% per year to 100% after 6 years. A year of vesting service is credited for each Plan Year in which an employee completes at least 1,000 hours of service. Years of Service prior to the plan effective date are excluded.
