**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Priefert Manufacturing Co., Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering all employees of Priefert Mfg. Co., Inc. and related entities; Priefert Complex Designs, LLC; PMCI Management I, LLC; BENT Properties, LLC; and DFW Steel, LLC (collectively, "the Company"). Employees are eligible to participate the first day of the calendar month coincident with or next following 90 days of service. Participation in the Plan is voluntary. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ERISA. Priefert Mfg. Co., Inc. is the Plan Sponsor.

**PLAN ADMINISTRATION**

The Board of Directors of the Company appoints the Plan Administrator and Plan Trustees. The Plan Administrator is an employee of the Plan Sponsor. The Plan's third-party administrator, Resource Benefits Administrators, performs the Plan's administrative duties such as preparation of the Form 5500, participant recordkeeping, compliance testing and enrollment.

**CONTRIBUTIONS**

Participants may elect to contribute pre-tax and Roth post-tax compensation, as defined in the Plan, not to exceed the limit of the Internal Revenue Code ("IRC"). Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company's discretionary matching contribution currently provides for a contribution of 50% of the first 6% of base compensation that a participant contributes to the Plan. The Company may provide discretionary non-elective contributions in an amount, to be determined by the Board of Directors, equal to a percentage of participants' eligible compensation. The Company did not make a non-elective contribution for the Plan year ended December 31, 2024.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with participant contributions, Company match contributions, and Plan earnings. Participant balances and future contributions are held at Capital Bank and Trust. Participants can elect to invest balances and contributions in a pre-selected panel of investment options. If an employee opts not to direct investments, employee balance and contributions are invested in specific Target Date funds based on employee age. Participant funds are valued daily. Employer match contribution funds are held at Charles Schwab. Semi-annually, each participant's employer match account is credited with (a) the employers' contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocation is based on a formula as defined in the Plan. Participant employer accounts are valued semi-annually on June 30 and December 31. Plan assets are invested for the benefit of the Plan participants with prudent care and in accordance with the authority granted by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are fully vested in the Company's contribution portion of their accounts upon the completion of five years of qualifying service or upon attainment of age sixty. If an employee terminates because of death or disability, they also become fully vested.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments, if the vested benefit exceeds \$5,000. Vested benefits not exceeding \$5,000 must be distributed as soon as practicable following death, disability, or retirement. For termination of service due to other reasons, a participant may receive the employee portion (salary deferral or 401(k) portion) of his or her account as a lump-sum distribution. Hardship distributions are permitted from the Plan in accordance with updated Internal Revenue Service ("IRS") guidelines.

Payment to participants may start immediately for elective deferral balances and rollover contribution amounts. Payment for matching, discretionary non-elective, and qualified non-elective contribution accounts are performed semi-annually due to the valuation of these accounts occurring on June 30 and December 31 every year. Distributions must begin no later than April 1 following the calendar year in which the participant attains the age of 72 for 5% owners and 72 or retirement for less than 5% owners.

**FORFEITED ACCOUNTS**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,646 and \$0, respectively. These accounts may be used to reduce employer contributions, restore forfeiture balances, or pay Plan expenses. Also, in 2024, employer contributions were reduced by \$80,263 from forfeited nonvested accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("GAAP").

**USE OF ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the Plan Trustee. See Note 3 for discussion of fair value measurements.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

**INVESTMENT VALUATION AND INCOME RECOGNITION – CONTINUED**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

The Plan's investments, stated at fair value, consist primarily of shares in registered investment companies, equity securities, corporate bonds, and undeveloped land.

**CONTRIBUTIONS**

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**OPERATING EXPENSES**

The Company, at its sole discretion, may pay the administrative expenses (i.e., trustee fees, fund fees, loan fees, recordkeeping fees and other similar expenses) of the Plan. If such expenses are not paid by the Plan Sponsor, they are paid out of plan assets. Investment related expenses are included in net investment appreciation (depreciation) from investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest bearing cash and money market funds:* Valued at the per unit price as quoted by the financial institution.

*Common stock:* The fair value of common stock is the value at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds and exchange-traded funds:* The fair value of mutual funds and exchange-traded funds ("ETFs") are based on quoted net asset values of the shares as reported by the fund. The mutual funds and ETFs held by the Plan are open-end and registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds and ETFs held by the Plan are deemed to be actively traded.

*Real estate:* The real estate is valued by third party appraisals and/or third-party sales on value. The value is determined on an "as is" market value based on comparable sales as if unaffected by environmental issues. The valuation process involves the selection of an appraiser. The appraiser prepares a report of estimated fair value. The report is reviewed and approved by a Plan trustee.

Accordingly, Capital Bank and Trust, the Trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

These amounts represent the participant contributions and accumulated earnings managed by Capital Bank and Trust. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to related information included in the financial statements and supplemental schedule.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Capital Bank and Trust Company and provided by American Funds. Capital Bank and Trust Company is a Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for administrative services amounted to \$78,971 for the year ended December 31, 2024. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments.

Other Plan investments are managed by Baker Financial Services Inc. and provided by Charles Schwab. Baker Financial Services, Inc. is the investment manager as defined by the Plan; therefore, transactions with Baker Financial Services, Inc. qualify as party-in-interest transactions. Fees paid to Baker Financial Services, Inc. by the Plan for investment management services amounted to \$11,411 for the year ended December 31, 2024.

The Plan holds shares of common stock of Guaranty Bancshares, Inc. The Plan also has a checking account with Guaranty Bank & Trust, a subsidiary of Guaranty Bancshares, Inc., which is used primarily for distributions of employer funds to participants. A Trustee of the Plan is also a bank director of Guaranty Bank & Trust. Any transactions between the Plan and Guaranty Bank & Trust, Inc. are deemed to be with a party-in-interest.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

**NOTE 7 - INCOME TAX STATUS**

The IRS has determined and informed the Company by a letter dated September 30, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been restated since receiving this determination letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

**NOTE 7 - INCOME TAX STATUS - CONTINUED**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.
