INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
JB Donuts & Affiliates 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the JB Donuts & Affiliates 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Plan management is responsible for the accompanying financial statement of the Plan, which comprises the Statement of Net Assets Available for Plan Benefits as of December 31, 2023, and the related notes to the financial statement in accordance with accounting principles generally accepted in the United States of America. We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statement, nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by Plan management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on the 2023 financial statement.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the JB Donuts & Affiliates 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution 401(k) plan, covering substantially all eligible employees of JB Donuts & Affiliates (the Employer and Plan Administrator), as defined in the Plan document, excluding union employees, nonresident aliens, and residents of Puerto Rico. The Plan was established by the Employer on January 1, 2022.

Participation in the Plan is voluntary. Employees are eligible to enter the Plan once they have attained the age of 19 and completed four months of service. Entry dates are on the first day of the month coinciding with or following the satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Reliance Trust Company (Reliance) is the trustee for the Plan and holds and manages Plan investments, as well as provides recordkeeping services, at the direction of the Plan Administrator.

Contributions

Participants may elect to contribute on a pre-tax or post-tax basis any percentage of their annual compensation to the Plan, subject to certain limitations as allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (Rollovers).

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled to contribute 3% of pre-tax compensation to the Plan unless they affirmatively elect otherwise. The deferral will be invested in a designated balanced fund until changed by the participant.

The Employer may make discretionary matching contributions. There were no matching contributions made to the Plan during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) discretionary Employer matching contributions, (b) Plan earnings (losses), and (c) administrative expenses. Plan earnings (losses) and administrative expenses are allocated to participant accounts based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their elective deferral contributions, rollovers, transfers from other plans, discretionary Employer matching contributions and earnings thereon.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding loan balance in the past twelve months, or 50% of their vested account balance.

Loans are secured by the vested balance in the participant's account and bear interest equal to the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions and must be completed within five years. Participants may only have two loans outstanding at any time.

Payment of Benefits

Participants may elect to withdraw all or a portion of their Rollover account at any time. Upon retirement from service, total and permanent disability, termination of employment or death, participants will receive a lump-sum distribution in accordance with the provisions of the Plan. Participants who have reached age 59½ may elect to withdraw all or a portion of their vested account balance while still employed by the Employer. Terminated participants with vested account balances equal to or less than \$7,000 may be involuntarily removed from the Plan with a lump-sum distribution. In addition, participants may request a financial hardship withdrawal from their employee deferral accounts, subject to limitations imposed by the IRC.

Effective January 1, 2024, the Plan adopted certain provisions of the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, including an increase in the automatic cash-out threshold from \$5,000 to \$7,000, and permitting self-certification of financial hardship withdrawals. Additional SECURE 2.0 provisions may also apply based on plan design and future regulatory guidance.

Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants. Any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan invests in the Invesco Stable Asset Fund – ADPZ Class, a bank collective trust fund. The Plan's interest in the bank collective trust fund is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the bank collective trust at year-end. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Interest income on participant notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when incurred. A receivable is considered past due if payment has not been received within the stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

Contributions

Participant contributions are recorded weekly when the Employer remits the contributions for investment into the Plan. Employer discretionary contributions are recorded at the end of each year, if applicable.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Excess Contributions Refundable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Services (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to year end.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid by the Employer, unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Plan Benefits.

The Plan invested in three and four mutual funds that accounted for approximately 69% and 78% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Fund: The Plan invests in the Invesco Stable Asset Fund – ADPZ Class of Invesco Trust Company, a bank collective trust fund that invests primarily in U.S. treasury securities, corporate bonds, mortgage-backed securities and other asset-backed securities. The fund is valued at the NAV of units of a collective trust. The NAV, as provided by Invesco Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Unit values are determined daily by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan; however, there is up to a 12-month redemption notice period for this investment at the Plan level.

As of December 31, 2024 and 2022, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

4. Income Tax Status

The Plan is an adoption of a non-standardized pre-approved profit-sharing plan. The Plan obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Summary of Financial Data Certified by the Trustee

The following is a summary of financial information and data certified by the trustee, Reliance:

Investment information provided in the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

6. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items, as well as for the inclusion of any contribution receivables and excess contributions refundable in the accompanying financial statements not reported on the Form 5500.

7. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Reliance. ADP Retirement Services is the third-party administrator of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments of \$4,860 to ADP Retirement Services for administrative services. For the year ended December 31, 2024, the Plan did not make any direct payments to Reliance for administrative fees or investment management services.

8. Subsequent Events

Effective January 1, 2025, the Employer changed the Plan’s trustee from Reliance Trust Company to ADP Retirement Trust Services, LLC.

Effective January 1, 2025, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

Management has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.
