**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Synergy Home Care of Montgomery County 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Synergy Home Care of Montgomery County 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Notes 3 and 4 to the financial statements, is complete and accurate.

**Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Synergy Home Care of Montgomery County 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, with a profit sharing feature, and an automatic salary deferral feature set at 1%, covering all full-time employees, except for certain nonresident aliens and residents of Puerto Rico, of Just One Step LLC Dba Synergy Home Care of Rockville, Bethesda, Potomac (the Company) who attained the age of 21 and have completed 12 consecutive months of employment and obtained 1,000 hours of service, subject to monthly entrance date requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute 90% of defined compensation and 90% of bonuses, subject to IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, and certain IRAs. Catch-up contributions are permitted for eligible participants age 50 or older as of the end of the calendar year.

The Company makes fixed matching contribution equal to 50% of salary deferrals not to exceed 4%. There were fixed matching contributions for plan years ended December 31, 2024 and 2023 of \$17,653 and 23,091, respectively.

The Company may also make discretionary profit sharing contributions on behalf of the participants. Participants are eligible for profit sharing when they are employed on the last day of the Plan Year. The maximum amount that can be allocated to a participant is 5.7% of compensation plus "excess compensation". There were no profit sharing contributions for plan years ended December 31, 2024 and 2023.

Vesting

Participants are fully vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's fixed matching contribution and profit sharing contribution portion of their accounts is based on years of service. Participants are 100% vested after five years of credited service for fixed matching and profit sharing contributions, as defined in the Plan Document. A participant will always, however, become fully vested on or after the date they reach normal retirement age, as defined.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the Company's discretionary matching contributions and plan earnings. Participant's accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances or equal dollar amount based on the number of participants in the Plan, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a commercially reasonable rate of interest as determined by the plan administrator based on interest rates charged for similar types of loans by other lenders. Loans must be repaid within five (5) years unless the proceeds are used to acquire a principal residence, in which the plan administrator may permit a longer repayment term. A participant may only have one (1) loan outstanding at any time. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may receive benefit payments in the form of a lump-sum, equal to the vested value of his or her account, or in installments over a period of not more than the participant's assumed life expectancy. Active participants who become totally disabled or die will become fully vested on that date, and a benefit equal to the participant's vested account balance will be paid to the participant or beneficiary. Any participant who terminates from the plan with a vested balance less than \$7,000 will receive a distribution of their vested balance automatically within a reasonable time after employment is terminated.

Participants are also permitted to make hardship withdrawals if certain criteria, as defined in the Plan Document, are met.

Payment of Benefits (Continued)

Benefits are recorded when paid. As of December 31, 2024, there were no pending distribution requests.

Forfeitures

The non-vested portion of participant account balances are forfeited during the Plan year in which the participant is no longer an employee and has received their vested benefit. Forfeitures may be used to pay Plan expenses or to reduce the amounts otherwise to be contributed to the Plan.

During the year ended December 31, 2024, \$6,591, of non-vested account balances were forfeited. For the year ended December 31, 2024, there were \$6,594 worth of forfeiture monies used towards employer contributions or to pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts available to offset future employer contributions or plan expenses totaled \$10 and \$10, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, no further contributions will be made to the Plan and all amounts credited to participant accounts will become 100% vested.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual amounts could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

Financial assets and liabilities valued using Level 1 inputs are based on unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. Level 2 inputs are based on quoted market prices for substantially similar assets in active markets. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Tax Status

The plan sponsor adopted a prototype document which obtained its latest opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the form of the plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). Although the plan has been amended since adoption of the prototype document receiving the opinion letter, the plan administrator believes that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, the plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan's information return filings are subject to audit by the Internal Revenue Service and the Department of Labor. The years before December 31, 2022 are no longer subject to audit.

Plan Administrative Expenses

Certain expenses specifically incurred by, or attributable to a particular participant, may be paid directly by this participant's account. Other expenses related to the administration of the Plan not specifically incurred by, or attributable to a particular participant, may be paid from the Plan's assets. All other administrative expenses of the Plan are paid by the Company.

Related Party and Party in Interest Transactions

Reliance Trust Company is the trustee and recordkeeper of the Plan. ADP is a subservicer to the trustee and provides recordkeeping services to the Plan.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Subsequent Events

The Plan evaluated events through the date that the financial statements were available to be issued. The Plan is not aware of any significant events that occurred subsequent to the statement of net assets available for benefits date, but prior to October 9, 2025, that would have a material impact on the financial statements.
