INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Shapell Investment Properties, Inc. 401(k) Plan

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Shapell Investment Properties, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE A – DESCRIPTION OF THE PLAN**

The following description of the Shapell Investment Properties, Inc. (the “Company” or “Employer”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**1. General**

The Plan was established in 1987 and is a Flexible 401(k) profit sharing plan (defined contribution plan) for full time employees of the Company.

**2. Eligibility**

Eligibility in the Plan is available to any employee who has completed three months of service and has attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**3. Contributions**

Each year participants may contribute up to 99% of pre-tax annual compensation, on a tax-deferred basis or make Roth contributions as defined in the Plan, to the maximum extent allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Company will make a safe harbor matching contribution of 100% of the employee elective deferral not to exceed 4% of employee compensation. The Company may make, on its prerogative, an additional contribution not exceeding 6% of the employee’s compensation. No discretionary employer matching contributions were made to the 401(k) plan during the 2024 plan year.

**4. Investment Options**

Upon enrollment in the Plan, a participant may direct employee and employer contributions as desired, in any of a variety of options held by Reliance Trust Company, the trustee, as chosen by the Employer. Participants may change their investment options daily.

**5. Participant Accounts**

Each participant’s account is credited with the participant’s contribution, employee rollovers, Employer matching and nonelective contributions and profit-sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**6. Vesting**

Each participant is 100% vested in all contributions made to the Plan.

**7. Benefit Payments**

Upon termination of service, participants are entitled to receive their vested account balances. Upon normal retirement age, permanent disability, or in the event of death, a participant or a participant's beneficiary is entitled to the total value of the participant's account balance. The Plan permits in-service distributions once a participant reaches 59.5 years of age. The Plan also permits hardship distributions, if certain criteria are met.

**8. Plan Termination**

While the Employer has not expressed any intent to terminate the Plan, the Employer reserves the right to terminate the Plan at any time. Upon termination, all interests of participants become fully vested, and the assets are distributed among the participants of the Plan in accordance with the provisions of the Plan.

**9. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Generally, loans have a five-year term. The loans are secured by the balance in the participant's account and bear interest of 1% above the prime rate. Principal and interest are paid ratably through monthly payroll deductions. Participants are limited to two outstanding loans at a time.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**2. Plan Administration**

The Employer is the Plan Sponsor and Plan Administrator. The Plan Administrator is responsible for carrying out the duties imposed under ERISA.

**3. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**4. Payment of Benefits**

Benefits are recorded when paid.

**5. Administrative Expenses**

Administrative expenses incurred by the trustee in performance of its duties are paid from the assets of the Plan. Substantially all other out-of-pocket administrative expenses of the Plan are paid by the Employer. Investment-related expenses are included in net appreciation/(depreciation) of fair value of investments.

**6. Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**7. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan document.

**8. Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**NOTE C – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2            Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E. – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

In prior years, the Plan entered into investment contracts that meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The investment contracts are with National Western Insurance Company and MassMutual Insurance Company that maintain the contributions in a general account for the participants. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily withdraw or transfer all of their investments or receive them via annuity payments paid on an installment basis. All the insurance contracts date from prior plan years.

The average yield is based on a formula agreed upon with the issuer but may not be lower than a designated percentage rate. Such interest rates are reviewed regularly for resetting. The following represent the traditional investment contract held by the Plan:

**NOTE F – TAX STATUS**

The Employer adopted a non-standardized pre-approved profit sharing plan (“pre-approved plan”), which received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, which stated that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Administration errors, if any, that are insignificant or operational in nature, are handled by the Plan Administrator in accordance with applicable IRS correction policies. Therefore, the Plan Administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The trustee is a party-in-interest with respect to the Plan. All investments are held with the trustee. Notes receivable from participants of the Plan and the related interest income are also considered party-in-interest transactions.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

The Plan invests in funds which invest in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

**NOTE I – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
