### **1. Description of the Plan**

The following description of the Sagent Pharmaceuticals, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Sagent Pharmaceuticals (“Company”). The Company is a wholly owned subsidiary of Que Pharma, Inc. (see note 11). The Company is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and the Internal Revenue Code of 1986, as amended (the “Code”). The Plan Trustee and certain employees of the Company determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

#### **Trustee and Plan Administrator**

The Plan Trustee is Reliance Trust Company (effective January 1, 2025, the Plan Trustee is ADP Retirement Trust Services, LLC – see note 11). The Plan recordkeeper is ADP Retirement Plan Services. The Plan Administrator is the Company. The Board of Directors of the Company delegated authority, responsibility, and oversight of the Plan to management and certain employees of the Company.

#### **Contributions**

##### *Participant Contributions*

Participants may contribute to the Plan up to 85% of eligible annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, generally referred to as rollovers.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set to 4% of eligible compensation. Contributions are automatically invested in accordance with the default investment allocation established under the Plan until changed by the participant. The Plan also provides participants the option to elect to make Roth 401(k) deferrals.

##### *Company Matching Contributions*

The Company makes matching contributions equal to 50% of each participant’s elective deferrals, not to exceed 6% of eligible earnings. Participants share in the matching contribution regardless of the amount of service completed during the Plan Year.

##### *Company Non-elective Contributions*

The Company may make discretionary, non-elective contributions to the Plan. Non-elective contributions are allocated among eligible participants using the following fraction: participant eligible compensation divided by total eligible compensation of all eligible participants. For the years ended December 31, 2024 and 2023, there were no non-elective contributions made to the Plan.

### **Participant Accounts**

Each participant's account is credited with the participant's salary reduction contribution, and allocations of (a) the Company's matching contribution, (b) Plan earnings (losses), and (c) the Company's non-elective contribution, if any. Each participant's account is charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

A participant is always 100% vested in his or her account that represents the salary reduction contributions, catch-up contributions, any rollover amount accepted by the Plan on his or her behalf and actual earnings thereon. A participant vests in Company match and non-elective contributions after three years of service from the date of hire. In the event of death, disability, or retirement at designated ages, participants become fully vested.

### **Notes Receivable from Participants**

Participants may, subject to review and approval of the Plan Administrator, borrow from his or her account between a minimum of \$500 and a maximum equal to the lesser of \$50,000 or fifty percent of the vested account balance. The notes are secured by the balance in the participant's account and bear interest at 2% over the prime rate at the time the note is requested. Notes generally are required to be repaid in five years or less, except for loans used to purchase a primary residence, which must be repaid in no more than thirty years. Principal and interest are repaid ratably through payroll deductions or direct payment, as applicable.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited, non-vested accounts were \$135,636 and \$81,575, respectively. Plan forfeitures are used to reduce employer contributions or pay Plan expenses. For the years ended December 31, 2024 and 2023, \$16,606 and \$74,622, respectively were used to reduce employer contributions made to the Plan. For the years ended December 31, 2024 and 2023, \$27,500 and \$0, respectively were used to pay Plan expenses.

### **Payment of Benefits**

On termination of service due to death, disability or normal retirement, a participant or designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or equal or substantially equal annual installments payable over the participant's life expectancy. Hardship withdrawals are permitted subject to certain conditions and limitations, and in-service withdrawals are allowed after a participant has reached 59½ years of age. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution.

**2. Significant Accounting Policies**

**Basis of Accounting**

The Plan's financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Fair Value Measurement**

The Plan performs fair value measurements in accordance with the Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements and Disclosures. Refer to Note 3 for the fair value measurement disclosures associated with the Plan's investments.

**Investment Valuation and Income Recognition**

The Plan Administrator and Plan Trustee determine the Plan's valuation policies. The Plan's Registered Investment Companies' (mutual funds) investments are recorded in the financial statements at fair value based on published market values. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Reliance Trust Company Stable Value Fund is valued at contract value which represents contributions plus earnings, less participant withdrawals and administrative expenses. Purchases and sales are recorded on a trade-date basis. Interest income is on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments in the statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Administrative Expenses**

The expenses of maintaining the Plan are paid by the Company. Participants are charged for certain transactions, such as the processing of a loan or distribution. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**3. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There were no level 2 or level 3 inputs used to measure fair value for the years ended December 31, 2024 or 2023.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Level 1* - Quoted prices in active markets for identical assets or liabilities.

*Level 2* - Observable inputs other than quoted prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. The Plan had no Level 2 assets as of December 31, 2024 or 2023.

*Level 3*- Inputs that are generally unobservable and typically reflect the Plan's estimate of assumptions that market participants would use in pricing the asset or liability. The Plan had no Level 3 assets as of December 31, 2024 or 2023.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023, and additional information about the Plan's investments.

Registered Investment Companies (Mutual Funds)

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are actively traded and valued at quoted market prices in active markets and are classified.

Common Collective Trusts

The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less related liabilities.

The Reliance Trust Company Stable Value Fund 25053 is a collective investment trust. This Fund primarily invests in MetLife Group Annuity Contracts that are administered by MetLife and managed by MetLife and the Trustee. The NAV of the Reliance Trust Company Stable Value Fund 25053 is based on the contract value of the underlying investments and is the value at which participant transactions occur. Participant transactions (purchases and sales) may occur daily in this Fund. If the Plan were to initiate a substantial or full redemption of this Fund, the investment advisor reserves the right to temporarily delay withdrawal from the Fund in order to ensure that securities liquidations will be carried out in an orderly business manner. The Reliance Trust Company Stable Value Fund had no unfunded commitments.

The NAV of the Putnam Large Cap Value Fund and PGIM Total Return Bond Fund is based on the daily market value of the underlying assets as traded in an exchange or active market. Participant transactions (purchases and sales) may occur daily in these Funds. If the Plan were to initiate a substantial or full redemption of either Fund, the investment advisors reserve the right to temporarily delay withdrawal from the Fund in order to ensure that securities liquidations will be carried out in an orderly business manner. Putnam Large Cap Value Fund and PGIM Total Return Bond Funds have no unfunded commitments.

Certain events may limit the ability of the Reliance Trust Company Stable Value Fund, Putnam Large Cap Value Fund and PGIM Total Return Bond Fund to transact at their NAV or stated value. Such events include but are not limited to: complete or partial plan termination or merger with another plan; failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction under ERISA; transfer of assets from the Fund directly into a competing investment option; or any communication given to Plan participants designed to influence a participant not to invest in the Fund or to transfer assets out of the Fund.

Plan management believes that the occurrence of events that would cause these Common Collective Trust Funds to transact at less than NAV or stated value is not probable.
