Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed audit of the accompanying financial statements of The Anti-Recidivism Coalition 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Anti-Recidivism Coalition 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1: DESCRIPTION OF PLAN

The following description of the Anti-Recidivism Coalition 401(K) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) covering substantially all eligible employees of The Anti-Recidivism Coalition ("Company") except employees covered under a collective bargaining agreement, nonresident aliens, residents of Puerto Rico, temporary and seasonal employees. Employees who have completed three months of service and are age twenty-one or older are eligible to participate in the Plan. Eligible participants are automatically enrolled into the Plan. Eligible employees are entitled to receive employer matching contributions and non-elective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may elect to contribute up to 90% of their pre-tax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code. The Plan also provides for transfers from other eligible plans. The Company has elected to make a matching contribution equal to 100% of the first 2% of participant compensation, not to exceed \$1,500 per year. The Company may elect to contribute, on a discretionary basis, additional matching and/or discretionary profit sharing contributions which would be allocated to all eligible employees. No discretionary contributions were made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant is credited with the participant's contributions and allocations of (a) the Company's contribution, and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants contributions, rollover and Employer safe harbor contributions, plus actual earnings thereon are immediately vested. Vesting in the Company's non-elective and matching contributions of their accounts is based upon years of continuous service. Participants vest 50% per year of service starting after the completion of one year of service, and are fully vested after the completion of two years of continual service. Company contributions are fully vested upon death, disability or the participant reaching normal retirement age.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments not to exceed the participant's (and beneficiary's, if applicable) life expectancy. If a participant's vested benefit in the Plan does not exceed \$5,000, then their distribution will be in a lump-sum payment. A participant may make a hardship withdrawal from the participant's account subject to certain ERISA provisions.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance of the participant's account and bear interest at rate of 8.25% - 10.50%, which is commensurate with local prevailing rates for similar type loans as determined by the Plan administrator. Loans must be repaid within five years of the date of issuance, unless the loan proceeds are used for the purchase of a participant's principal residence, then the terms may be modified at the determination of the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Forfeited Accounts

Forfeited nonvested Company contributions may be either be used to pay administrative expenses of the Plan or reduce future Company contributions. For Plan year ended December 31, 2024, \$13,542 of forfeitures were utilized by the Plan to reduce Company contributions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the term of the Plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Company pays all costs for administrating the Plan including investment advisory, audit and other fees, with the exception of loan processing and benefit payment fees which are specifically allocated and deducted from the participants' accounts.

NOTE 3: CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in investments, interest and dividend income for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the Custodian of the Plan.

NOTE 4: PARTY IN INTEREST AND RELATED PARTY TRANSACTIONS

Certain of the Plan's investments are funds managed by the Custodian and related entities. Therefore, these transactions qualify as party-in-interest transactions. The Company paid fees for investment management services directly.

NOTE 5: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Input to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6: INVESTMENTS AT CONTRACT VALUE

The Plan's investment in the Invesco Stable Asset Fund guarantees principal and a minimum interest rate. This investment meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Reliance Trust Company, the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

With the Plan's investment in Invesco Stable Asset Fund, which is a stable value, and considered as a lower-risk investment option that focused on principal preservation and liquidity. This investment aims to provide steady positive returns and a stable net asset value. Stable Value investments offered by ADP Retirement Services are fully benefit responsive, and it is reported at Book (Contract) Value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment at December 31, 2024 and 2023 were \$1,977 and \$1,504, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7: PLAN TERMINATION

The Company anticipates that the Plan will continue without interruption but reserves the right to discontinue the Plan at any time. In the event of discontinuance of the Plan, all participants will become 100% vested in their account balances and the net assets will be allocated among the participants and beneficiaries of the Plan.

NOTE 8: TAX STATUS

The Plan has adopted the prototype non-standardized profit sharing plan administered by ADP, Inc. who received a favorable determination letter from the Internal Revenue Service dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The prototype Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income examinations for years prior to 2022.
