## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
**Plan de Retiro San Lucas**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Plan de Retiro San Lucas**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **Plan de Retiro San Lucas's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the **Plan de Retiro San Lucas**, (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

**General** — The Plan is a defined contribution plan created on August 19, 2022 for substantially all employees who are not covered by other plan, of Saint Luke's Memorial Hospital, Inc, Servicios de Salud Episcopales, Inc y Servicios Generales Episcopales, Inc, (collectively “the Plan Sponsors”). According to the Deed of Trust, the adoption of the Plan was effective retrospectively to January 1, 2022. The Board of Directors of the Plan Sponsors has appointed the Pension Plan Committee to control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendments** — Effective January 1, 2024, Section 5.1 if the Plan was amended to increase the automatic enrollment employee’s elective deferrals from 1% to 2%. The rest of the Plan provisions remained unchanged.

**Contributions** — Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) discretionary matching contributions made by the Plan Sponsors; and (iii) participant rollovers from another plan. There will be no profit sharing and/or additional contributions made by the Plan Sponsor.

Participants may elect to contribute a percentage of their compensation, excluding bonuses and commissions, to the Plan each year, subject to the limitations, as defined in the plan document. Such contributions are excluded from the participant’s taxable income for Puerto Rico income tax purposes until received as a withdrawal or distribution from the Plan. The minimum elective deferral percentage is 1% of eligible compensation and their contributions invested in a designated balanced fund. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions subject to the limitations of Puerto Rico Internal Revenue Code of 2011 (the PRIRC) Section 1081.01(d)(7)(C).

The Plan Sponsors may make contributions at the discretion of the Plan Sponsor’s Board of Directors. These contributions are totally discretionary, including the discretion to forego a contribution for one or more Plan Years. During the year ended December 31, 2024 contribution to the Plan made by the Plan Sponsors amounted to \$220,453 of matching contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain PRIRC limitations.

**Participant Accounts** — Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related nonelective contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## 1. DESCRIPTION OF THE PLAN, Continued

**Investments** — Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers various registered investment companies and mutual funds.

**Vesting** — Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. Following is a table of vesting interest on Plan Sponsors' contribution portion based on years of continuous service:

**Notes Receivable from Participants** — Notes receivable from Participants are not permitted.

**Payment of Benefits** — On termination of service with the Plan Sponsors (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments if his or her vested interest exceed \$5,000.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of twelve (12) months following the date of the in-service withdrawal.

**Forfeited Accounts** — When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future employer contributions or plan administrative expenses for the plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,413 and \$54, respectively. During 2024, no employer contributions were reduced from forfeited nonvested accounts to pay plan expenses.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties** — The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, Continued

**Investment Valuation and Income Recognition** — The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses** — Administrative expenses of the Plan are paid by the Plan Sponsor as provided in the plan document. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits** — Benefit payments to participants are recorded upon distribution. FASB ASC 962-205-50-1(i) requires disclosure for amounts allocated to accounts of persons who have elected to withdraw from the plan but have not yet been paid. These amounts shall not be reported as a liability on the statement of net assets available for benefits. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$1,061 and \$33 at December 31, 2024 and 2023, respectively.

**Excess Contributions Payable** — The Plan is required to return contributions received during the Plan year in excess of the PRIRC limits.

**Date of Management's Review of Subsequent Events** — Subsequent events were evaluated through October 6, 2025, the date the financial statements were available to be issued. No events occurred after December 31, 2024, but before October 6, 2025, that require consideration as adjustments to or disclosure in the financial statements.

## 3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain unaudited information regarding the Plan as of December 31, 2024 and included in the Plan's financial statements and supplemental schedules, was prepared by Empower Trust Company LLC, custodian of the Plan's assets for the years ended December 31, 2024. The information was furnished to the trustee of the Plan and to the plan administrator. The plan administrator has obtained a certification from the trustee, that such information, disclosed below, is complete and accurate, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA:

- Investments, at fair value, including cash and cash equivalents included in the accompanying Statements of Net Assets Available for Benefits of \$1,495,894 and \$715,087 as of December 31, 2024 and 2023, respectively.
- Investments, at contract value, included in the accompanying Statements of Net Assets Available for Benefits of \$11,681 and \$3,716 as of December 31, 2024 and 2023, respectively,
- Net appreciation in fair value of investments (including interest and dividend income), as reported in the accompanying Statement of Changes in Net Assets Available for Benefits of \$124,577 for the year ended December 31, 2024.

### 3. INFORMATION CERTIFIED BY THE CUSTODIAN, Continued

- All investment balances and investment information disclosed in Notes 4, 5 and 6, excluding the classification of investments by level,
- All investments-related information, included in the accompanying Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year).

### 4. FAIR VALUE MEASUREMENTS

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1—observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2—observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3—inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The Plan's investments are comprised of mutual funds, which are valued at the published per share net asset value ("NAV") of shares held by the Plan and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at NAV.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following table details the Plan's investments at fair value by level, within the fair value hierarchy, as of December 31, 2024 and 2023. The Plan has no assets classified within Level 2 or Level 3 of the valuation hierarchy.

These items are classified in their entirety based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets and liabilities within the levels of the fair value hierarchy.

## **5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2022, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company (Empower). Empower maintains the contributions in a pooled account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$11,681 and \$3,716, respectively. The crediting interest rate is based on an agreed-upon formula with the issuer, which may never fall below zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## **6. INVESTMENTS**

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$86,584.

## **7. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan cash accounts and investments are shares of money market funds managed by Empower Trust Company, LLC, the custodian and recordkeeper, as defined by the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

## **8. NONEXEMPT PARTY-IN-INTEREST TRANSACTION**

### Excess Contribution Payable

During the years ended December 31, 2024 and 2023, the Plan Sponsors did not comply with the discrimination test. This test requires compliance with a determined percentage of contributions to the Plan as established in section 1081.01(a)(3)(B). The Plan had two alternatives to correct this noncompliance; (1) make an additional contribution to non-highly compensated participants or (2) reimburse to highly compensated participants their excess contributions, which would result in reporting this reimbursement as taxable income for the year in which the noncompliance takes place. The Plan Sponsors elected to reimburse to highly compensated participants their excess contributions during the year of noncompliance. The reimbursement amounted to \$20,090 for 2024 and \$26,447 for 2023. As of December 31, 2024, the excess contributions remain undistributed to participants.

## **9. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

## **10. INCOME TAX STATUS**

The Puerto Rico Treasury Department (PRTD) has determined and informed the Plan Sponsors by a letter dated December 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Puerto Rico Internal Revenue Code (PRIRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the PRIRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
