NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of Maspeth Town Hall, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution prototype plan, qualifying under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was adopted and became effective on January 1, 2022 and was established for the purpose of providing funds for retirement for eligible employees of Maspeth Town Hall, Inc. (“Plan Administrator” or “MTH”).

Plan Administration

MTH has overall responsibility for administering the Plan. The Plan Administrator determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Plan’s trustee is Reliance Trust Company (the “Trustee”). The Trustee is responsible for the management and control of the Plan’s assets. The Trustee has a sub-custody agreement with State Street Bank and Trust Company, in which the Plan holds security investments (see Note 6). The Plan’s administrative agent is ADP Retirement Services.

Eligibility

Employees who have attained the age of 18 are eligible to participate in making elective deferrals. Entry dates for employee contributions are the first day of the month after achieving eligibility.

Exclusions to Participate

The Plan excludes employees who are residents of Puerto Rico and nonresident aliens who have no earned income from sources within the United States.

Participant Contributions

A participant may make contributions to the Plan through payroll deductions of any whole percentage of 1%-90% of salary, as defined, Roth and pre-tax deferrals, not to exceed amounts as determined by the IRC. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate at 3% of eligible compensation. Under the auto-enrollment provision, contributions are automatically invested in a designated balanced fund until changed by the participant. The Plan also includes an ADP feature that allows participants to automatically increase their pre-tax contribution percentage by 1%, 2% or 3% each year on their chosen anniversary date.

Participant Contributions (continued)

Participants may also rollover funds from other qualified plans. Any participant, age 50 or over, may make an additional “catch-up” contribution, as determined by the Internal Revenue Service (“IRS”). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may suspend, increase, or decrease their level of contributions at any time during the year.

Vesting

A participant is fully vested in participant contributions, plus actual earnings, gains and losses thereon, at all times. In addition, MTH has the ability to make a discretionary contribution. The discretionary contribution and earnings thereon become vested according to the following schedule or upon death, disability, or at age 65 (“normal retirement”). As of December 31, 2024 and 2023, MTH has not made any discretionary contributions to the Plan. The vesting schedule for discretionary employer contributions is as follows:

Participant Accounts

Individual accounts are established for each participant. The Plan offers a variety of registered investment companies’ funds and a common/collective trust with varying investment objectives as investment options. Each participant’s account is credited with the participant’s pretax and after-tax (“Roth”) contributions and the proportionate share of dividends, interest, and investment fair value gains. The participant’s account is reduced by withdrawals, an administrative participant fee on a per distribution basis, with a \$65 maximum charge on each distribution, and fair value losses on investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Forfeited Accounts

Forfeitures occur when participants end their employment before they are fully vested in their benefits under the Plan. These forfeited amounts serve to offset MTH’s discretionary contributions. As of December 31, 2024 and 2023, the Plan had no forfeited balances available for use.

Payment of Benefits

The Plan offers various options for participants to access their funds based on certain triggering events, such as retirement, termination of employment, or reaching a specific age. The distribution methods available are designed to provide flexibility to participants, while ensuring the Plan remains in compliance with regulatory requirements.

The following summarizes the distribution options:

- **Termination Distributions**

Retirement, Death, Disability, or Termination of Employment: Upon any of these events, participants (or their beneficiaries in the case of death) may choose to receive their vested account balance either as a lump sum or in annual installments over a period they specify.

Automatic Lump Sum: For vested account balances of \$5,000 and below, the Plan may distribute these amounts as a lump sum without requiring explicit participant consent. Balances exceeding \$5,000 require participant (or beneficiary) consent for the chosen distribution method.

- **In-Service Distributions** – Participants who have attained the age of 59 1/2 are eligible to request distributions without terminating their employment.
- **Partial Withdrawals** – Participants may opt for withdrawals, subject to a minimum amount of \$500.
- **Rollovers** – Upon termination of employment, participants can choose to either receive a cash distribution or roll over their vested account balance to another qualified retirement plan.
- **Hardship Withdrawals** – Aligned with IRS regulations, the Plan provides for hardship distributions. Should participants face significant financial distress, they can access any portion of their vested account to alleviate the hardship.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The significant accounting policies of the Plan are as follows:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Expenses associated with the administration of the Plan are either paid by MTH or allocated to individual participants. Specific expenses that MTH directly covers are excluded from these financial statements. For the year ended December 31, 2024, the Plan recognized \$6,672, which is entirely derived from individual participant expenses associated with distributions.

NOTE 3 – TAX STATUS

The Plan adopted a Prototype Non-standardized Profit-Sharing Plan, which received a favorable opinion letter from the IRS on October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there have been no tax-related interest or penalties for the periods presented in these financial statements.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

No auditing procedures were performed by the independent public accountants, as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, with respect to information certified as complete and accurate by the Trustee, except for comparing such information with the related information included in the financial statements. Based on information provided and certified by the Trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of December 31, 2024 and 2023.

The following information is prepared from reports certified by the Trustee:

- Investments at fair value reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income from net appreciation in fair value of investments and interest and dividend income on investments reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments on the schedule of assets (held at end of year) as of December 31, 2024.

NOTE 5 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) established a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The levels of the fair value hierarchy are as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Observable inputs other than Level 1 prices, such as quoted prices for identical assets in inactive markets or for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are financial instruments which values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

NOTE 5 – FAIR VALUE MEASUREMENTS (continued)

The categorization within the fair value hierarchy is determined by the lowest level of input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation methodologies used for the Plan’s assets measured at fair value. There have been no changes in the methodologies used for the periods presented in these financial statements.

Registered Investment Companies: Shares of registered investment companies are valued at quoted market prices which represent the net asset value (“NAV”) of shares held by the Plan at year-end. Since NAV is a quoted price in a market that is active, the shares are classified within Level 1 of the fair value hierarchy.

Common/Collective Trust: The Plan holds a single common/collective trust, the Invesco Stable Asset Fund. It is valued based on the Plan’s pro rata share of the fund’s value, derived from the underlying market values of its holdings, placing it in Level 2 of the fair value hierarchy. This fund, which is focused on stable value investment contracts, allows for daily redemptions at its reported NAV. Should the Plan opt for a complete redemption, the issuer may require a 12-month notification to facilitate an orderly liquidation process.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

ADP Retirement Services provides comprehensive 401(k) services to the Plan, which include recordkeeping, administration, and asset custody. ADP Retirement Services is a subsidiary of Reliance Trust Company, the Trustee of the Plan. The Plan’s assets include securities managed by State Street, which has a sub-custody agreement with the Trustee.

Furthermore, MTH collaborates with ADP for payroll services. This process involves the automatic withdrawal of funds from MTH’s bank account for employee contributions, which are then deposited into the Plan’s trust account.

Transactions with these providers qualify as party-in-interest transactions.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – PLAN TERMINATION

MTH intends to continue the Plan indefinitely; however, MTH reserves the right to modify, amend, or terminate the Plan at any time by resolution of its board of directors. The termination of the Plan is subject to the provisions of ERISA. If termination takes place, the participant will have a 100% vested and nonforfeitable interest in all of the amounts in their account. These amounts may be distributed to the participant at that time or may be distributed in accordance with the benefit distribution rules. MTH will arrange for distributions upon Plan termination as soon as administratively feasible.

NOTE 9 – SUBSEQUENT EVENTS

Management of the Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. Based on this evaluation, Management has determined that no subsequent events require adjustment to the financial statements. However, as disclosed below, a change in the Plan’s Trustee occurred after December 31, 2024.

Change in Plan’s Trustee

MTH was notified that Reliance Trust Company will resign as the Plan’s Trustee, effective December 31, 2024. Upon the resignation of Reliance Trust Company on December 31, 2024, MTH consented to the appointment of ADP Retirement Trust Services, LLC as the Plan’s Trustee, effective January 1, 2025. Management has determined that, although this event does not materially impact the Plan’s financial position as of December 31, 2024, it is disclosed for transparency regarding significant post-year-end developments.
