### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Trivium Healthcare LLC 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Trivium Healthcare LLC 401K Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. **Responsibilities of Management for the Financial Statements**

NOTE 1 - GENERAL

The following description of Trivium Healthcare LLC 401K Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

In order to be eligible to participate in the Plan an employee must complete at least 3 months of service.

The participants could contribute between a minimum of 1% and a maximum of 90% of their compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may elect to defer after-tax Roth contributions in addition to pre-tax elective deferral contributions. Participants age 50 and older may defer catch-up contributions in excess of the deferral limit. Participants direct the investment of their contributions into various investment options offered by the Plan. The plan sponsor's matching contributions are discretionary. Currently, the plan sponsor is not contributing to the Plan. However, in order to be eligible for plan sponsor's matching participants must be employed by the plan sponsor on December 31 and have completed at least 1,000 hours of service. In years that it makes a contribution the participants vest under a modified vesting schedule as follows: 20% after two years, then 20% per year. Service is calculated using all years of service.

Each participant's account is credited with the participant's contribution and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures are utilized for the Plan's expenses and to offset plan sponsor's matching contributions. During 2024 and 2023, forfeitures were \$0 and \$0, respectively.

NOTE 1 - GENERAL (CONT'D)

On termination of service due to death, disability or retirement, a participant may receive the value of the vested interest in his or her account only as a lump-sum distribution.

Participants may borrow from their accounts up to a maximum amount of the lesser of: 50% of the participant's vested account, or \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The minimum loan amount is \$500. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5% to 10%, which interest rate is based on Prime rate plus 2%. The maximum amount of outstanding loans per participant is one and maximum term is 5 years, unless participant purchases primary residence, where maximum term is not more than 30 years. Principal and interest is paid ratably through payroll deductions. During 2024 and 2023, the defaulted loans were \$0 and \$0, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The Plan prepares its financial statements on the modified cash basis of accounting. Consequently, contributions are recognized when received and deductions are recognized when paid rather than when the obligations are incurred.

ESTIMATES

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated using Level 2 inputs and Level 3 inputs within the fair value hierarchy. The fair values that are stated using net asset value ("NAV") where fair value is readily determinable because it is available on a domestic stock exchange or is a mutual fund or similar investment with a published price. The level 1 inputs are quoted prices (unadjusted) in active markets for identical assets that the plan has the ability to access at the measurement date. The fair values that are stated using Level 2 inputs are inputs other than quoted price included within level 1. The level 2 inputs are observable for valuing the asset or liability, either directly or indirectly which include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. The fair values that are stated using Level 3 inputs are based on at least one significant unobservable inputs used for valuing the financial instruments. Unobservable inputs are those that reflect the plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances.
