Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained a certification from a qualified institution, Fidelity Management Trust Company, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are

presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Medical Associates of Rhode Island, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A – DESCRIPTION OF PLAN

The following description of the Medical Associates of Rhode Island, Inc. 401(k) Plan. (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan established effective January 1, 1987. The Plan covers all employees of Medical Associates of Rhode Island, Inc. (the Company) who have completed six months of service and are aged 21 or older. The Plan requires a participant to be employed as of year-end to be eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan's investment advisor determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Plan Administrator. The Plan has a 3(16)-relationship established with Fidelity Workplace Services to oversee recordkeeping and administrative services to the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to ninety percent (90%) of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Service. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100 percent of the first 4 percent of base compensation that a participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the option of the Trustees. For the year ended December 31, 2024, there were no profit-sharing contributions to the Plan. Additional discretionary amounts may be contributed by the Company at the option of the Trustees. For the year ended December 31, 2024, there were no discretionary contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant’s account is credited with the participant’s contribution, the Company’s match as well as allocations of (a) the Company’s profit-sharing contribution; (b) Plan earnings and (c) charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are vested immediately in their contributions and safe harbor match plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 50 percent vested after 2 years of credited service and continues to vest in increments of 50 percent until 100 percent vested after 3 years of credited service.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of the employee's vested balance or \$50,000, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% over the Prime Rate as published in the Wall Street Journal on the first business day of the month the loan is originated. The interest rate on outstanding loans ranges from 4.25% to 9.50% with current year loans having an interest rate of 9.50%. Principal and interest is paid ratably, directly by the participants, over a maximum term of five (5) years. The term of loans used to acquire a participant's primary residence may be extended to thirty (30) years. The notes are valued at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits. On termination of service due to death or total and permanent disability, the participant's account will become fully vested regardless of the number of service years. On termination of service due to retirement or any other reason not stated in the previous sentence, a participant may receive the value of the participant's vested interest in his or her account.

Forfeited Accounts - During the years ended December 31, 2024, and 2023, there was \$123 and \$0, respectively, remaining in forfeited nonvested accounts. Forfeitures, if any, are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future Employer contributions payable under the Plan. During 2024 no amounts were applied to plan activities from forfeited nonvested accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for doubtful credit losses have been recorded as of December 31, 2024, and 2023. If a participant fails to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account.

Subsequent events. The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Reclassifications – Certain amounts have been reclassified in the 2023 financial statements to conform to the 2024 presentation with no impact to net assets available for benefits.

NOTE C – FAIR VALUE MEASUREMENT

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the custodians as complete and accurate to the best of their knowledge, except for comparing such information certified by the custodian to the information included in the Plan's financial statements and supplemental schedule. Investments held and certified by the custodian in the accompanying statements of net assets available for benefits totaling \$23,674,961 and \$21,291,767 as of December 31, 2024, and 2023, respectively.

U.S. generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in the active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or by other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair values measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used on December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and are required to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common Collective Trust: Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE E – TAX STATUS

The Plan adopted a pre-approved plan offered by Medical Associates of Rhode Island, Inc. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine tax audits by jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to informational return examinations for years prior to 2021.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes a third-party custodian and record keeper, Fidelity Trust Company and Fidelity Workplace Services. Certain plan investments are shares of mutual funds managed by Fidelity Trust Company; therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participants account balances.

The Plan Sponsor also provides administrative services to the Plan at no cost while also paying certain Plan expenses in the amount of \$10,131 and \$10,809 during the 2024 and 2023 plan year, respectively.

All these party-in-interest transactions are exempt from the prohibited transaction rules.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Concentration of Credit Risk

The Plan's investments are exposed to various risks, including interest rate, market, and credit risk. Investment securities, in general, are exposed to credit risk due to possible default of the issuer. Securities of a single issuer that represents 10 percent or more of the Plan's net assets available for benefits are required to be disclosed.

At December 31, 2024, the Plan held the following investments that individually represented 10 percent or more of the Plan's net assets available for benefits:

NOTE I – INVESTMENT EXPENSES

The Plan's investment expenses are calculated for each fund based on the Asset Management Charge (AMC). The charges to each fund are not shown separately in the financial statements, but rather are netted against the net appreciation of each individual fund and are disclosed to the participants in their individual statements.

NOTE J – REVENUE SHARING

Certain funds within the investment line-up, whose expense fee ratios provide for revenue sharing arrangement, provide for those participants, that selected those investments, to be credited for their proportional share thereby lowering plan fees/expenses. During 2024 and 2023, the revenue sharing amount was \$7,181 and \$6,237, respectively.

NOTE K – COVID RESPONSE

In December 2019, an outbreak of a novel strain of coronavirus (COVID-19) originated in Wuhan, China and has since spread to other countries, including the United States of America. On March 11, 2020, the World Health Organization characterized COVID-19 as a pandemic. The COVID-19 outbreak in the United States of America has caused significant business disruption through mandated and voluntary closings of businesses and organizations across the country for non-essential services. While the disruption is expected to be temporary, there is considerable uncertainty about the duration of the disruption and business closings at the time of publication of these financial statements.

On May 11, 2023, the United Nations World Health Organization declared an end to COVID-19 as a public health emergency, stressing that it does not mean that the disease is no longer a global threat.

Any future financial impact on the Plan cannot be reasonably estimated at this time.

NOTE L – SUBSEQUENT EVENTS

Change in Definition of Compensation

After the plan year ended December 31, 2024, the Plan Sponsor amended the Plan's definition of *eligible compensation* to exclude bonuses from compensation used in determining participant deferrals and employer matching contributions. The amendment is effective January 1, 2025. This change will affect contributions related to compensation earned on or after that date.

Adoption of Automatic Enrollment Provision

After the plan year ended December 31, 2024, the Plan Sponsor adopted an automatic enrollment provision effective January 1, 2025. Under this provision, eligible

employees who have completed six months of service will be automatically enrolled in the Plan at the default deferral rate of 3% specified in the plan document, unless they elect otherwise. This amendment will apply to employees who meet the eligibility requirements on or after January 1, 2025.

Change in Plan Administrator

Effective January 2025, Matthew Uustal, Director of Operations of the Plan Sponsor, was appointed as the Plan Administrator, succeeding Elena Williams, CFO who previously served in that capacity. The change in Plan Administrator represents a change in personnel within the Plan Sponsor and does not affect the accompanying financial statements as of and for the year ended December 31, 2024.

Management has evaluated subsequent events through the date the financial statements were available to be issued and determined that these amendments do not have a material impact on the financial statements for the year ended December 31, 2024.
