NOTE 1 - Description of Plan

The following description of NextGen Security, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan with an Internal Revenue Code ("IRC") Section 401(k) provision covering all employees of NextGen Security, LLC and ISO Network, LLC (together, the "Company" and "Employer") who meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Administrative Committee is responsible for oversight of the Plan including monitoring of investment performance and determining appropriate investment offerings.
- B. Eligibility Requirements - Each employee who is not a nonresident alien, a resident of Puerto Rico, or a union employee is eligible to participate in the Plan and receive Employer Qualified Automatic Contribution Arrangement ("QACA") safe harbor matching contributions after 2 months of service.
- C. Participant Contributions - Eligible employees may make salary deferral contributions not to exceed 50% of their pretax annual eligible compensation up to \$23,000 and \$22,500, which is the maximum dollar limit set by law for the years ended December 31, 2024 and 2023, respectively. Participants are also permitted to make Roth elective deferrals.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation.

Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up contributions." For the years ending December 31, 2024 and 2023, the maximum catch-up contributions were \$7,500.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

- D. Employer Contributions - Effective January 1, 2024, the Employer will make a QACA safe harbor matching contribution equal to 100% of a participant's elective deferrals up to 1% of the participant's eligible compensation, plus 50% of the participant's elective deferrals between 1% and 6% of eligible compensation. Prior to this, the Employer would make fixed tiered matching contributions equal to 75% of the of the first 2% of eligible compensation deferred by the participant, then 25% of the next 4% of eligible compensation deferred by the participant.
- E. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specified participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- F. Payment of Benefits - A participant will receive a lump sum, substantially equal installments, or partial withdrawals over \$500 in amounts equal to the value of the individual's account upon termination of service due to death, disability, or upon attaining a Normal Retirement age or an early Retirement benefit if certain age and service requirements are met. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or attaining age 59 ½, in accordance with provisions specified in the Plan document.

Participants will receive a lump sum payment as soon as administratively feasible following termination. Participants with vested balances that exceed \$1,000 but do not exceed \$5,000 who do not consent to a lump sum payment will automatically be rolled over into an individual retirement account. If total vested benefits exceed \$5,000, no distribution is made from the Plan without consent of the participant.

- G. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Participants become fully (100%) vested in the Employer safe harbor matching contributions upon the occurrence of death and total or permanent disability.

Other than as stated above, Employer safe harbor matching contributions vest based upon the following:

Less than 2 years	0%
2 years or more	100%

The vesting computation period will be the date an employee first performs an hour of service and each anniversary thereof.

Prior to January 1, 2024, participants were immediately vested in their Employer matching contributions upon entering the plan.

- H. Income Tax Status - The Plan is structured and follows a prototype non-standardized cash or deferred profit sharing plan, pre-approved by the IRS. The IRS issued an opinion letter dated October 6, 2020, that the prototype non-standardized profit sharing plan is acceptable with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- I. **Forfeited Accounts** - Any participant who terminates employment without being fully vested (100%) in their Employer contribution account forfeits their nonvested portion of the Employer contribution. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,129 and \$3,914, respectively. These accounts are used to reduce future Employer contributions. During 2024, the Employer contributions were reduced by \$21,405 from forfeited nonvested accounts.

**NOTE 2 - Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are a representation of the Plan's management, who is responsible for their integrity and objectivity. The accounting policies described below conform to accounting principles generally accepted in the United States of America and have been applied consistently in the preparation of the financial statements.

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Administrative expenses for maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant's accounts, and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events** - Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 9, 2025.

**NOTE 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Shares of Registered Investment Companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of Registered Investment Companies held by the Plan are deemed to be actively traded.

The Plan's assets at fair value are comprised of registered investment companies, for which fair value measurements at the end of the reported period use quoted prices in active markets for identical assets (level 1). The total assets at fair value using level 1 are \$8,433,347 and \$6,516,173 for the years ended December 31, 2024 and 2023, respectively.

NOTE 4 - Trustee Certification

The 2024 and 2023 information summarized below was certified by Reliance Trust Company. The Plan administrator has obtained certifications from the trustee as of and for the years ended December 31, 2024 and 2023, that the information provided to the plan administrator by the trustee is complete and accurate.

NOTE 5 - Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their nonforfeitable account balance. Loan transactions are treated as transfers between the investment fund and the participant notes fund. Loan terms range from one to five years, unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which is based on the Prime rate plus 2%. Principal and interest are paid ratably through weekly and biweekly payroll deductions. Balances outstanding at December 31, 2024 and 2023 were \$173,066 and \$142,585, respectively.

NOTE 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Employer contributions.

**NOTE 7 - Risks and Uncertainties**

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - Related Party Transactions**

Certain plan investments are administered by Reliance Trust Company and ADP Retirement Solutions. Reliance Trust Company is the trustee for the Plan and ADP Retirement Solutions provides record keeping services to the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments for financial reporting purposes. Fees paid directly by the Plan to ADP Retirement Solutions for recordkeeping / administrative and investment management services amounted to \$15,785 and \$30,766, respectively, for the year ended December 31, 2024. Certain administrative functions of the Plan are performed by officers or employees of the Company. The Company pays directly any other fees related to the Plan's operations.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.
