NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Sonic Systems International, Inc. 401(k) P/S Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s information.

General: The Plan is a defined contribution plan and covers all eligible employees of Sonic Systems International, LLC (formerly known as Sonic Systems International, Inc.) and its subsidiaries (the “Company”) except collectively bargained employees, nonresident aliens who receive no compensation from the Company which constitutes U.S. source income, leased employees, and seasonal employees who are regularly scheduled for less than 1,000 hours during a year. New employees must complete one month of service to become eligible to enter the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may elect to make salary deferral contributions to the Plan of a minimum of 1% and a maximum of 90% of eligible compensation subject to the amounts allowed by law. Participants are allowed to designate salary deferral contributions as Roth elective deferrals to the Plan. Participants age 50 or over in the plan year may also make catch-up contributions into the Plan. The Plan also allows rollover contributions. The Company may make a discretionary contribution in the form of profit sharing. Profit sharing contributions are allocated based on a participant’s eligible compensation to total plan compensation. Participants must be employed on the last day of the plan year, except for participants who become disabled, die, or retire in the plan year, and complete 1,000 hours of service during the plan year to receive discretionary contributions. The Company did not make any discretionary contributions for the year ended December 31, 2024. The Plan is participant directed, and participants may change their contribution rates and investment options at any time.

Participant Accounts: Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and profit-sharing contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments: Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers numerous mutual fund investment options for participants.

Vesting: Participants are fully vested in all sources at all times.

Notes Receivable from Participants: Plan participants may borrow from their account a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. Notes receivable from participants are paid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence, in which case the period will be determined at the time the note is made. The notes bear interest at prime plus 2% at the date of the note and are secured by the participant’s vested account to the extent of the principal amount of the note plus accrued interest. The Plan allows participants to have three loans outstanding, subject to loan limitations.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits: Benefits may be paid to a participant or beneficiary upon retirement, total and permanent disability, death, or termination of employment in a lump-sum amount or in installments or a direct rollover into an eligible retirement plan equal to the value in the participant's account in accordance with the restated Plan provisions. Participants with vested balances of \$5,000 or less will have the balance of their account disbursed as soon as administratively feasible. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½. Rollover contributions can be withdrawn at any time.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefit payments to participants are recorded upon distribution.

Subsequent Events: Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

NOTE 5 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Actual fees paid by the Plan for recordkeeping services qualify as party-in-interest transactions. Such costs are included in administrative expenses in the accompanying financial statements. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Notes receivable from participants held by the Plan are also considered party-in-interest transactions.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would receive their vested account balance, less applicable costs.

NOTE 7 – FEDERAL INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated October 6, 2020 indicating that the nonstandardized prototype plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original nonstandardized prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
