NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

Note 1 – Description of Plan

The following description of the Century Mold Co., Inc. Section 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan designed to meet the requirements of the §401(k) of the Internal Revenue Code (IRC). The Plan is sponsored and administered by Century Mold Co., Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective with the close of business on April 9, 2024, the Company acquired Integrity Injection Molding Inc. (IIM) and effective May 1, 2024, IIM employees were eligible to participate in the Plan. Effective September 1, 2024, IIM was renamed Century Mold Pulaski Company Inc.

Reliance Trust Company is the trustee and custodian of the Plan. Automatic Data Processing, Inc. Retirement Services is the Plan's recordkeeper.

Participation

Employees are eligible to make contributions to the Plan and for employer matching contributions the first day of the month coinciding with an employee's date of hire. If the employee's date of hire is any day other than the first day of a calendar month, employees are eligible to make contributions to the Plan and for employer matching contributions the first day of the month following the employee's date of hire. Participants are eligible for employer profit sharing contributions, as determined annually by the Company's Board of Directors, after completing one year of service, as defined.

Contributions

Participants may elect to defer up to 90% of their compensation, not to exceed the maximum annual limitations as provided by the IRC. Participants are automatically enrolled to defer 4% of compensation upon meeting eligibility requirements as defined in the Plan document. Employees, who are automatically enrolled after the effective date will have their deferral percentage increased by 1% on the employees anniversary date of entry into the Plan until a ceiling of 10% is reached.

The plan document includes a fixed employer match of \$0.50 Company match per \$1.00 contributed by the participant up to the maximum Company match of \$1,000 per calendar year to be funded into the Plan per payroll period.

The Company may make discretionary matching contributions, which would be allocated to participant accounts based on their annual employee contributions. Additional amounts may be contributed at the option of the Company's Board of Directors, subject to certain limitations. There were no discretionary matching contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions, and Plan earnings, and charged with withdrawals and an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Plan provides for 20% vesting in the employer's contribution after two years of service, as defined in the Plan document, with 100% vesting after three years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, or longer for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator based on interest rates charged for similar types of notes by other lenders. Principal and interest is paid ratably through payroll deductions. The maximum number of loans outstanding at any one time is one.

Payment of Benefits

Unless a participant elects otherwise, distributions will be made as soon as administratively feasible after a participant's normal retirement date or actual retirement date occurs. The Plan provides for normal retirement benefits upon reaching age 62 and has provisions for disability, death, hardship and termination benefits for those participants who are eligible to receive such benefits. Participants who have reached age 55 and have completed three years of service are eligible for early retirement. In-service distributions are eligible to participants who have attained age 59 and one-half and are still employed with the Plan Sponsor. Participants may receive their accumulated vested benefits upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death or disability if their account is in excess of \$7,000. All balances under \$7,000 are distributed to the participant as soon as administratively feasible.

Administrative Expenses

Administrative expenses can be paid by the Plan or the Company.

Revenue Sharing Account

The Plan has a Revenue Sharing Account which is a suspense account funded with certain other revenue generated by the Plan. During 2024, the Plan received revenue of \$137,818 which is included in other income on the statement of changes in net assets available for benefits. These funds may be used to pay Plan expenses or be allocated to participants. During 2024, \$106,707 of Plan expenses and \$30,000 in allocations to participants were paid from the Revenue Sharing Account. The unused balance of this account amounted to \$6,410 and \$5,299 as of December 31, 2024 and 2023, respectively.

Forfeitures

In accordance with the Plan document, forfeitures of non-vested employer contributions and earnings thereon are applied to reduce future employer contributions. During 2024, \$92,168 of forfeitures were used to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,650 and \$827, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Subsequent Events

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date that the financial statements were available to be issued.

Effective as of January 1, 2025, the Plan was amended to include several updated provisions. Participants are now 50% vested in employer matching contributions after two years of service and continue to be 100% vested after three years of service. Additionally, the automatic deferral percentage increased from 4% to 5%. Company matching contributions are now matched up to 5% of participant's compensation and there is no longer a maximum matching contribution of \$1,000.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as inflation, pandemic or international conflict. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Note 3 – Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. That guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: These investments are valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

Collective Trust Funds: Valued at NAV based on the underlying assets of the trust. The NAV is used as a practical expedient to estimate fair value and is obtained from information provided by the investment advisor using the audited financial statements of the collective trust at year end. There are no restrictions on redemptions of these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Financial Information Certified by the Custodian

The Plan Administrator has elected the method of compliance in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets (held at end of year) as of December 31, 2024 and the related investment activity (including interest and dividends, other income and net appreciation in fair value of investments), and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 5 – Party-in-Interest Transactions

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in employer contributions.

Note 7 – Tax Status

The Plan adopted a non-standardized form of a pre-approved plan sponsored by ADP, LLC. The pre-approved plan has received an opinion letter, dated October 6, 2020, from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no Plan audits for any tax periods in progress.
