### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Law Offices of Robert S. Gitmeid & Associates 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Law Offices of Robert S. Gitmeid & Associates 401(k) Profit Sharing Plan and Trust (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of the Law Offices of Robert S. Gitmeid & Associates, PLLC's (hereinafter, the "Employer" or the "Plan Sponsor") management, which is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America, and have been consistently applied in the preparation of the financial statements and supplemental schedule.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments in registered investment companies and common collective trusts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 3 and 4 for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year. During the year ended December 31, 2024, the Plan's investment gains (including gains and losses on investments bought and sold, as well as held during the year) were \$535,255.

Participant Notes Receivable: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid to the Plan's participants.

Events Occurring After Report Date: The Plan Sponsor evaluated events and transactions that occurred between January 1, 2025 and October 13, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. Subsequent to year end, the Employer decided to change the trustee. The change occurred in February 2025.

**NOTE 2 - DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan, restated effective March 1, 2022, was established to provide deferred compensation and profit-sharing benefits to employees of the Plan Sponsor. The Plan is registered with the Internal Revenue Service ("IRS") as a prototype, non-standardized, profit-sharing plan with a cash or deferred arrangement.

The Plan is a defined contribution plan covering all employees of the Plan Sponsor who have completed one month of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Reliance Trust Company ("RTC") served as the Plan custodian of the Plan assets for the years ended December 31, 2024 and 2023. The Plan Sponsor uses Automatic Data Processing ("ADP") for its administrative and recordkeeping services.

Contributions: Each year, participants may contribute to the Plan a percentage of compensation, as defined, or a specific dollar amount. Employees may elect to defer a maximum amount not to exceed the annual thresholds established by the IRS. Participants who attained age 50 by the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts distributed from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Automatically enrolled participants have their deferral rates set initially at 3% of eligible compensation and their contributions are invested in a balanced fund until changed by the participant.

The Plan also allows participants to designate a portion of their contributions to be treated as "Roth" contributions. A contribution treated as a Roth contribution is subject to current federal income tax at the time it is contributed to the Plan. However, if certain requirements are satisfied prior to the distribution of such amounts from the Plan, distributions of amounts attributable to Roth contributions (including earnings thereon) will not be subject to federal income tax at the time of distribution.

The Plan provides for safe harbor employer matching contributions to deferring participants. Such employees are eligible to receive a matching contribution equal to 100% of the first 1% of eligible compensation that a participant contributes, plus 50% of eligible compensation that a participant contributes in excess of 1%, not to exceed 6%. For the year ended December 31, 2024, the Plan Sponsor made matching contributions of \$627,001. The Plan provides for additional employer contributions at the discretion of the Plan Sponsor, not to exceed 3.5%. There were no employer discretionary contributions for the year ended December 31, 2024. Contributions are subject to certain IRS limitations, which are established every year.

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the Plan Sponsor's contribution, the Plan's earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions and all Plan Sponsor contributions plus actual earnings thereon. As such there are no forfeitures.

Notes Receivable from Participants: The Plan provides for participant loans at a minimum of \$500 to a maximum of the lesser of \$50,000 or 50% of a participant's account balance. The loans are secured by the balances in the participants' accounts and bear interest at rates ranging between 5.25% and 10.50%, which are commensurate with local prevailing rates as determined by the plan administrator at the time the loans were taken. Loans are repaid over a period selected by the participant, which extends no longer than five years, or thirty years if loan proceeds were for the purchase of a principal residence. Principal and interest are repaid ratably through payroll deductions.

Deemed Distributions: When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. A loan in default is considered a distribution from the Plan (deemed distribution) that could result in taxable income to the participant. There were no deemed distributions during the 2024 plan year. There were deemed distributions of \$573 during the 2023 Plan year.

In-Service Withdrawals: In-service or hardship withdrawals are permitted by the Plan.

Payment of Benefits: Participants will reach the Plan's normal retirement age at the later of age sixty-five or the fifth anniversary of the first Plan year in which the employee became a participant. At the normal retirement age, participants will be entitled to one hundred percent of their vested account balances, but benefits may be deferred if the participants so elect. Participants are entitled to one hundred percent of their vested account balances upon separation of employment and their estates are entitled to one hundred percent of the decedents' vested account balances upon death.

Administrative Expenses: The Plan pays for all investment-related expenses, while the Plan Sponsor pays for all other costs of maintaining and administering the Plan.

Plan Amendments: The Plan Sponsor has the right under the Plan to amend the Plan at any time. The Plan was restated effective March 1, 2022 to comply with legislative and regulatory changes set forth in IRS Notice 2017-37.

Impact of New Regulations: In January 2020, Congress passed the Setting Every Community Up for Retirement Enhancement ("SECURE") Act. Many of the provisions of the SECURE Act were effective on January 1, 2020 and will require significant changes to plan administration and recordkeeping.

The Plan Sponsor has until the 2025 Plan year to amend the Plan to include any adopt SECURE Act provisions.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become one hundred percent vested in their accounts.

Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The Plan Sponsor utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset and liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Mutual Funds (Registered Investment Companies): Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV is based upon quoted market prices.

Common/Collective Trusts: Valued at the NAV of units held by the Plan at year-end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments are shares of mutual funds managed by the custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included as part of net appreciation in fair value of investments.

**NOTE 6 - TAX STATUS**

The Plan Sponsor adopted a prototype, non-standardized; profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020, which states that the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**NOTE 8 - INFORMATION CERTIFIED BY CUSTODIAN**

All investment information and notes receivable from participants disclosed in the accompanying financial statements as of December 31, 2024 and 2023, and ERISA-required supplemental schedule, including net appreciation in fair value of investments, interest and dividends, and notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian, RTC.
