### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Bristol Farms, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bristol Farms, Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 – Plan Description

The following description of the Bristol Farms, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** – The Plan was established effective as of July 3, 1995, and is intended to qualify as a profit sharing plan under sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration** – The Plan is sponsored by Bristol Farms, Inc. (the Company or Sponsor), which also serves as the plan administrator. Reliance Trust Company (Reliance Trust or Trustee) is the Plan's trustee and maintains the Plan's assets. ADP Retirement Services (ADP) is the Plan's recordkeeper.

**Eligibility** – Full-time employees of the Company are generally eligible to participate in the Plan after three months of service.

**Contributions** – Plan participants may make contributions of up to 60% of pretax annual compensation, as defined in the Plan, and not in excess of the maximum allowed by the IRC. However, highly compensated employees (as defined by the Plan) may be subject to further limitations. Employees who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified plans. All participant contributions are participant-directed by the participant in one or more of the investment options offered under the Plan. Contributions are subject to regulatory limitations.

The Plan also provides for employer discretionary matching contributions based upon a discretionary percentage of each participant's deferral contributions as determined by the Sponsor. Participants who have at least one year of service are eligible for the employer discretionary matching contributions.

**Participants' accounts** – Participants' contributions are invested in various funds according to participant elections and must be allocated among the available funds in whole percentages. Individual accounts are maintained for each of the Plan's participants to reflect each participant's contributions and related employer contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of the plan income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are 100% vested at all times in their deferral contributions, plus actual earnings or losses thereon. In addition, participants are also 100% vested at all times in any safe harbor matching contributions that were made prior to the Plan being amended and restated to discontinue the safe harbor contributions.

**Forfeited accounts** – If a participant’s employment is terminated before full vesting of employer contributions and related earnings are attained, the amount not vested is allocated to pay any administrative expenses of the Plan or to reduce any employer contributions. During the year ended December 31, 2024, forfeitures of \$21,771 were used to reduce employer contributions. Non-vested forfeited balances in the Plan totaled \$0 for the year ended December 31, 2024.

**Payment of benefits** – Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account. These payments may be paid in a lump-sum payment or paid in installments over time. Any withdrawal made by a participant prior to attaining age 59 ½, that is not rolled over into another retirement account, for reasons other than death or disability is subject to a 10% federal excise tax.

**Participant loans** – Participants may borrow from their accounts a minimum of \$500 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance of the participant’s account and must be repaid at a fixed rate which is commensurate with local prevailing rates. As of December 31, 2024, the rates of interest ranged from 4.25% to 9.50% with maturities through August 2041.

Loans must be repaid within five years, unless the loan is for the purchase of a principal residence, in which case, the repayment period may be extended.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The accompanying financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could materially differ from those estimates.

**Investment valuation** – Investments are stated at fair value (see Note 3).

The Plan's trustee, Reliance Trust Company, certifies the fair value of all investments. In accordance with the policy of stating plan assets at fair value, the Plan presents the net appreciation in the fair value of its investments in the statement of changes in net assets, which consists of the realized gains or losses and the unrealized appreciation on those investments.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Interest and other income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of benefits** – Benefit payments are recorded when paid.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loans to be in default, the participant loan is reduced and a benefit is recorded.

**Administrative expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**Excess Contributions payable** – Excess contributions payable represent amounts refunded to participants after year end to comply with regulatory contribution limitations.

### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds** – The fair value of mutual funds is determined based on quoted market prices in active markets, which represent the net asset value of shares of the mutual fund held by the Plan at year end. Mutual funds are classified in Level 1 of the valuation hierarchy.

**Common and collective trusts** – Units of the common and collective trusts are stated at net asset value (NAV) which is based on the aggregate fair value of the underlying assets of the trust in relation to the total number of units outstanding. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations will be carried out in an orderly business manner.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5 – Income Tax Status**

The Internal Revenue Service (IRS) issued a determination letter dated October 6, 2020, stating that the prototype plan adopted by the Plan was designed in accordance with the applicable IRC requirements as of that date. Although the Plan has been amended since the date of the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes is reflected in the accompanying financial statements. Continued qualification is dependent on the Plan's future operations.

In accordance with GAAP, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that is more likely than not to be sustained upon audit by the IRS. An uncertain income tax position will not be recognized if it has less than a 50% likelihood of being sustained. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

#### **Note 7 – Party-in-Interest Transactions**

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

#### **Note 8 – Plan Termination**

Although the Company has not expressed any such intention, the Plan may be discontinued at any time by the Company. In the event of termination, participants' rights to company contributions become fully vested and the net assets of the Plan would continue to be held for normal withdrawal by participants assuming the Company's operations continue or would be distributed to participants immediately if the Company's operations cease.

#### **Note 9 – Delinquent Contributions**

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. Specific to delinquent contributions from the plan year ended December 31, 2024, the Company is in the process of determining lost earnings and will remit these amounts subsequent to year end. There were \$427,865 of delinquent contributions from the Plan during the year ended December 31, 2024.

#### **Note 10 – Subsequent Events**

Plan management has evaluated and determined that no events have occurred subsequent to December 31, 2024, the date of the accompanying net assets available for benefits, through October 14, 2025, the date of issuance of these financial statements, which would require recording or disclosure in its financial statements.
