Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of FreeAlliance.com LLC 401(k) Profit Sharing Plan & Trust (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined that it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of plan

The following is a brief description of the FreeAlliance.com LLC 401(k) Profit Sharing Plan & Trust and is provided for general purposes only. Participants should refer to the Plan agreement, as amended and restated, for a more complete description of the Plan's provisions.

General – FreeAlliance.com LLC 401(k) Profit Sharing Plan & Trust (the Plan) was established January 1, 2015 and amended and restated most recently on June 1, 2022. The Plan is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers all eligible employees of FreeAlliance.com LLC (the Company or the Plan Sponsor). Employees are eligible to participate in the Plan on the first day of the month following their month of hire and attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has appointed Reliance Trust Company (Reliance) to act as trustee of the Plan and appointed Automatic Data Processing, LLC (ADP) as the recordkeeper of the Plan.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses are paid directly by the Company.

Participant contributions – Participants may make salary contributions from 1% up to 90% of their compensation, subject to limitations of the IRC. Employees can choose pre-tax contributions and after-tax Roth contributions or a combination of both, subject to the limitations of the IRC. Participants may, on a quarterly basis, change their contribution percentage or suspend future deductions from their pay. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. Participants are immediately fully vested in their salary deferral and rollover contributions.

Company contributions – In 2024, the Company contributed matching contributions equal to the lesser of one-hundred percent of each participant's contribution or two percent of each participant's salary deferred into the Plan. In addition, the Company can elect to make non-elective contributions. There were no non-elective contributions during the year ended December 31, 2024.

Vesting - Vesting in the Company's non-elective contribution portion of their accounts is based upon years of service, as defined in the Plan. A participant is 100% vested after 6 years of credited service. In addition, participants who die or become disabled while employed by the Company become 100% vested.

Investment Options - Participants are afforded several investment options covering a wide range of investment objectives and risk. Participants may allocate their contribution across these options in any proportion they wish, and can change this allocation at any time. Transfers of account balances between elected investment options may also be made at any time. As of December 31, 2024, participants have the choice of investing their contributions, along with Company contributions, in at least 30 different investment options.

Forfeitures – Terminating participants forfeit the non-vested portion of the participant's employer contributions. Forfeitures can be used to pay administrative expenses or to reduce the Company's discretionary contributions. The Company used \$69,817 of forfeitures during 2024 to reduce the discretionary contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$84 and \$83, respectively.

Participants' accounts – Individual accounts are maintained for each participant and include participants' salary deferral contribution, rollovers (transfers in from other qualified plans), the Company matching contribution and an allocation of the Company non-elective contribution (if any), plan earnings, and realized and unrealized gains and losses on investments. Non-elective Company contributions are allocated in proportion to each participant's share of total eligible compensation, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits – Participants are eligible for retirement benefits upon attaining the age of 65. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the vested value of his or her account or installments over a period of time. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or elect a direct rollover contribution.

Hardship withdrawals – The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw part or all of their account balances while actively employed. These hardships withdrawals are subject to IRC restrictions and penalties.

Notes receivable from participants – The Plan allows participants to borrow against their vested account balances, subject to IRC restrictions. Participant loans require periodic payments, bear interest at rates charged on similar commercial loans under like circumstances, and are due within 5 years. However, loans to purchase a principal residence may be repaid over a period longer than 5 years. Participant loans were \$78,845 and \$46,510 at December 31, 2024 and 2023, respectively. Interest rates as of December 31, 2024 and 2023 were 5.25% - 10.5% and loans mature at various dates through November 2029.

Note 2 – Summary of significant accounting policies

Basis of accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Investment transactions are recorded on the date of purchase or sale (trade date). Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants – This asset is stated at the unpaid principal balance plus any accrued but unpaid, interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2023.

Payments of benefits – Benefits are expensed when paid.

Risks and uncertainties – The Plan invests in various investment instruments. Such investments, in general, are exposed to various risks, such as interest-rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect

participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Estimates – The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent events – The Plan has evaluated events through October 14, 2025 in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.

As of January 1, 2025, Reliance Trust Company, the Plan's trustee, changed its name to ADP Retirement Trust Services, LLC. As such, the plan amended its plan document and summary plan description to reflect this change.

Note 3 – Fair value measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). Fair value is determined based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. An asset's or liability's classification is based on the lowest level of input that is significant to the fair value measurement. Assets and liabilities carried at fair value are classified and disclosed in one of the following categories:

- Level 1 – Quoted market prices in active markets for identical assets or liabilities.
- Level 2 – Observable market-based inputs or unobservable inputs corroborated by market data.
- Level 3 – Unobservable inputs reflecting management's own assumptions.

The following is a description of the valuation methodologies and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the valuation techniques and inputs used. There are no plan assets requiring the use of level 3 inputs at December 31, 2023.

Mutual funds – The fair value of the investments in this category are valued at the daily closing price as quoted on the active market which is considered Level 1.

Common Collective Trust – The fair value of the investments in this category have been estimated using the Net Asset Value (NAV) per unit provided by the trustee of the fund. The NAV of this account is based on the value of the underlying assets owned by the fund, minus liabilities divided by the number of shares outstanding. The NAV is not a publicly quoted price in an active market since the investments' unit prices are quoted on a private market that is not active; however, the unit price is based on the underlying investments which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies and assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Fully benefit-responsive investment contract

The Plan holds the Invesco Stable Asset Fund which is a collective trust fund within the Invesco Stable Asset Trust. This trust was established exclusively for collective investment and re-investment of assets contributed by eligible pension and profit-sharing trusts and entities. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

This fund, as held by the Plan, is considered a common collective trust. The fund stated that as of December 31, 2024, the underlying assets within the fund were valued based upon Level 2 inputs (as defined in Note 3 above) and the NAV as of December 31, 2024 was \$1.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contracts
- Plan termination or merger
- Excessive participant trading (under which participant transfers may be restricted for up to 30 days or after the resolution of closed or disrupted financial exchanges or markets)
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer.

Note 5 – Tax status

The Plan is an adoption of an ADP, LLC prototype non-standardized, pre-approved profit sharing plan with CODA designed to be qualified under the IRC as exempt from Federal income taxes, and has received a favorable determination letter dated October 6, 2020 from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no unrelated business income. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are no audits for any tax periods in progress. Plan Management believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6 – Information certified by the Trustee

The Plan administrator has elected the alternative method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the trustees except for comparing such information certified by the trustees to information included in the Plan's financial statements and supplemental schedule.

Reliance Trust Company has supplied the Plan administrator with certifications as to the completeness and accuracy of certain investment information presented in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the Supplemental Schedule of Assets (Held at End of Year) at December 31, 2024.

Note 7 – Plan termination

Although it has no present intention of doing so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan’s termination, participants will become fully vested in their accounts.
