To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Areas USA, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Areas USA, Inc. 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Areas USA, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A) GENERAL

The Plan is a profit sharing plan covering eligible employees of Areas USA, Inc. (the "Company" or "plan sponsor") and certain affiliates under the provisions of Section 401(a) of the Internal Revenue Code (the "Code"), as amended, which includes qualified cash or deferred arrangements as described in Section 401(k) of the Code, for the benefit of eligible employees of the Company. The Plan was restated effective August 1, 2022. The Plan's service provider and trustee are Automated Data Processing Inc. ("ADP") and Reliance Trust Company ("Reliance"), respectively.

The Plan is subject to and conforms with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

B) ELIGIBILITY

Prior to August 1, 2022, employees were eligible to participate in the Plan upon reaching the age of 21 and completing one month of service, as defined, prior to entry date. The Plan entry date was the first day of the month coinciding with or the next month following the date after meeting the above requirements. Participants were eligible to receive employer matching and nonelective contributions upon reaching the age of 21 and completing six months of service, as defined. Effective August 1, 2022, employees are eligible to participate in the Plan and receive employer matching and nonelective contributions upon reaching the age of 21 and completing six months of service, as defined, prior to entry date. The Plan entry date is the first day of the quarter coinciding with or the next month following the date after meeting the above requirements. The entry date and service requirements are waived for employees that were employed on December 31, 2021. Participants must be employed on the last day of the Plan year and have completed at least 500 hours of service to receive the Company's nonelective contribution. Participants that are not employed on the last day of the Plan year are eligible if they are terminated after reaching normal retirement age, are totally and permanently disabled, or death occurs.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

C) CONTRIBUTIONS

Eligible employees can contribute up to 90% of annual compensation, as defined in the Plan document. The total maximum allowable contribution per participant to the Plan directly from the participant was \$23,000 for the fiscal Plan year, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500. The Company may make discretionary matching contributions determined by the Company's management. The Company may also elect to make nonelective contributions to the Plan. During the year ended December 31, 2024, the Company elected to match 50% of participant deferrals up to 4% of eligible compensation. The Company's matching contributions totaled approximately \$395,000 during the year ended December 31, 2024. No nonelective contributions were made for the year ended December 31, 2024.

D) VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of continuous service. Vesting in the Company's discretionary matching contributions is as follows:

Participants are 100% vested, regardless of years of service, when they reach normal retirement age, are totally and permanently disabled, or death occurs.

E) PAYMENT OF BENEFITS

Benefits are payable on termination of service due to retirement, termination, disability or death. Participants or their beneficiaries may elect to receive a lump-sum distribution, annual installments, or partial withdrawals as defined in the Plan document. Eligible participants may also make hardship withdrawals, as defined.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

F) PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's compensation deferral contributions, the Company's discretionary matching and nonelective contributions, if any, and an allocation of the investment earnings, based upon each participant's election, and charged with an allocation of administrative expenses not paid by the Company. The benefit to which a participant is entitled upon withdrawal from the Plan, as defined above, is the vested benefit in the participant's account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

G) INVESTMENT OPTIONS

Participants are allowed to invest their elective 401(k) contributions, rollovers, if any, as well as Company matching and nonelective contributions to the Plan in a variety of investment options as more fully described in the Plan document. Participants may change their investment options and deferral percentages at any time.

H) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$500 and up to a maximum equal to the lesser of (a) 50 percent of their vested account balance, or (b) \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve month period. The notes are secured by the vested balance in the participant's account. The interest rate for a loan will be the rate in effect in the month the note is effective. The interest rate is the prime rate as published by the *Wall Street Journal* on the 14th of each month, plus one percentage point. Participants are permitted to have one loan outstanding at a given time.

Principal and interest is repaid through payroll deductions over a period of no more than five years, unless the loan is used for the purchase of a primary residence.

I) FORFEITED ACCOUNTS

Pursuant to the Plan, forfeited non-vested accounts may be used to pay Plan expenses, offset matching contributions, or be allocated as additional employer matching contributions. During the year ended December 31, 2024, approximately \$50 in forfeitures were used to offset matching contributions. At December 31, 2024 and 2023, the Plan had a remaining forfeiture balance of \$18,111 and \$6,435, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

A) BASIS OF ACCOUNTING

The Plan's financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America for employee benefit plans.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

B) USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

C) INVESTMENT VALUATION AND INCOME RECOGNITION

Assets of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at the net asset value ("NAV") of shares held by the Plan.

Purchases and sales of securities are recorded on a trade date basis. Dividend and interest income are recorded by the trustee in the period earned. Net realized and unrealized appreciation or depreciation in fair value of investments consists of the change in unrealized appreciation or depreciation and the realized gain or loss on the sales of investments during the year. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses. Investments are self-directed by the individual Plan participants.

D) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

E) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

F) PAYMENT OF BENEFITS

Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

G) ADMINISTRATIVE EXPENSES

The Plan agreement allows for the Company to absorb a significant amount of the Plan's administrative expenses. Investment related expenses are included in net appreciation of fair value of investments through revenue sharing arrangements. During the fiscal year ended December 31, 2024, administrative expenses incurred by the Plan totaled approximately \$114,000.

H) RECENT ACCOUNTING PRONOUNCEMENTS

The Company evaluates new accounting pronouncements for relevance and impact on the Plan's financial statements. Management does not expect that timely adoption of new pronouncements will have a material impact on the Plan's net assets available for benefits.

I) MANAGEMENT REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 22, 2025, the date when the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, Level 1 inputs were available and therefore used. No level 2 and 3 inputs were used by the Plan.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - The mutual funds invest mainly in domestic equity funds, international equity funds, bond funds, short-term funds, and common stocks which have observable Level 1 pricing inputs, including quoted prices for identical assets in active markets. Mutual funds are valued at the quoted NAV of shares held by the Plan at year-end.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to suspend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5 - TAX STATUS

The Plan is based on a "prototype" plan document. The sponsor of the prototype document has received a favorable determination letter from the Internal Revenue Service ("IRS") dated October 6, 2020, stating that the form of the Plan is qualified under Section 401 of the Code. The Company has chosen to rely on the IRS determination letter issued to the sponsor of the prototype document as evidence that the form of the Plan is tax-qualified. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Reliance is the appointed trustee and ADP is the service provider of the Plan during the fiscal years ended December 31, 2024 and 2023. Therefore, fees paid to the trustee and service provider qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

NOTE 7 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, the trustee of the Plan and qualified institution, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE 8 - EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants totaling approximately \$69,000 and \$70,000 as of December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to contributions. The excess contributions were refunded in the subsequent Plan year.

NOTE 9 - FIDELITY BONDING

The Company maintains a fidelity bond of \$500,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.
