### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of the Concrete General, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. **Description of the Plan** The following description of the Concrete General, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Concrete General, Inc. (the “Company”). Employees are eligible to contribute to the Plan on the day they satisfy the Plan’s eligibility requirements. For salary reduction and employer matching contributions employees who are at least 18 years old and have completed 9 months of service are eligible to participate. Employees who are at least 18 years old and have completed 9 months of service will be eligible for employer discretionary profit sharing contributions beginning on January 1st or July 1st following the date the eligibility requirements have been met. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions:** Participants can contribute up to 75% of eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, common collective trusts, and a stable value fund as investment options for participants. The Plan provides for discretionary employer contributions. The Company has a safe-harbor matching contribution that provides for a matching contribution of 100% of salary deferral contributions up to 5% of pay for each payroll period. Additional matching contributions and profit sharing contributions may be made at the discretion of the Company’s Board of Directors. For the year ended December 31, 2024, no additional employer contributions were made. Contributions are subject to certain limitations.

**Participant accounts:** Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, an allocation of the Company’s discretionary contributions, and an allocation of the investment earnings and losses. Allocations of the Company’s discretionary contributions and investment earnings and losses are based on eligible participant compensation or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting:** Participants vest immediately in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company’s safe harbor matching contributions. Vesting in the discretionary employer matching and profit sharing is based on years of continuous service. A participant is 20% vested in employer discretionary contributions after two years of service is completed, and continues to vest at a rate of 20% per year until fully vested after six years of service.

1. **Description of the Plan (continued)**

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% or any other reasonable rate established by the trustees, which was 4.25% - 9.50% for outstanding loans at December 31, 2024. Principal and interest are paid through payroll deductions.

**Payment of benefits:** Benefits are payable upon retirement at age 65, early retirement at age 55 with five years of service, in-service withdrawals at age 59 1/2, disability, death, or termination of employment. Hardship withdrawals are also permitted, subject to provisions described in the Plan document. The participant will receive a lump-sum distribution of all vested amounts.

**Forfeited accounts:** At December 31, 2024, there was \$7 of forfeited non-vested accounts. Any non-vested forfeited amounts will be used to pay plan expenses, reduce future matching contributions and then will be allocated to participant accounts.

**Subsequent events:** Management has evaluated subsequent events for disclosure in these financial statements through October 14, 2025, which is the date the financial statements are available to be issued.

2. **Significant accounting policies**

**Basis of accounting and use of estimates:** The accompanying financial statements have been prepared on the accrual basis of accounting. The preparation of the financial statements in accordance with U.S. generally accepted accounting principles ("U.S. GAAP") requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

**Payment of benefits:** Benefits are recorded when paid.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### 2. Significant accounting policies (continued)

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are recorded as distributions based on the terms of the Plan document.

**Administrative expense:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account.

### 3. Information certified by the trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits
- Investment activity, as shown in the statement of changes in net assets available for benefits
- Schedule H, line 4i – schedule of assets (held at end of year)

### 4. Fair value

The Plan reports its investments at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the units of pooled separate accounts is based on the net asset value (“NAV”) on the last business day of the Plan year provided by the entity holding the account. The NAV is used as a practical expedient to estimate fair value of the underlying assets in the account, less the liabilities.

The fair value of common collective trust funds is based on the net asset value (“NAV”) on the last business day of the plan year provided by the entity holding the trust funds. The NAV of the common collective trust is used as a practical expedient to estimate fair value and is determined by the custodian based on the fair value of underlying assets in the trusts, less the liabilities.

There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

### 5. Risks and uncertainties

Investment securities are exposed to various risks, such as interest rates, credit and overall market volatility. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 6. Tax status

The plan is a prototype plan of Principal Life Insurance Company., which received an opinion letter on March 31, 2014, in which the Internal Revenue Service stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving that letter, the Plan Administrator believes that the Plan is currently designed and operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date and no provision for income taxes has been included in the Plan's financial statements.

6. **Tax status (continued)** Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal tax return is subject to examination by the Internal Revenue Service and tax authorities, generally for a period of three years after the returns are filed.
7. **Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
8. **Related party transactions** Certain Plan investments consist of shares of pooled separate accounts, mutual funds and common collective trusts that are managed by affiliates of Principal Financial Group. The Plan pays Principal Financial Group for certain administrative and transactional fees. These transactions qualify as exempt party-in-interest transactions. The Plan paid Principal Life Insurance Company \$109,204 in contract administration fees in 2024. The fees charged qualify as exempt party-in-interest transactions.
