**1. Description of Plan**

The following description of the National MicroRentals, Inc. 401(k) Plan (the “Plan”) provides only general information. The Plan was originally effective January 1, 1994, and was most recently amended and restated effective June 1, 2022. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of National MicroRentals, Inc. (the “Company”), who are age 18 and completed two months of service with the Company. Eligible employees are immediately able to enter the Plan upon satisfying the eligibility requirements. Union employees are excluded from participation in the Plan. Effective February 26, 2024, the Plan was amended to exclude employees classified as “Short Term Show Support Staff” from participation in the Plan (see Note 9). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Reliance Trust Company (“Reliance”) is the trustee of the Plan.

**Contributions**

Each year, participants may contribute up to a maximum of 90% of their pretax compensation, as defined in the Plan document, provided that in no event shall a participant elect to contribute more than the maximum allowed by law. Participants may designate contributions as Roth contributions. The Plan provides for an automatic enrollment provision of 6% of compensation. Participants who attain the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for discretionary employer matching contributions which are calculated each payroll period. For the year ended December 31, 2024 discretionary employer matching contributions were 50% of the first 6% of an active participant’s eligible compensation contributed to the Plan.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and employer matching contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Forfeited Accounts**

Forfeitures are generally used to pay administrative expenses or to offset any employer contributions (see Note 9). The total unallocated forfeiture account balance was \$14,219 and \$18,783 as of December 31, 2024 and 2023, respectively. Forfeitures of \$4,336 were used to offset employer contributions and forfeitures of \$17,074 were used to pay administrative expenses during the year ended December 31, 2024.

**Vesting**

A participant, at all times, has a fully vested (100%) interest in their own contributions and rollover contributions, including actual earnings thereon. Participants’ vesting in the Company’s discretionary employer matching contributions portion of their accounts plus actual earnings thereon is based on their years of continuous service in accordance with the following schedule:

Notwithstanding the above vesting for discretionary employer matching contributions, a participant will become 100% vested in this account upon their attainment of normal retirement age (65), or on account of their termination of employment due to death or disability while an employee.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account and bear interest equal to the prime interest rate plus one percent. Principal and interest are paid ratably through payroll deductions. Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant's primary residence. A participant may have only five loans outstanding at any given time.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum, installment payments or partial withdrawals up to the value of the participant's vested interest in his or her account. In the event of a mandatory distribution greater than \$1,000 but does not exceed \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 ("SECURE Act 2.0")), if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the plan administrator. Hardship and in-service distributions are also permitted from participant accounts, based on the terms of the Plan document.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions**

Contributions from Plan participants and the discretionary employer matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses, including trustee and third party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Reliance Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividends, other income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds (registered investment companies), common collective trust, self-directed brokerage accounts and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds and self-directed brokerage accounts:* Mutual funds (registered investment companies) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Self-directed brokerage accounts generally are limited to certain mutual funds, including money market funds, as well as publicly traded common stock, preferred stock, and exchange-traded funds. Common stock, preferred stock, and exchange-traded funds are valued at the closing prices reported on the active market on which the individual securities are traded.

*Common collective trust:* A common collective trust is valued at the NAV or equivalent based on units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the common collective trust less its liabilities. This practical expedient is not used when it is determined to be probable that the common collective trust will sell the investment for an amount different than the reported NAV. Were the Plan to initiate a full redemption of the common collective trust, the common collective trust reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future returns. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its investment in Federated Hermes Capital Preservation Fund. The Federated Hermes Capital Preservation Fund is a common collective trust investment that seeks the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The Federated Hermes Capital Preservation Fund invests primarily in stable value products, such as GICs (traditional GICs), separate account GICs and synthetic GICs. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the Federated Hermes Capital Preservation Fund.

## 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any employer contributions for which they were not already vested and the trustee would distribute account balances as permitted by the Plan document.

## 6. Tax Status

Effective June 1, 2022, through the adoption of an Automatic Data Processing non-standardized defined contribution pre-approved plan, the Plan was amended and restated. The Internal Revenue Service (“IRS”) issued an opinion letter dated October 6, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable Internal Revenue Code (“IRC”) requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## 7. Related-Party and Party-In-Interest Transactions

Reliance provides custodial and trustee services to the Plan. ADP provides recordkeeping services to the Plan. Therefore, transactions with these providers qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. During 2024, total fees

paid by the Plan to ADP amounted to \$5,565. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

Certain other investment management and plan administration fees of the Plan and its participants are partially offset through income generated from revenue sharing agreements. More specifically, ADP or its affiliates provide certain administrative services to the Plan. ADP or its affiliates may receive revenue from mutual fund service providers for services ADP or its affiliates provide to the funds. This revenue may be used to offset certain amounts owed to ADP or its affiliates for its administrative services to the Plan. If the revenue received by ADP or its affiliates from such mutual fund service providers exceeds the amount owed as agreed to by ADP or its affiliates and the Plan for administrative services, ADP or its affiliates is to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the year ended December 31, 2024, the related amounts deposited into the Plan were \$2,962. During the year ended December 31, 2024, the amount used to pay expenses were \$2,925. As of December 31, 2024 and 2023, the balance available was \$2,306 and \$2,216, respectively. The Plan or the Company may make payments to ADP or its affiliates for administrative expenses not covered by revenue sharing.

## **8. Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

## **9. Plan Amendments**

Effective February 26, 2024, the Plan was amended to exclude employees classified as "Short Term Show Support Staff" from participation in the Plan.

Effective April 5, 2024, the Plan was amended to allow for forfeitures to be utilized to reduce any employer contributions on a per payroll period basis.

Effective November 20, 2024, the Plan was amended to update the administrative procedures regarding in-Plan Roth rollover contributions and in-Plan Roth rollover transfers.

## **10. Subsequent Events**

Effective January 1, 2025, ADP Retirement Trust Services, LLC replaced Reliance Trust Company as the trustee of the Plan.

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued.
