- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Group Insurance Plan for Certain Employees of Anheuser-Busch Companies, LLC 's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Group Insurance Plan for Certain Employees of Anheuser-Busch Companies, LLC 's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023**

1. Plan Description

The following description of the Group Insurance Plan for Certain Employees of Anheuser-Busch Companies, LLC (the Plan) is intended to give a general summary of its principal provisions. Participants should refer to the Plan Document for more complete information.

General

The Plan was established by Anheuser-Busch Companies, LLC (the Company) to provide employee health and life insurance, income continuation and other benefits for those employees and their eligible dependents who meet the service and other requirements described in various health and welfare benefit plans adopted by the Company and its subsidiaries, with the exception of certain subsidiaries and certain bargaining groups (Participating Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Participation

Employees and dependents who meet the eligibility requirements as described within the various health and welfare benefit plans may participate in the Plan.

Benefits and Administration

Health benefits are provided primarily on a self-insured basis pursuant to the Plan's agreements. In addition, employees at certain locations may participate in group insurance arrangements with participating Health Maintenance Organizations (HMOs).

Short-term disability, dental, vision, and prescription drug benefits are provided primarily on a self-insured basis.

Other benefits including life insurance, long-term disability, supplemental life and accidental death and dismemberment are provided on an insured basis in accordance with the Plan's agreements with various insurance companies. The Plan also provides certain legal services to participants.

The Company provides a Wellness Program to incentivize employees to become healthier. Certain salaried, non-union hourly and bargaining unit employees, and spouses or certified same gender domestic partners enrolled in the Plan are eligible to receive an incentive payment if they complete a visit to their primary care physician for a wellness checkup or participate in a biometric screening. Payments made under this program for the years ended December 31, 2024 and 2023 amounted to approximately \$640,000 and \$1,160,000, respectively and is included as a reduction to participant contributions in the statement of changes in net assets available for benefits.

Employee Benefit Trust

The Plan provides that some or all of its welfare benefits may be funded through the Anheuser-Busch Employee Benefit Trust (Master Trust) account at Bank of New York Mellon (Trustee and Custodian). Short-term disability claims are paid from the Master Trust assets and are processed through an agreement with MetLife. The Plan has utilized all of its assets in the Master Trust to fund benefits. Therefore, the Plan has no interest in the Master Trust as of December 31, 2024 and 2023.

In August 2024, the Master Trust was terminated, and the Bank of New York Mellon account was closed.

Contributions

The Company makes contributions to the Plan as necessary to pay claims under self-insured benefit programs and pay related claims administration expenses to the extent they are not paid by participant contributions. A portion of Company contributions are made to the Master Trust as needed to pay short-term disability claims. Under present law, the Company is not permitted to make deductible contributions to the Master Trust for future benefits to current participants.

Additionally, the Company will contribute \$735,000 monthly beginning in March 2024, which will increase to \$1,481,944 monthly in 2025 through 2027 for discretionary benefits to eligible retirees managed by an outside plan. The Company contributed \$7,350,000 during the year ended December 31, 2024.

Premiums paid for life insurance, long-term disability and accidental death and dismemberment coverage and premiums paid to participating HMOs are paid directly to the insurance carriers by the Plan.

Participants are required to contribute specified amounts to obtain coverage. These amounts are based on the participants' elections and can vary significantly. Participant contributions are used directly to purchase coverage.

COBRA Premium Contributions

Participants terminated by the Company are allowed to individually pay for continued health coverage. These individuals contributed approximately \$663,000 and \$865,000 during 2024 and 2023, respectively. These contributions are included in participant contributions on the statement of changes in net assets available for benefits.

Expenses of the Plan

The Plan pays administrative expenses that consist of administrative fees paid to third party claims administrators and transitional reinsurance fees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company may amend or terminate the Plan at any time. In the event of Plan termination, benefit payments will be made for claims incurred to date of termination.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities held by the Master Trust investments, and related realized gains and losses, are accounted for on the trade date. The change in value of interest in the Master Trust consists of the Plan's interest in Master Trust interest income, which is recorded as earned.

Allocation of Assets in Employee Benefit Master Trust

The Master Trust was established for the investment of the Plan's assets and certain other Company sponsored health plans. As noted in Note 1, the Master Trust was terminated in August 2024.

Prior to termination, the interest of each plan was represented in units. Each unit represented an undivided interest in the Master Trust. The value of each plan's interest in the Master Trust was based on the beginning of year value of the plan's interest in the trust plus actual contributions and allocated investment income, net of investment expenses and premium payments. The allocation of investment income and administrative expenses was based on each plan's ownership of Master Trust units at the end of each month.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

3. Benefit Obligations

Plan obligations at December 31, 2024 and 2023 for health claims payable are recognized when the Plan pays the claims processor based on information reported by the third-party administrators.

Plan obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 relates primarily to timing of funding of claims. It is expected that the deficiency will be funded through future Company and participant contributions.

4. Interest in the Master Trust

5. Fair Value Measurements

The Master Trust follows current accounting standards, which provide a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Master Trust has the ability to access.

Level 2 inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Short-Term Investments: Short-term investments are considered to be cash equivalents due to their short maturities, and are valued at amortized cost, which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

As noted in Note 1, the Master Trust was terminated in August 2024. The trust was qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (the Code) and, accordingly, any investment income is exempt from income taxes. The Company received a favorable tax-exempt letter from the Internal Revenue Service (IRS) on November 3, 1988, exempting the trust from federal income tax under section 501(c)(9) of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

8. Transactions with Party-In-Interest

The Master Trust invested in a short-term investment that was managed by the Trustee. These transactions were exempt party-in-interest transactions under ERISA.
