### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of KMM Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. Description of Plan

The following description of the KMM Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of KMM Telecommunications, Inc. (the Company) who have completed three months of service and reach the entry date. Employees become eligible for employer contributions when they have completed six months of service and reach the entry date. The entry date is the first day of the month coinciding with or next month following the date an employee satisfies the eligibility requirements. The Plan is subject to the provisions of ERISA. The Retirement Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

SECURE Act

The Plan has adopted certain provisions under the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE 2.0 Act). The Plan intends to formally execute the required Plan amendments for these provisions by December 31, 2026.

The following descriptions of the Plan below have been updated with the provisions of the SECURE 2.0 Act that impact the Plan.

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants age 50 or older, before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Company may make matching contributions equal to a discretionary percentage of a participant's deferrals, which is determined annually by the Company's Board of Directors. During the year ended December 31, 2024, Company discretionary matching contributions equaled \$.50 for each \$1.00 of participant deferral, up to 4% of the participant's annual compensation. For the year December 31, 2024, the Company discretionary matching contributions totaled \$120,387. The Company may also make a discretionary profit-sharing contribution at the discretion of the Company's Board of Directors. The Company did not make any discretionary profit-sharing contributions during the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant's accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, Company discretionary profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution portion of their accounts is based upon years of continuous service. A participant is 100% vested after three years of credited service.

Payment of benefits

On termination of service, due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of his or her account, or annual installments over a fixed reasonable period of time, not to exceed the life expectancy of the participant and his or her spouse. Participants may also withdraw their contributions upon demonstrating hardship for certain events. Effective on or about January 1, 2024, the Company elected to not opt out of a unilateral amendment advanced by ADP, LLC, and thus adopted the Increase in Dollar Threshold for Mandatory Cash-Out Distributions, as defined in Section 304 under the SECURE 2.0 Act.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,349 and \$2,222, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$51,739 from nonvested accounts.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan repayment periods are five years or less except for loans for the purchase of a residence, which can be for as long as 30 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are repaid ratably through weekly payroll deductions.

2. Summary of accounting policies

Basis of accounting

These financial statements have been prepared using the modified cash basis of accounting which is a comprehensive basis of accounting other than generally accepted accounting principles. Under the modified cash basis of accounting, other than recognizing unrealized gains and losses on investments, revenue is recognized when received rather than when earned and expenses when paid rather than when incurred.

Use of estimates

The preparation of financial statements in accordance with the modified cash basis of accounting, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Contributions

Contributions from Plan participants and the discretionary matching and profit-sharing contributions from the Employer are recorded in the year in which they are received.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and expensed when paid. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payments of benefits

Benefits are recorded when paid.

2. Summary of accounting policies (continued)

Plan expenses

All administrative expenses shall be paid out of the Plan, unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Tax status

Effective July 1, 2022, the Plan adopted a prototype plan offered by ADP, LLC, which received an Internal Revenue Service Opinion Letter dated October 6, 2020, that the Plan is designed in accordance with the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Code and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. As of December 31, 2024, the Plan Administrator believes that based on evaluation of the Plan's tax positions that any liability as a result of uncertain tax positions would not be material. Management continually evaluates expiring statutes of limitations, changes in tax law, and new authoritative rulings to assist in evaluating the Plan's tax positions. Accrued interest and penalties associated with uncertain tax positions, if any, would be recognized as part of the income tax provision. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that such changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. The Plan maintains its investments with an investment manager. Exposure to credit risk is reduced by placing such investments in high quality financial institutions and by following an investment strategy which utilizes a wide range of diversified funds.

5. Certified investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the plan.

6. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the entire account balance will be distributed to the participants.

7. Fair value measurement of investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 as follows:

Level 1 – Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at quoted market prices that represent the net asset value of shares held by the Plan at year end. The change in market value of these investments is reflected in the statement of changes in net assets available for benefits as net appreciation or depreciation in fair value. The mutual funds held by the Plan are deemed to be actively traded.

7. Fair value measurement of investments (continued)

Common collective trust is a stable value fund designed to preserve principal and provide income consistent with capital preservation. These funds are valued at the NAV of units of the common collective trust, as determined by the trustee. The fund seeks to maintain a stable unit value of \$10.00, though this is not guaranteed. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective investment trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidation will be carried out in an orderly business manner.

8. Related party and party-in-interest transactions

The Company pays for professional fees relating to services provided to the Plan. Fees paid on behalf of the Plan during the years ended December 31, 2024 and 2023 were \$12,000 and \$11,000, respectively. The Company also provides certain accounting and administrative services to the Plan for which no fees are charged.

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan's recordkeeper, ADP Retirement Services (a subsidiary of Automatic Data Processing, Inc.) is also paid investment management fees as a percentage of assets in certain fund investments. These transactions are exempt from prohibited transaction rules. The fees paid by the Plan for investment management services are included as a reduction in the net appreciation in fair value of investments. Direct fees were also paid to ADP Retirement Services during the years ended December 31, 2024 and 2023 of \$31,298 and \$32,750, respectively.

9. Subsequent events

Subsequent events have been evaluated through October 9, 2025, which is the date the report was available to be issued. The Plan is not aware of any material subsequent events, except as noted below:

Effective on or about January 1, 2025, the Company elected to not opt out of a unilateral amendment advanced by ADP, LLC, and thus adopted the Increased Catch-Up Limits for Ages 60, 61, 62 and 63, as defined in Section 109 under the Secure Act.

Effective July 1, 2025, a participant becomes 100% vested in matching and profit-sharing contributions after one year of credited service.
